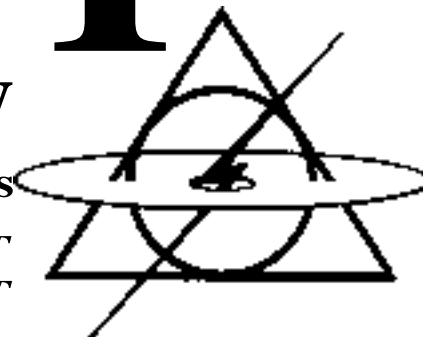

# Adversary ‘Confounded’ By Opposition to Error

health costs, immigrants who live outside the law, North Korea’s claimed nuclear test, genocide in Sudan and Iran’s nuclear ambitions.

Bush’s decision to lay down blunt new markers about the things he deems intolerable comes at an odd time, a phase of his presidency in which **all manner of circumstances are not bending to his will**: national security setbacks in North Korea and Iraq, a Congress that has shrugged its shoulders at his top domestic initiatives, a favorability rating mired below 40 percent.

But a survey of transcripts from Bush’s public remarks over the past seven years shows the president’s worsening political predicament has actually stoked, rather than diminished, his desire to proclaim what he cannot abide. Some presidential scholars and psychologists describe the trend as a signpost of Bush’s **rising frustration** with his declining influence.

In the first nine months of this year, Bush declared more than twice as many events or outcomes “unacceptable” or “not acceptable” as he did in all of 2005, and nearly four times as many as he did in 2004. He is, in fact, at a presidential career high in denouncing events he considers intolerable. They number 37 so far this year, as opposed to five in 2003, 18 in 2002 and 14 in 2001.

Through a spokesman and then in a televised statement, he declared North Korea’s claimed nuclear test “unacceptable” before and after it occurred Oct. 9. ...

Having a president call something “unacceptable” is not the same as having him order U.S. troops into action. But foreign policy experts say the word is one of the strongest any leader can deploy, since it both broadcasts a national position and conveys an implicit threat to take action if his warnings are disregarded.

Bush’s use of the term “reflects in some ways his **frustration** with a world that doesn’t seem as amenable to his policies as he would like them to be”, said Stanley A. Renshon, a political scientist at the City University of New York.

... Bush’s targets expanded from 2003 to 2005 to include nine condemnations of “unacceptable” actions by Iraq and Iran, as well as the Social Security system and the administration’s own response to the Katrina hurricane. This year, he has hurled the term “unacceptable” at actions by Iraqi insurgents and police, at supporters of a withdrawal of U.S. forces from Iraq, and at a U.S. law making the degrading treatment of detainees a war crime.

North Korea’s planned firing of a missile was unacceptable, Bush said June 29; after Pyongyang fired several missiles July 4, Bush again labeled the action unacceptable on July 7 and July 10.

... Asked at a news conference on Wednesday whether Washington risks looking feckless in making such categorical statements without taking decisive action, Bush said: “It’s very important for the American people and North Korea to understand that that statement still stands. ... I know this sounds [like] just saying it over and over again, but it’s—rhetoric and actions are all aimed at convincing others” to join Washington’s effort to impede that country’s weapons ambitions. ...

Indeed, Mr. Bush is sounding more and more confounded all the time. One of the most confounding things for him is the extent of the leaks which have poured forth undermining his audacious lies. This would not be happening if all inside the organization were bent to the will of Satan.

GENERALS ‘SENSE THE END OF THE ROAD’

Back in July, Seymour Hersh wrote in the *New Yorker* about the “April Revolution” at the Pentagon. Apparently, the Joint Chiefs of Staff led by General Peter Pace “achieved a major victory when the White House dropped its insistence that the plan for a bombing campaign include the possible use of a nuclear device to destroy Iran’s uranium-enrichment plant”.

According to Mr. Hersh:  
“A crucial issue in the military’s dissent, the officers said, is the fact that American and European intelligence agencies have not found specific evidence of clandestine activities or hidden facilities ...”

But perhaps the most telling citation in the whole Hersh piece was this (emphasis added):

“A retired four-star general, who ran a major command, said, **‘The system is starting to sense the end of the road, and they don’t want to be condemned by history. They want to be able to say, ‘We stood up.’**”

And, of course, the “quiet riot” of the intelligence and military personnel continues. Among these individuals you will find “the truest and the bluest”, “the best and the brightest” and some of the most truly patriotic people in the World. At least they now seem to have a much clearer idea as to who is the real enemy, “foreign or domestic”.

Updating the story line, the *Iranian Republic News Agency (IRNA)*—in an article entitled “Rioting of U.S. Generals and Talking with Iran”—covers Professor Mowlana’s analysis of the comments made by Generals Charles Swank and John Batisteh, “who were forced to retire themselves last week following their strong objection to U.S. policies in Iraq”.

Hamid Mowlana, Professor of International Relations at School of International Service (SIS) of the American University in Washington DC had an article in Thursday edition of *Kayhan* Persian morning daily, focusing on Iran-U.S. relations.

Professor Mowlana begins his article with a recent quote from former U.S. Under-secretary of State **Richard Armitage**, **“Under such conditions that the strongest army in Mideast region, the Israeli army has failed in silencing Lebanon (read Hezbollah), it is time to hesitate about resorting to force against the 70 million strong Iran, that has a noticeable strategic depth as well.”**

He then focuses on two major and unprecedented developments in the United States in the course of the past couple of weeks, namely the rioting of a group of U.S. generals against the U.S. policies in Iraq and, the recommendation of the senior partisans in both the Republican and the Democrat parties to Bush Administration to begin talks with Iran as a “bare necessity”.

Among the rioting high brass U.S. generals, Professor Mowlana refers to the commander of U.S. Air Force in invasion against Iraq General Charles Swank and the commander of that country’s Army in that war, General John Batisteh, who were forced to retire themselves last week following their strong objection to U.S. policies in Iraq.

They had argued that the situation in Iraq strongly resembled the quagmire in which the U.S. forces had got entangled in Vietnam, and that [exiting] Iraq would be as defaming for Washington as it once was from Hanoi.

They and a larger number of high brass U.S. generals had also asked for immediate resignation of the U.S. Defense Secretary Donald Rumsfeld, who is one of the main architects of Iraq war. ...

It is also worth noting at this point the comments made by General Sir Richard Dannatt, the head of the British Army, Chief of General Staff (according to *The Herald*—UK):  
“Let’s face it, the military campaign we fought in 2003 effectively kicked the door in. Whatever consent we may have had in the first place ... has largely turned to intolerance. I don’t say that the difficulties we are experiencing round the world are caused by our presence in Iraq but undoubtedly our presence in Iraq exacerbates them.”

General Dannatt added: “Our society has always been embedded in Christian values; once you have pulled the anchor up there is a danger that our society moves with the prevailing wind. I think it is up to society to realize that is the situation we are in.”

Add Tony Blair’s cabinet problems to the picture and it is clear that things are not going well for Satan’s poor, confounded minions in the United States and Britain. And oh, yes, Mr. Olmert has his plate full of frustration and confusion to contend with in Israel, too, but that is beyond the scope of this article.

**As of the date of this writing there is no indication that President Bush has yet signed the already infamous War Commissions Act to avail himself of the dictatorial, Habeas Corpus-suspending powers both Congress and the Senate have afforded him. Vladimir Anokhin’s article, “Putin Creates New Axis in Europe to Oppose USA’s Global Hegemony” appeared in *Pravda* on September 26, 2006. The new “axis” to which he refers is one between Russia, Germany and France.

Now on the one hand you have Russia and China flanked by India and Brazil and on the other hand you have Russia and the cornerstones of continental Europe. The common denominator, of course, is Russia, which has pretty much established its lead position as the enemy of our enemy.

... U.S. politicians have become famous for their passion for the notion of axis. It has become a tradition for each U.S. president to create his own axis of something: axis of evil, axis of cooperation, friendship, etc. The latest axis was created without Washington’s participation. The Paris-Berlin-Moscow axis appeared in Europe last week. It can be interpreted as a link of international politics run by three superpowers—Russia, France and Germany.

To all appearance, the agreements achieved in France will influence the world energy policies. President Putin said that German Chancellor Angela Merkel raised a question about giving the European orientation to Russia’s giant Shtokman gas field. ...

The Shtokman gas field is one of the largest gas deposits in the world. Its reserves make up 3.2 trillion cubic meters and 31 million tons of gas condensate. It is possible to extract about 70 billion cubic meters a year, which means that the field reserves may last for 50 or even 70 years. It was previously believed that liquefied gas would be delivered to the USA, where Gazprom initially planned to develop one-tenth of the U.S. market and subsequently enlarge its share to 20 percent.

... The success of the talks can be explained with mutual economic interests and close political views. It is an open secret that Russia, France and Germany stand against the establishment of the unipolar world structure. The three countries share similar positions regarding the events in the Middle East and Iran too.

To crown it all, special relations with Russia can bring the leading place for France and Germany in Europe. ... It is worthy of note that Russia has recently acquired five percent of stocks of the European Aeronautic Defense and Space Company (EADS). This corporation depends on the deliveries of Russian-made titanium.

... The European axis (Paris-Berlin-Moscow) is a normal reaction of experienced politicians to USA’s hegemony. The USA has become a defense machine making its way to global reign. The agreements in France show that “Old Europe” approaches Russia as an independent and attractive center of power.

The geopolitical field is being well tilled in preparation for the advent of an entirely new way of doing business through Global Alliance.

THAT CON-FOUNDED IRS:  
GLOBAL ALLIANCE PUBLIC NOTICE

The following text should be included alongside copies of the referenced letters as part of the Public Notice which should be run for the next three consecutive issues: [See Public Notice on pages 14-15.]

At the end of April 2006 a certain agency of Global Alliance Investment Association (which shall remain unnamed for now) was approached by an agent of the IRS with an allegation of possibly unlawful activity and a request to submit a comprehensive list of documents for review.

Global Alliance Investment Association shares with Cosmos Seafood Energy Marketing, Ltd. the status of Creditor with regard to the United States Treasury (documented by cross resolutions which have been previously publicly noticed). The Internal Revenue Service is the collection agent of the United States Treasury (for the Federal Reserve System and International Monetary Fund—and ultimately the International Bankers), i.e., the debtors. Thus, the action of the IRS was a case of the debtor making demands of the creditor.

Our initial response was to both Mr. John Snow, then Secretary of the Treasury, along with a Notice to Cease and Desist Actions against the Creditor to the Internal Revenue Service’s Mr. Gerald Reese. Mr. Snow immediately resigned as did the General Counsel. There has been no protest against the Cease and Desist Notice.

In late July, however, a letter from a Special Agent of the Treasury Inspector General Tax Administration (TIGTA) suggested that the letter to Gerald Reese could be construed as “an attempt to interfere with administration of internal revenue laws through corrupt or forcible interference”. There is nothing, of course, either corrupt or forcible about our contractual, commercial position.

Our response to the agent’s suggestion is contained in our letter of July 21 to J. Russell George, the head of TIGTA and the agent’s top boss. There has been no protest or response of any kind to that communication.

The IRS has not pursued its initial approach against the GAIA agency, which continues to conduct business in compliance with all rules of man and God.

The United States Treasury does not and properly cannot deny Global Alliance Investment Association’s position as the CREDITOR. When the people of any nation—Anywhere, World, including the United States—determine to get out from under Satan’s enslaving money system, we stand ready, willing and able to assist.

CHAPTER 11  
GOVERNED BY SHADOWS

Before anything else, I wish to emphasize that the testimony which will follow later in the chapter is not written to criticize anyone, but simply focuses on the power that this “alien group” holds over this country. The very same people who claim to have given us our freedom and democracy have forced us to pay heavily for their parasitic way of life, living off us like vampires, unable to exist on their own without having to suck the blood from their helpless victims.

As Christians and Muslims, it is incumbent upon us to support the powers-that-be, as long as they are under duly constituted authority and do not cause us to do things contrary to our professed faith. But these “hidden hands” do not want us to follow what our religion teaches, since it leads to a nationalistic “mindset” which diametrically opposes that of the New World Order. This they have demonstrated many times over, as we have witnessed the rise and fall of our patriotic leaders. For example, in his book *Behind the Lodge Door*, Paul A. Fisher notes the demands these hidden hands imposed on President Manuel L. Quezon. They urged him to submit absolute allegiance to their cause by joining the secret society of conspirators. The fiery Chief Executive declined to accept the offer because he feared that joining their cause may force him to act contrary to the interests of his own people. “I would rather see this country run like hell by Filipinos,” was his stinging reply. Shortly thereafter, the Philippines found itself dragged into a terrible war orchestrated by these 20<sup>th</sup> Century Jacobins. Rear Admiral Theobald made it clear in his bestseller, *The Final Secret of Pearl Harbor*, that the Roosevelt gang knew well in advance of the impending Japanese attack on Pearl Harbor, but did nothing to prevent it. The information was relayed by Brigadier General Elliott R. Thorpe, who was then Chief of Counter-Intelligence under General Douglas MacArthur, but he was not taken seriously. The devastation suffered by millions of Filipinos was too much for Quezon to bear. He died of tuberculosis at a U.S. Army hospital. Ditto was the charismatic mechanic from Zambales, Ramon “the Guy” Magsaysay, whose dream of making the Philippines a great democratic nation upset the timetable of the globalists, who secretly supported the Huk forces of socialist subalterns like Luis Taruc, Jesus Lava and many others. Magsaysay’s well-trained intelligence units broke the back of the communist movement. He, like Quezon before him, had to go way before his time. On his way to Cebu on board the presidential plane *Mount Pinatubo*, the overloaded aircraft mysteriously plunged into a mountain and crashed. Only one of the passengers,

Nestor Mata, survived. He now writes for the *Manila Standard*. It was Benjamin Disraeli, British Prime Minister (1874-80), who said that “the world is governed by very different personages to what is imagined by those who are not behind the scenes.” Later, U.S. President Franklin D. Roosevelt was to confirm this by stating that “nothing accidental ever happens in politics”. Still, many of our scholars ignored these warnings and continued to believe in the accidental theory of history, dismissing any information to prove otherwise. As a consequence, these mal-educated political scientists and historians do not enjoy a broad database for serious study and evaluation, and the goings-on behind the scenes.

Today our country still reels from the continuous assault of the One-Worlders, whose latest concocted novelty on Philippine shores is the “people power” revolution of 1986, led by the troika of the inept Corazon Aquino, the wily Cardinal Jaime Sin and the unassuming West Pointer Fidel V. Ramos. Under Cory’s aimless leadership, the Philippines became the basket case of Asia. Naturally, this socio-economic holocaust was never properly presented to the rest of the world by the globalist-controlled media. Instead, what was painted was a vibrant, post-Marcos nation, which would soon be transformed into a “tiger” by the year 2000. Unless our people are told of the dangers which lurk around the corner, there will be no political resurrection for the future generations of Filipinos—only never-ending subjugation by China, the Dragon of the East.

I have continually been asked the following set of questions. I have arranged them in such fashion so as to make known exactly what I knew of the events surrounding the pressures besetting the late strongman in his last few days in Malacanang:

Q: From your direct knowledge, what events or conversations with certain personalities indicated foreign complicity in the EDSA Revolution and its connection to the Marcos gold? Who were the gainers and why?

A: During the latter stages of the Marcos regime, I came to be friends with James Brandon Foley, a political officer (another term for CIA agents at that time) of the U.S. Embassy. We used to go out and date several women, sometimes to discos and the like. Our favorite hangout was the Hyatt Regency. In between socials, Jim and I would engage in frequent brainstorming at his private apartment at the Seafront. On one particular night, he disclosed to me that there was a secret operation plan to oust Marcos, and that men like Jose Concepcion of RFM and the Ayalas were being used as conduits to access the smooth flow of funds to finally bring an end to the Marcos authoritarian government. (Re James Brandon Foley: I am constrained to break my pledge to preserve the anonymity of my sources because without any attribution to an authoritative source, this revelation will be nothing but hearsay. My apologies. I sincerely hope he will understand, given the situation I am in and the position I am in and the position I have taken.)

Jim likewise mentioned the involvement of Cardinal Jaime Sin, whose role was to draw a large crowd of supporters and sympathizers in the event that a blocking force was needed. Sin is an expert in the Antonio Gramsci-type of Marxism. This was confirmed by Dr. John Coleman in his exposé *The Violation of the Christian Church*, where he stated that

Sin’s Radio Veritas “speaks out Communist propaganda in 13 languages all throughout Asia”, using Liberation Theology to destroy the moral fiber of the large number of Catholics. Sin believes in the Marxist principle that “Religion is the opium of the masses”. He exploited this tactic to the hilt and succeeded in what is now called “people power” mass action. As acknowledged by Coleman, “Cardinal Sin of the Philippines worked diligently to overthrow the Government of President Marcos. He was ably assisted by a former executive of the World Council of Churches, Jovito Salonga. Salonga was brought back to the Philippines under escort of the U.S. State Department.”—*CDC Report*, October 1988

In Coleman’s estimation, Salonga was to take Mrs. Aquino and this Protestant “will cut a deal with the Marxist New people’s Army (NPA)”. Although this did not materialize because of Salonga’s poor health, Coleman was still partly correct. Another fellow Protestant filled in his shoes (Fidel V. Ramos) and has quite successfully negotiated peace with the communists!

Q: What events preceding Marcos’ announcement of the snap election proved that he was under American pressure? Why do you think he acceded to the “request”?

A: Everything really hinged on the Marcos gold bars. The Trilateral Commission, through its Chairman, David Rockefeller, and member George Schultz, were convinced that they had been conned by President Marcos. This being so, the Trilateralists did everything to pressure him, to destabilize his one-man rule, cut his source of funding and even blackmail him (the Dovie Beams affair). A part of the globalists’ notorious activities was documented by David Smith of the U.S.-based *NEWSWATCH* magazine in August 1987: “Representatives from Indonesia and the Philippines went to Jonathan May (ex-World Bank head) and stated that agents from the Chase Manhattan Bank and other banks said they would ‘forgive’ the loans and interests if the following were met: (1) Eliminate their National Currency; (2) Dollar-denominate their new money system; (3) Use a debit card instead of a currency system, and (4) Give the bankers perpetual rights over all natural resources. Ferdinand Marcos of the Philippines refused to accept and was deposed very shortly thereafter.”—*Final Steps to Collapse*, p.3

Marcos eventually gave in to the globalists’ proposal for a snap election, using veteran “ambush interview” expert Ted Koppel of CBS. Clever as he was, Marcos did not reveal to the Americans that prior to his interview with Koppel, he had already conducted a secret survey of the electorate. Despite the adverse media hype launched against him, Marcos was confident of re-election.

However, Jim Foley (who was later transferred to Algiers) disclosed that the real agenda was not the snap election; rather, it was to persuade Marcos to sign a document attesting to the fact that his gold bars and other precious metals deposited at Fort Knox and other depositories of the world would be under the guardianship of the Trilateral Commission, and a certain percentage would be given to the Philippine Government in the form of an investment loan from the World Bank.

The document was subsequently hand-carried by U.S. Ambassador-at-Large Philip Habib, which Marcos refused to sign. The Filipino head of state felt that the war loot (which was remolded into gold bars bearing the Central Bank seal) must be given to the Filipino people.

Q: How was the Americans’ influence exerted during the snap election? Was there American involvement in the walkout of the computer workers?

A: First, there was the barrage of disinformation launched by *Newsweek*, *Time* and other publications regarding the illicit love affairs of both Marcos and the First Lady (e.g., George Hamilton), the incurable ailment of the President, and the public confidence in Namfrel and distrust in the Comelec. Then came the walkout of the computer workers at the PICC. These were all part of the U.S. scenario during the snap election.

Most of the computer workers were promised visas and immigrant status to the U.S. Some of them, I understand, took advantage of this rare opportunity.

Q: Did any of your contacts know about the outbreak of the mutiny at EDSA?

A: Both Jim Foley and Norbert Garrett, CIA Station Chief, U.S. Embassy, predicted a bloody confrontation in the event that Marcos stubbornly decided to stay in Malacanang. The President’s only saving grace was the signing of the document brought by Habib.

Q: Who were pressuring Marcos to give in and leave? Is there any credible evidence that this happened?

A: The pressures came from both U.S. and Philippine sources. On the American side, there was Philip Habib. He was joined by U.S. Ambassador to the Philippines, Stephen Bosworth, Richard Armitage, Michael Armacost, Rep. Stephen Solarz, Norbert Garrett (CIA Station Chief in Manila) and Joseph Mussomelli (Anti-Fraud Section, U.S. Embassy). Senator Paul Laxalt, as you probably know, was the guy who spoke to Marcos on the phone and told him to “cut and cut cleanly”. Lines to Washington were kept busy by calls coming in from Lawrence Eagleburger and Henry Kissinger. Later on, I was told that operating funds came from Maurice “Hank” Greenberg, through dollar grants from the C.V. Starr Foundation of New York. Greenberg is a powerful member of the B’nai B’rith. Others like Higdon, Brzezinski and Generals Pike and Allen of JUSMAG also formed part of the American initiative to oust Marcos.

On the Philippine side were assets like Joe Concepcion, Jobo Fernandez, Cesar Zalamea, Jaime Ongpin and Alex Melchor. Journalists, likewise, were used for their media hype.

Q: Could you elaborate more on Habib’s role in the events that followed?

A: As I have earlier stated, Habib was sent by the Trilateralists to the Philippines to pressure Marcos into signing the document prepared in the U.S. It contained provisions of equal sharing of the gold bars among different countries (through their bankers in the Commission), transshipped by Marcos to Fort Knox and other depositories under a top-secret operation plan coded “*Tuna Highway*”. Initially, Marcos was supported by the Commission to implement martial law in 1972 and was even provided with a martial plan. Along with it came a minting plant, installed at the Central Bank premises by Thomas de la Rue Ltd. of London, and a smelting plant with which to convert the war booty into new gold bars. The Oplan [*Operational Plan Big Bird*] was executed by trusted generals of Marcos, who diverted some portions of the shipment to other destinations aside from Fort Knox. This was covered by a prescription period (November 1945 to November 1985) in accordance with international law. After this 40-year period, it was to be declared “finders keepers”. Some countries which felt conned by these agreements pursued their claim at the International Court of Justice, to mature in 2005.

Had Marcos chosen to sign the document, he would have remained President for life. In the process, he would have received the distinction of being “the best President we ever had”. In addition, the Philippines’ share could have paid our external

debt of, at that time, \$24 billion, plus a comprehensive Marshall Plan for industrialization. (To date, our external debt has zoomed up to \$47 billion, according to the latest BSP figures.) Instead, he chose the hard way and very badly miscalculated. He wanted to regroup his forces in the North, but was flown to Hawaii, instead.

Q: Were there contacts between the military camps and the embassy and/or Washington during the four days at EDSA?

A: Definitely. It has always been standard operating procedure for our military officials to “keep the line open” between them and the defense attachés of the U.S. Embassy. Most of our top-ranking officers have been nurtured in U.S. military schools. Some were even granted immigrant status in the U.S. while serving in the Armed Forces of the Philippines (AFP). Their families were granted entry to the exclusive clubs of the American Government, such as JUSMAG, Seafront, Clark Air Base, Subic Base, Camp John Hay, etc. There, they could avail [themselves] of clubhouse facilities, golf courses and other amenities.

After EDSA, most of the renegade Marcos generals migrated to the U.S. These are the ones who never resisted the Aquino-Ramos-Enrile-Sin forces.

Q: Why didn’t Marcos move during the first hours of the mutiny, when there were very few people around the camps?

A: Marcos was sternly warned not to harm the people at EDSA; otherwise, Malacanang would be targeted by the U.S. military sources. Thus, Marcos took the backseat and relied on the group of then-Col. Rolando Abadilla to finish the job for him. You see, Abadilla’s elite force from the MISG (Military Intelligence and Security Group), together with a SWAT team, successfully penetrated Camp Crame disguised as Ramos supporters. As soon as Marcos was confronted about this by his Chief-of-Staff, General Fabian Ver, the President simply advised the latter to relax, as Abadilla was in the process of arresting Defense Secretary Juan Ponce Enrile and his cousin, Fidel Ramos, whom the President underestimated as a gutless individual. Marcos never imagined that Abadilla would have a change of heart. Abadilla was the prime suspect as the chief operator of Ninoy’s death at the tarmac.

Q: How do you connect Cardinal Sin with the American plan?

A: Cory Aquino was instructed by Cardinal Sin to seek refuge in a Cebu convent. As the fireworks were about to start, Cory was to install her revolutionary government in Davao with the assistance of the RAM forces and her NPA sympathizers. This alternate plan was likewise designed by the CIA, with Col. Voltaire Gazmin given the role of securing Cory in Cebu.

This plan was totally discarded when Marcos peacefully left the Philippines, due to the insistence of Cardinal Sin, who was backed up all the way by the Vatican and the U.S. State Department. Cory ended up being the sole titular head.

CHAPTER 12  
WHAT’S WITH THE PRECIOUS METALS?

Late in 1995, something undeniably significant was observed to be happening in the precious-metals market. Silver stocks in the U.S. were surreptitiously removed from domestic warehouses, including those registered with the COMEX division of the New York Mercantile Exchange. Who did it? The Exchange didn’t make any comment. Even the U.S. financial press did not encourage investigative reporters daring enough to ask the right questions.

That same year, American stockpiles of the metal fell sharply, causing an acute rise in silver prices to the \$6.20 per troy ounce level. Soon after, European stockpiles were also being drawn down and no one seemed to know why—or who was purchasing the metal. Stocks of silver in London fell [to near] zero level, and those in Zurich were likewise low.

It was very clear that forces were manipulating the market, but this time, no one could determine who it was. In a news report published by *Today* and the *Inquirer* late in 1995, a huge portion of the Philippine Government’s gold and silver deposits in the Bangko Sentral was reported missing. This was confirmed by the Commission on Audit, which discovered the discrepancy in the records of the Treasury Department and that of the Mint and Gold Refinery.

According to COA, “Gold and silver holdings of the Bangko Sentral ng Pilipinas had an unreconciled difference of 33,450,079 troy ounces of gold and 23,736,323 troy ounces of silver in the record of the Mint and Gold Refinery”—*Today*, 13 November, 1995. Moreover, the Commission confirmed that gold account balances in depository banks until December 31 showed a difference of 9,672,182 troy ounces worth P90 million. Even receivable interests from foreign banks for time deposits were overstated by \$172,268.32 or about P4.2 million then.

But BSP Governor Gabriel Singson was quick to deny all this, saying that the government’s gold and silver holdings were safe and intact. The reported disparity in deposits arose from the differences in the recording method used by the Treasury Department, which opted to use the defunct Central Bank’s system. Really, Mr. Governor?

It has been customary for producers to lease silver and gold from warehouses, liquidate it and pay the loan

back with their own production. This is a cheap way to borrow money. But, now, instead of paying one percent per annum to borrow silver, the rental rate has reached the 8 percent level—with no one willing to lend. This has been causing confusion, as no one knew where all the silver was going!

Our American associates say that if we were to combine this event with the production of the new U.S. currency to the Russians, a domestic rescue of the dollar (which would not last) and a disastrous sale of Treasury debt (resulting in hundreds of millions of dollars of losses), it would make one begin to smell the advent of a horrendous crisis.

Who was accumulating the silver stockpiles worldwide? Did this particular group know anything at all about a monetary reorganization and the introduction of a new currency? Most definitely! There was no way to keep these people out of the markets, and they always get the word very early from their bosses and buy up as much of the commodity as possible without causing any ripples. This was exactly what seemed to be going on.

The New World Order is taking as few people on the next upward hike in price as is humanly possible. They intend to make precious metals ownership risky, uninteresting and even boring. The CIA may have been used to play up such stories in the press. They may have even set up fake companies to deal in metals, which would only end up cheating customers out of their money. CHAPTER 13  
THE 1940 SHIPMENT

History seems to repeat itself. Imelda Marcos is running once again for the presidency, and is all over again using the Marcos gold as a convenient come-on for the unwitting voting public to vote for her. Although privy to the U.S.\$365 million (now, worth almost U.S.\$800 million, inclusive of accrued interests), she still does not know who actually controls Ferdinand Marcos’ other accounts.

It had been gathered from several sources as early as 1992 that the Gold Hoard, estimated then at 20,000 metric tons, did not comprise anything of the so-called Yamashita Treasure, but that of a 1940 shipment from the Vatican, which came from the bulk of the wealth of the Catholic Church.

Although the bulk of the precious metals is intact in several bank depositories worldwide, especially in Europe, the value of the combined gold, precious metals and jewelry cache has been comfortably placed at U.S.\$1 trillion. It was strongly believed that a good half of the total hoard is still hidden in several parts of this archipelago, still waiting to be found.

Sources claimed that the Vatican had acted as a repository of the treasures of European families, which sought papal assistance upon the Nazis’ invasion in 1939. At the time, the Pope reportedly ordered a big bulk of the cache transported to the Philippines, in the custody of one Fr. Jose Antonio Diaz.

The same sources cited records showing that when World War II ended, the real owners sought to recover their billions (reportedly in 75 kg. bars) but discovered that the custodian, a priest, had allegedly refused to return everything back to them, forcing them to file the necessary claims for the recovery of their metals and jewelry with the International Court of Justice in The Hague in October of 1946. Fr. Diaz then sought the assistance of Ferdinand Marcos, a brilliant young lawyer, offering him 15 percent of the entire hoard for his fee.

But some sources say that soon after, in the Seventies, the aging Dr. Diaz died, leaving behind a holographic will assigning 15 percent of the total stashed gold to his trusted young lawyer, Marcos, another 15 percent to the priest’s heiress (which turned out to be Remedios Trinidad, Imelda’s mother), and the rest of the hoard to the Filipino people. (TRUTH: Fr. Jose Antonio Diaz in 1978 at the San Juan de Dios Hospital, with his wife, Luz Rambano, by his side. The photograph is in my care. His tape-recorded message was also given to me in confidence by this trusted friend. Imelda Marcos was reportedly related to Fr. Jose Antonio Diaz, alias Colonel Severino Sta. Romana, which means The Servant of Rome.)

Soon after, the young Marcos deposited part of the gold in 18 foreign banks in Hong Kong, London and Switzerland. These deposits were reportedly those covered by certificates now in the possession of Imelda Marcos.

The very same sources claimed, too, that in Hong Kong alone, some U.S.\$20 billion of the Marcos gold was held in secure vaults, a fact known to all the relatives of then President Aquino. They further added that when national disorder came about after the assassination of former Senator Benigno Aquino in 1983, the late strongman ordered part of the gold shipped through Sumatra en route to banks owned by his friends. It was said that about 4,000 metric tons of gold was transported out of the country in 1984 alone.

Sources close to Imelda, however, insisted that the 40-year prescription for the recovery of the gold by its original owners lapsed in October 1985. (Despite this setback, several more country-claimants have filed their cases with the International Court of Justice, with the prescription in Year 2005.) There being no legal impediment to the disposition of the hoard now, Imelda Marcos believes that she can almost immediately dispose of the gold in London, Zurich and Tokyo to generate the much-needed cash to finance her presidential bid. Now, which is which?

# Radiation Detoxification

It’s sad but true that there are thousands of scientific references and medical studies out there on the fact that radiation and radioactivity can harm you, yet despite millions of dollars spent by the government to study radiation, virtually nothing is available about a detoxification diet or nutritional supplements you might use if you are exposed to radioactive contamination.

Here’s some of the information we do know from the only book in the world on the topic. Keep this information in the back of your mind as it may one day help save you or someone you know.

Most people are aware taking potassium iodide (KI) or potassium iodate (KIO3) tablets will help block your thyroid gland from absorbing radioactive iodine should there ever be a dirty bomb explosion or nuclear power plant mishap such as the Three Mile Island incident. ...

What people don’t recognize is that potassium iodide or iodate tablets only protect the thyroid gland and do not provide protection from any other radiation exposure, so taking them should not give you a false sense of security. It’s important to detox your body after radioactive exposure!

One question is, what do you do if KI or KIO3 tablets aren’t available during an emergency? Interestingly enough, according to research by Ken Miller, health physicist at the Hershey Medical Center, he found that an adult could get a blocking dose of stable iodine by painting 8 ml of a 2 percent tincture of Iodine on the abdomen or forearm approximately 2 hours prior to I-131 contamination. Potassium iodine tablets are best, but if they’re not available this is the next best thing.

An entirely different problem arises after you’ve been exposed to radioactive contamination because now you have to get rid of any radioactive particles you may have ingested through the air you breathed, water you drank, or food you ate. Some people suggest Epsom salt, Clorox or clay baths to remove any residues on your skin and to leach out any heavy metals you may have absorbed, but the big worry is internal contamination. To gain some insights into what to do, we have to turn to the story of the atomic bombing of Nagasaki.

At the time of the atomic bombing, Tatsuichiro Akizuki, M.D. was Director of the Department of Internal Medicine at St. Francis’s Hospital in Nagasaki and he fed his staff and patients a strict diet of brown rice, miso and tamari soy soup, wakame, kombu and other seaweed, Hokkaido pumpkin and sea salt. He also prohibited the consumption of sugar and sweets since they suppress the immune system.

By imposing this diet on his staff and patients, no one succumbed to radiation poisoning whereas the occupants of hospitals located much further away from the blast incident suffered severe radiation fatalities.

Much of this positive result has to do with the fact that the sea vegetables contain substances that bind radioactive particles and escort them out of the body. This is why seaweed sales usually skyrocket after radiation disasters, and why various seaweeds and algae are typically used to treat radiation victims.

In Chernobyl, for instance, spirulina was used to help save many children from radiation poisoning. By

taking 5 grams of spirulina a day for 45 days, the Institute of Radiation Medicine in Minsk even proved that children on this protocol experienced enhanced immune systems, T-cell counts and reduced radioactivity. Israeli scientists have since treated Chernobyl children with doses of natural beta carotene from Dunaliella algae and proved that it helped normalize their blood chemistry. Chlorella algae, a known immune system builder and heavy metal detoxifier, has also shown radioprotective effects. Because they bind heavy metals, algae should therefore be consumed after exposure to any type of radioactive contamination.

In 1968 a group of Canadian researchers at McGill University of Montreal, headed by Dr. Stanley Skoryna, actually set out to devise a method to counteract the effects of nuclear fallout. The key finding from their studies was that sea vegetables contained a polysaccharide substance, called sodium alginate, which selectively bound radioactive strontium and eliminated it from the body.

Sodium alginate is found in many seaweeds, especially kelp, and since that time the Russians have been seriously researching the use of their own kelps from Vladivostok, from which they have isolated the polysaccharide U-Fucoidan, which is another radioactive detoxifier. Because miso soup was so effective in helping prevent radiation sickness, the Japanese have also done research identifying the presence of an active ingredient called zybicolin, discovered in 1972, which acts as a binding agent to also detoxify and eliminate radioactive elements (such as strontium) and other pollutants from the body.

The kelps and algae aren’t the only natural foods with radio-detoxifying effects. In terms of fluids to drink, black and green tea have shown “radioprotective effects” whether consumed either before or after exposure to radiation. This anti-radiation effect was observed in several Japanese studies, and studies from China also suggest that the ingredients in tea are radioactive antagonists.

In short, after any sort of radioactive exposure you want to be eating seaweeds and algae along with almost any type of commercial heavy metal chelating formula to bind radioactive particles and help escort them out of the body. Whether you’re worried about depleted uranium, plutonium or other isotopes, this is the wise thing to do which can possibly help, and certainly won’t hurt. Many nutritional supplements have been developed for the purpose of detoxifying heavy metals, most of which contain the algae and plant fibers and other binding substances.

Basically, an anti-radiation diet should focus on the following foods:

- Miso soup
- Spirulina, chlorella and the algae (kelp, etc.)
- Brassica vegetables and high beta carotene vegetables
- Beans and lentils
- Potassium, calcium and mineral rich foods
- High nucleotide content foods to assist in cellular repair including spirulina, chlorella, algae, yeast, sardines, liver, anchovies and mackerel
- Cod liver oil and olive oil
- Avoid sugars and sweets and wheat
- A good multivitamin/multimineral supplement

Yet another benefit of the sea vegetables rarely discussed is their high mineral content, which is a bonus in the case of radioactive exposure. Consuming natural iodine, such as in the seaweeds, helps prevent the uptake of iodine-131 while iron inhibits the absorption of plutonium-238 and plutonium-239. Vitamin B-12 inhibits cobalt-60 uptake (used in nuclear medicine), zinc inhibits zinc-65 uptake and sulfur is preventative

for sulfur-35 (a product of nuclear reactors) incorporation by the body.

Since nuclear workers are potentially exposed to radioactive sulfur, this means that workers in the atomic power industry need a higher content of sulfur in their diet. MSM supplements provide a source of dietary sulfur, but thiol supplements such as cysteine, lipoic acid and glutathione serve double-duty in this area because they help detoxify the body and attack all sorts of other health problems as well.

The immune system is usually hit hard after radiation exposure, and a number of steps can be taken to help prevent opportunistic infections after a radioactive incident. Though the full dimensions of the protective mechanism is still unknown, Siberian ginseng is one form of ginseng that exerts a definite radioprotective effect and has been demonstrated to lessen the side effects of radiation. It was widely distributed by the Soviet Union to those exposed Chernobyl radiation and is commonly used to help cancer patients undergoing radiation therapy.

Consuming Reishi mushrooms is another proven way to bolster your immune system after radiation exposure and helps reduce the damage from radiation. It’s been used to decrease radiation sickness in animals and help them recover faster after potentially deadly exposure.

Panax ginseng has prevented hemorrhaging after radiation exposure, prevents bone marrow death and stimulates blood cell formation, so it’s another supplement to add to one’s protocol. In short, yeasts, beta glucans, bee pollen and various forms of ginseng have all been shown to bolster the immune system after radiation incidents. In terms of radiation burns, aloe vera has a proven ability to treat serious radiation burns and offers other radioprotective effects and can easily be grown in your house.

The amino acid L-Glutamine can be used to help repair the intestine in case of the gastrointestinal syndrome usually suffered due to radiation exposure, and a variety of substances can help rebuild blood cells to prevent hematopoietic syndrome. Those particular foods include beet juice, liver extract, spleen extract and shark alkyglycerols. Most oncologists don’t know that shark liver oil, with alkyglycerols, can help platelet counts rebound in days.

Depleted uranium is currently in the journalistic spotlight because U.S. weapons are made from this material, and after being fired leave a legacy of depleted uranium dust in the environment, which anyone can absorb. Because the kidneys are usually the first organs to show chemical damage upon uranium exposure, military manuals suggest doses or infusions of sodium bicarbonate to help alkalinize the urine if this happens. This makes the uranyl ion less kidney-toxic and promotes excretion of the nontoxic uranium carbonate complex.

In areas contaminated by depleted uranium dusts, it therefore makes sense to switch to drinking slightly alkaline water and to favor a non-acidic diet to assist in this detoxification. Any of the heavy metal detoxifiers, such as miso soup, chlorella, spirulina and seaweeds, are also commonsense warranted.

... One homeopathic, in particular, is URANIUM NITRICUM (nitrate of uranium) which homeopaths suggest should be used in cases of depleted uranium exposure or uranium poisoning. Not just soldiers or civilians exposed to battlefield dusts, but uranium miners and radiation workers may find it quite useful.

... [T]here is a plant that is a natural geiger counter. The spiderwort plant is so sensitive to changes in radiation levels (its petals change color upon exposure) that it’s often used as a natural radiation detector (dosimeter), just as they use canaries in mines as detectors of poisonous gas. Some people like knowing that they have an ongoing monitoring system for radiation in the environment, and this is just another tip available in *How to Neutralize the Harmful Effects of Radiation or Radioactive Exposure [available online]*.

Attracted by the promise of power and change, people served without realizing whom or what they were supporting. Weishaupt urged his followers to “practise the art of counterfeit”. New recruits were told the Illuminati expressed the original spirit of Christianity. Weishaupt marveled that even churchmen could be gulled. “Oh! Men, of what cannot you be persuaded?”—(Nesta Webster, *World Revolution*, 1921, p. 27)

The Illuminati had a hand in every so-called “progressive” movement of the past 200 years. Women, said Weishaupt, were to be enlisted with

“hints of emancipation”. They “can all be led toward change by vanity, curiosity, sensuality and inclination”.—(Webster, p. 29)

William Huntington, an American who had studied in Germany, founded the “Skull and Bones” (Chapter 322 of the Bavarian Illuminati) at Yale University in 1832. The members wore a death’s head on their chests and were sworn to secrecy on pain of death. “The Order” became the preserve of the leading New England families, many wealthy from the Opium trade. These include the Whitneys, Tafts, Buckleys, Lowells, Sloans, Coffins and Harrimans. The Bush family was dependent on these interests.

For over 150 years, “Bonesmen” have run the world from positions in banking, intelligence, media, law and government. Members included Presidential handler Averell Harriman, anti-war leader William Sloan Coffin, *Time-Life* magnate Henry Luce, Truman war secretary Henry Stimson (responsible for dropping the atomic bomb), pseudo conservative William F. Buckley and many more.



## ‘THE BATTLE IS NOT BETWEEN LEFT AND RIGHT’

In the 1960s British-born Dr. Anthony Sutton was a Fellow at Stanford’s Hoover Institute when he discovered that, in spite of the Cold War, the U.S. was supplying the USSR with its technology, including weapons used against American soldiers in Vietnam. Sutton dug deeper and discovered that Wall Street had sponsored both the Bolshevik Revolution and the rise of Nazi Germany. The resulting books which are on line cost Dr. Sutton his academic career.

In 1983, Dr. Sutton received a list of Skull and Bones members and immediately recognized the names of many men who controlled American policy. He published a book entitled *America’s Secret Establishment: An Introduction to the Order of Skull and Bones* (1986). He updated and republished this book just before his death last June at age 77. Here are some of his conclusions.

“The Order” is “a purely American phenomenon with German origin.” Dr. Sutton compares it to the Round Table, Cecil Rhodes’ secret society at Oxford also known as “The Group”. The American and British entities consist of 20-30 dynastic families each. Jewish banking interests connect them.

“The links between ‘The Order’ and Britain go through Lazard Freres and the private merchant banks... ‘The Group’ links to the Jewish equivalent through the Rothschilds in Britain ... ‘The Order’ in the U.S. links to the Guggenheim, Schiff and Warburg families.”

As Dr. Sutton notes, the “Order” had definite anti Semitic tendencies but by the 1960s, many Jewish names started to appear among the 15 annual inductees.

Dr. Sutton believes the “left” versus “right” split is fraudulent and used to control the debate and condition citizens to think along certain lines. Left-wing magazines like the *The Nation* and *The New Republic* and right-wing magazines like *The National Review* were “artificially set up”. The former were financed by Whitney money while the latter by Buckley. Both are “The Order”.

Dr. Sutton states: “Sooner or later people will wake

up. First we have to dump the trap of right and left. This is a Hegelian trap to divide and control. The battle is not between right and left; it is between us and them.”

Similarly, in the international field left and right political structures are artificially constructed and collapsed in the drive for one-world synthesis, i.e. authoritarian socialism controlled by monopoly capital.

College textbooks present war and revolution as accidental results of conflicting forces. This is nonsense, says Dr. Sutton. They are created and financed by Wall Street to create a new world order. But you won’t read this in history books.

“Our Western history is every bit as distorted, censored and largely useless as that of Hitler’s Germany or the Soviet Union or Communist China....”

Dr. Sutton believes The Order has many weaknesses resulting from an inbred gene pool, a shallow power base and a limited worldview. In any future conflict between the authoritarian state and the individual, he believes opposition will take “a million forms”.

“No one is going to create the anti-The Order movement. That would be foolish and unnecessary. It could be infiltrated, bought off, or diverted all too easily. Why play by the rules set by the enemy?”

“The movement that will topple The Order will be extremely simple and most effective. It will be ten thousand or a million Americans who come to the conclusion that they don’t want the State to be boss, that they prefer to live under the protection of the *Constitution*. They will make their own independent decision to thwart The Order and it will take ten thousand or a million forms.”

## COGNITIVE DISSONANCE

Bizarre as it sounds, our world is the product of a multi-generational satanic conspiracy. (Believe me I would give everything I own to be wrong.)

When we compare this disturbing conclusion with the comforting picture purveyed by Illuminati controlled-mass media and education, we experience “cognitive dissonance”, or psychological stress. This is usually resolved by evading reality, dismissing it as “conspiracy theory”.

One reader, stirring in his sleep, wrote: “You sir are T-TOTALLY the biggest story teller I have ever heard. If I ever get really bored I will read some of your concoctions.”

In fact, conspiracy is very plausible. People who control a grossly disproportionate share of the world’s wealth will take measures to consolidate their position. They will destabilize the public by inciting a series of wars and other mind-boggling hoaxes (communism, lesbian feminism, multiculturalism). ## CHAPTER THREE BRINGING THE WORLD TOGETHER

### WORLD WAR I

World War I began in 1914, and in 1915, the United States, who were not yet involved, lent France and Great Britain \$500 million through American banks. In 1916, a single French loan totaled \$750 million. In all, the total amount of the loans to these allied countries amounted to \$3 billion, plus another \$6 billion for exports, none of which were repaid. This was just one of the reasons for America’s entry into the war. Had Germany won, those bonds held by American bankers would have been worthless. J. P. Morgan (who served as England’s financial agent in the U.S.), Rockefeller (who made more than \$200,000,000 on the war), Warburg and Schiff were instrumental in pushing America into the war, so they could protect their loans to Europe.

The Illuminati-controlled newspapers publicized, and played-up the sinking of the British auxiliary cruiser, the *Lusitania*, which was torpedoed by a German U-Boat on May 7, 1915. The Germans said they had the right to attack an allied ship, even though the United States, up to that time, had been neutral. The *Lusitania*, which had been converted into an ammunition war ship early in the war, was armed with guns, and was carrying six million pounds of ammunition, which were to be sold to England and France for use in the war against Germany. It was illegal for American passengers to be on board a ship carrying munitions, and on May 1, 1915, the German embassy in Washington, D.C., ran ads in the New York papers, in addition to verbal announcements, warning Americans that the ship would be attacked. Three months earlier, Germany had issued a proclamation that the waters around the British Isles were part of the war zone. In addition, it was later revealed that on December 14, 1914, British Intelligence broke the German war code, which meant that the First Lord of the Admiralty, Winston Churchill, knew the location of every U-Boat in the English Channel area.

When the ship was sunk off the coast of Ireland, 1201 people were killed, including 128 Americans. The Illuminati used the incident to create a war fever, portraying the Germans as being barbaric. Because of President Wilson’s handling of the *Lusitania* affair, William Jennings Bryan, his Secretary of State, resigned.

Colonel House was already in England, making firm commitments that America would enter the war; and on April 6, 1917, Congress declared war, selling it as a “war to end all wars” and a war “to make the world safe for democracy”.

When the war was finally over, over 63,000 American soldiers had been killed in the fighting. A year later, in 1919, Lenin offered four-fifths of Soviet territory, in exchange for the formal recognition of his communist government and economic aid from the United States. He offered to accept the creation of allied-sponsored non-communist states in the Baltic

region, in the area of Archangel, Western Byelorussia, half of the Ukraine, Crimea, the Caucasus, the Ural Mountains and all of Siberia. Wilson rejected the offer for “patriotic reasons” because the Illuminati had big plans for that country. Had he accepted the offer, Russia would have never have become a world power.

### THE LEAGUE OF NATIONS

Before World War I, the Illuminati, using various influential groups in the United States and Great Britain, urged the creation of an organization to promote world peace, even though George Washington warned against involvement with foreign nations. President Wilson favored the idea and echoed those sentiments in his famous “Peace Without Victory” speech before the Senate. He proposed his idea of a League of Nations to the Senate in 1917, seeing it as a means of preventing another World War. It would provide “collective security” or, in other words, an attack on one would be considered an attack on all. The League would also help in the arbitration of international disputes, the reduction of armaments and the development of open diplomacy.

The armistice ending World War I on November 11, 1918 was negotiated on the basis of Wilson’s “Fourteen Points” and on June 28, 1919, was included in the *Treaty of Versailles*, a 20-year truce which divided up Europe, setting the stage for World War II. It demanded that Germany pay war reparations to the victorious countries. The Allies maintained that “since Germany was responsible for the War she was liable for the costs and damages incurred by the victors.” This amount was set at \$32 billion, plus interest; which called for annual payments of \$500 million, plus a 26% surcharge on exports. The agreement forced Germany to forfeit some of her prime provinces, colonies and natural resources. They signed away their rights, had to make trade concessions, and lost what property they had in those foreign countries.

The Treaty was widely criticized. David Lloyd George, the Prime Minister of England, said: “We have written a document that guarantees war in 20 years ... When you place conditions on a people (Germany) that it cannot possibly keep, you force it to either breach the agreement or to war. Either we modify that agreement, and make it tolerable to the German people, or when the new generation comes along they will try again.” Lord Curzon, the British Foreign Secretary, said: “This is no peace, this is only a truce for twenty years!” Even President Wilson was reported to have said: “If I were a German, I think I should never sign it.”

The League of Nations was signed and sealed at the Paris Peace Conference. Even though the United States was represented by Wilson, Col. House was calling the shots. Bernard Baruch, who, as head of the War Industries Board made about \$200,000,000 for himself, was also in the American delegation at the Paris Conference; as well as Walter Lippman (who later became a syndicated newspaper columnist), Allen Dulles (who was appointed Director of the CIA in 1951), John Foster Dulles (brother of Allen, who later became the Secretary of State under Eisenhower) and Christian Herter (who became Secretary of State after the death of Dulles). English Prime Minister George was accompanied by Sir Philip Sassoon, a member of the British Privy Council and a direct descendant of Amschel Rothschild. Georges Clemenceau, the French Prime Minister, had at his side his advisor,

Georges Mandel, also known as Jeroboam Rothschild. The citizens of the United States refused to accept the League of Nations because they felt it would draw them into future European conflicts. Frank B. Kellogg (who in 1925 became Secretary of State under Coolidge) inspired by the American “outlawry of war” movement, and supported by those who were disappointed at the failure of the United States to enter the League, proposed a pact to the French Foreign Minister, Aristide Briand in the spring of 1927. Its purpose was to create alliances directed against a possible resurgence of German aggression. This Pact of Paris was signed on August 27, 1928 by 65 nations, who promised to settle all international disputes by peaceful means.

Because of the efforts of Sen. Henry Cabot Lodge, who saw through Wilson’s plan, the United States didn’t join the League, and in 1921 made a separate peace treaty with Germany and Austria.

The League of Nations, headquartered in Geneva, Switzerland, throughout the 1920s, gained new members and helped settle minor international disputes. However, weakened by the failure of the United States to join and the restlessness of nations who were not satisfied, such as Japan, Italy and Germany, the Illuminati’s second attempt at establishing a one-world government failed. The League had little impact on international affairs and ceased to exist in 1946 when the United Nations was established.

What the League of Nations did do, was allow the Illuminati to get more of a grip on world finances. Countries which belonged to the League sought financial aid from the United States, wherein Rockefeller said that no country could get a loan unless the International Bankers controlled the bank. If they had no bank, they were able to set one up. Through the Bank for International Settlements, established in 1930, the Illuminati was able to control more of the world’s money.

### SYMBOL OF THE ILLUMINATI

When Weishaupt founded the Order of the Illuminati, he adopted the All-Seeing Eye symbol of Masonry [as] the symbol of the organization. It is the Great Pyramid of Cheops, with the capstone missing, and replaced with an eye. The All-Seeing Eye can be traced back to Chaldea as the Solar Eye, the Eye of Jupiter or Apollo, or the Eye of Providence. Hieroglyphics in ancient Egypt identified the name of the chief Sun God Osiris with a human eye.

On July 4, 1776, Thomas Jefferson (a Mason and Illuminist), John Adams (a Mason), and Ben Franklin (a Mason and Rosicrucian), were appointed by a Committee of the Continental Congress to prepare the Great Seal of the United States to signify that the 13 states had united in an act of independence. After some preliminary work by another, William Barton submitted an Eagle on the pinnacle of a Doric column, the All-Seeing Eye and the stars (representing a new constellation, or new empire). Barton’s second design pushed the All-Seeing Eye to the reverse side, and moved the eagle up to the crest, and placed a phoenix (a mythical bird that would be consumed with fire of its own volition, then be resurrected out of its own ashes, which was the Egyptian symbol of regeneration used by the Rosicrucians) rising from the flames at the column’s summit, which was to indicate the revival of the new (America) out of the old (England).

This design was accepted on May 9, 1782 and referred to Charles Thompson (a Mason), the Secretary of Congress on June 13<sup>th</sup>. The final version, approved and adopted by an act of Congress on June 20, 1782, was the result of a series of committee



meetings which combined ideas from Barton, Thompson and Jefferson, who placed a triangle around the eye, added the year ‘1776’, ‘*E Pluribus Unum*’, the olive branch on the front, stars above the eagle and other things. Within weeks, a brass plate of the face of the Great Seal was produced, but not the reverse side.

Although the design of the seal was not to deviate from the one approved, when the original wore out and a second engraving in 1841 was ordered by Secretary of State Daniel Webster. The design by French artist R. P. Lamplier and cut by John V. N. Throop had many subtle differences, such as six, rather than thirteen arrows, and the phoenix clearly became an eagle. Referred to as the Websterian Great Seal, it was used until 1885.

The third engraving was prepared in 1885 under Secretary of State F. T. Frelinghuysen and cut by Tiffany and Co.; and the fourth engraving, under Secretary of State John Hay, engraved by Max Zeiler, and cut by Baily, Banks & Biddle; were both consistent with the design passed by law in 1782.

A committee appointed by Frelinghuysen, consisting of Theodore F. Dwight (Chief of the Bureau of Rolls and Library of the State Department), Justin Winsor (historian), Charles Eliot Norton (Harvard professor), William H. Whitmore (genealogist), John Denison Chaplin, Jr. (associate editor of *American Cyclopedia*) and James Horton Whitehouse (designer for Tiffany and Co. in New York City) decided that a die for the reverse side of the seal would not be produced and used as an official seal. Norton called it a “dull emblem of a Masonic fraternity”. However, a 1957 pamphlet by the U.S. Government Printing Office, called *The Seal of the United States*, indicated that in 1885 “a die may have been cut” but never used.

Celestia Root Lang (editor and publisher of *Divine Life* magazine from the Independent Theosophical Society of America) wrote in 1917: “The reverse side must have been designed by a mystic, one versed in symbolism ... The time will come ... when the white stone (pyramid capstone) will become the headstone of the corner of our government ... in proclaiming a new religion in which all spiritual currents flowing from every religion shall meet in the perfection of the white stone ... having neither dogma nor doctrine ... We see in Mr. Barton only the facade of the instrument; that if he himself was not a mystic or seer, then, a Master (thought to have been Thomas Paine) stood behind him.”

Arthur M. Schlesinger, Jr. wrote in his book, *The Coming of the New Deal*, that Vice President Henry A. Wallace (a Mason) was “fascinated” by the occult and was impressed enough with the significance of the reverse side of the Great Seal to lobby Treasury Secretary Morgenthau to have it put on the back of the one-dollar bill in 1935. Wallace later ran for President as a Socialist. What this gesture meant was that the Illuminati had finally reached the point where they could set into motion their plans for the New World Order by initiating the destruction of our *Constitution*.

The front side of the Great Seal, or the Eagle, is well known. It is used to seal all governmental documents. The reverse side displays a pyramid with an eye in the capstone and a Latin inscription around it. This seems to be a continuation of the Masonic symbolism found on the front. The number thirteen is displayed prominently and was thought to have referred to the thirteen colonies. However, the number thirteen was a mystical number to the Egyptians and Babylonians, and also the Masons.

- There are:
- 13 stars in the crest
  - 13 stripes and bars in the shield
  - 13 olive leaves
  - 13 olives
  - 13 arrows in the right claw
  - 13 feathers in the arrows
  - 13 letters in “*Annuit Coeptis*”
  - 13 letters in “*E Pluribus Unum*”
  - 13 courses of stone in the pyramid
  - 13 X 9 dots in the divisions around the crest

It has been said that the cluster of 13 five-pointed stars above the head of the eagle is actually a representation of a hexagram, which is the most evil of all occult symbols, and is used to invoke Satan.

This is not to be confused with the Star of David, Mogen David, or Seal of Solomon, which consists of two interlaced equilateral triangles, which symbolize the union of God and man.

There are 32 long feathers on the right wing which represent the 32 degrees in Scottish Rite Masonry, and there are 33 feathers on the left, which represent the 33 degrees of York Rite Freemasonry. The pyramid has thirteen levels, said to represent the 13 bloodlines; and within the capstone is an eye. It is not the eye of God, as we have been taught to believe. It stems from Masonic tradition, where it is known as the ‘Eye of Horus’ (the Sun God), or the ‘All-Seeing Eye’, which refers to the protection of Providence, “whose eye never slumbers nor sleeps”, alluding to the ‘Big Brother’ system of constant surveillance. To the Illuminati, it represents the eye of Satan, whom its members worship.

The pyramid represents the organizational structure of the Illuminati, and the capstone containing the eye represents the House of Rothschild, who control the group and have perpetuated the goal of one-world government. Some sources claim that on the top level, the 1<sup>st</sup> block represents the Council of 13 (the 13 most powerful witches), the 2<sup>nd</sup> block represents the Council of 33 (33 highest ranking Masons in the world), and the 3<sup>rd</sup> block is the Council of 500 (500 richest people and corporations in the world).

According to the original Treasury Department press release of August 15, 1935, which gave details of the symbol being put on the back of the one-dollar bill, said the following: “The eye and triangular glory symbolize an all-seeing Deity. The pyramid is the symbol of strength and its unfinished condition denoted the belief of the designers of the Great Seal that there was still work to be done.” Notice they said “Deity” and not “God”.

The news release indicated that the Latin phrase “*Annuit Coeptis*” is translated as “he (God) favored our undertakings” and comes from Virgil’s ‘*audacibus annue coeptis*’ or “favor my daring undertaking”, which refers to the ‘golden’ age during which the ‘Saturnian’ (Saturn was the father of Osiris) kingdom shall return. “*Novus Ordo Seclorum*” is translated as ‘a new order of the ages’, which is taken from Virgil’s ‘*magnus ab integro seclorum nascitur ordo*’ or “the great series of ages begins anew”. To the Illuminati, the combination of these two Latin phrases is translated as: “Announcing the Birth of a New Secular Order”.

The date 1776, found at the base of the pyramid in Roman numerals, doesn’t refer to July 4<sup>th</sup>, the date of the country’s independence; but May 1<sup>st</sup>, when the Illuminati was founded. May 1<sup>st</sup> is also an international holiday for all workers, known as May Day, which was established in 1889 at the

International Socialist Congress. Now, take a pen, and on the seal on the left side of the bill find the word “*Annuit*” and draw a circle around the first letter, ‘A’. Find the word “*Coeptis*” and draw a circle around the last letter, ‘S’. Find the word “*Novus*” and draw a circle around the first letter, ‘N’. Find the word “*Ordo*” and draw a circle around the last letter, ‘O’. Find the word ‘*Seclorum*’ and draw a circle around the last letter, ‘M’. Now, take your pen, and starting from ‘N’ to the top of the capstone, back down to ‘M’ and back over to ‘N’ (utilizing the entire pyramid as one triangle). Then draw a line from ‘A’ to ‘S’ then down to ‘O’ and then back up to ‘A’ which is the second triangle. Not only will you will see a representation of the six-pointed star, but you will also an anagram that spells the word M-A-S-O-N.

The reverse side of the Great Seal, which can be found in the Meditation Room of the United Nations, has never been used to seal one document in this country’s history, and it never will, because it is the seal of the Illuminati.

CHAPTER FOUR  
DOMESTIC TAMPERING

THE ILLUMINATI CREATES RACIAL TENSION

In the book *A Racial Program for the Twentieth Century*, published in 1913 by Israel Cohen of the Fabian Society (a follow-up to Zangwill’s *Melting Pot*), he wrote:

“We must realize that our Party’s most powerful weapon is racial tension. By propounding into the consciousness of the dark races, that for centuries have been oppressed by the Whites, we can mold them to the program of the Communist Party ... In America, we will aim for subtle victory. While enflaming the Negro minority against the Whites, we will instill in the Whites a guilt complex for the exploitation of the Negroes. We will aid the Negroes to rise to prominence in every walk of life, in the professions, and in the world of sports and entertainment. With this prestige, the Negroes will be able to intermarry with the Whites, and begin a process which will deliver America to our cause.”

On June 17, 1957, this passage was read into the Congressional Record by Rep. Thomas G. Abernathy.

In 1922, the Russian Comintern provided \$300,000 for the spreading of communist propaganda among Negroes. In 1925, the Communist Party, U.S.A., told its members:

“The aim of our Party in our work among the Negro masses is to create a powerful proletarian movement which will fight and lead the struggle of the Negro race against the exploitation and oppression in every form and which will be a militant part of the revolutionary movement of the whole American working class ... and connect them with the struggles of national minorities and colonial peoples of all the world and thereby the cause of world revolution and the dictatorship of the proletariat.”

In 1925, a dozen Blacks were recruited for propaganda training in Russia. That same year, the American Negro Labor Congress was established. In 1930 they changed their name to the League of Struggle for Negro Rights. They merged with the United Negro Congress when it was founded in 1936, in Washington, D.C. By 1940, communists made up two-thirds of its membership. In 1947, they united with the Civil Rights Congress, a communist front group.

In a 1928 pamphlet by John Pepper (alias for Joseph Pogany) called *American Negro Problems*, a move was being made by Stalin to ferment revolution

and stir the Blacks into creating a separate Republic for the Negro. Another pamphlet put out by the New York Communist Party in 1935, called *The Negroes in a Soviet America*, urged the Blacks to rise up and form a Soviet State in the South by applying for admission to the Comintern. It contained a firm pledge that a revolt would be supported by all American communists and liberals. On page 48, it said that the Soviet Government would give the Blacks more benefits than they would give to the Whites, and “any act of discrimination or prejudice against the Negro would become a crime under the revolutionary law.”

In *The Communist Party: A Manual On Organization* by J. Peters, he writes:

“The other important ally of the American proletariat is their mass of 13,000,000 Negro people in their struggle against national oppression. The Communist Party, as the revolutionary party of the proletariat, is the only party which is courageously and resolutely carrying on a struggle against the double exploitation and national oppression of the Negro people, becoming intense with the developing crisis, can win over the great masses of the Negro people as allies of the Proletariat against the American bourgeoisie.”

In James Cannon’s *America’s Road to Socialism*, he says that the Negroes “will play a great and decisive role in the revolution ... And why shouldn’t they be? They have nothing to lose but their property and discrimination, and a whole world of prosperity, freedom and equality to gain. You can bet your boots the Negro will join the Revolution to fight for that—once it becomes clear to them that it cannot be gained except by revolution.”

The former FBI Director, J. Edgar Hoover, said of the Communists goals: “Communists seek to advance the cause of communism by injecting themselves into racial situations and in exploiting them, (1) to intensify the frictions between Negroes and Whites to ‘prove’ that discrimination against the minorities is an inherent defect of the capitalistic system, (2) to foster domestic disunity by dividing Negroes and Whites into antagonistic, warring factions, (3) to undermine and destroy established authority, (4) to incite racial strife and riotous activity, and ([5]) to portray the Communist movement as the ‘champion’ of social protest and the only force capable of ameliorating the conditions of the Negro and the oppressed.”

In light of all this, you can see why the Supreme Court, under elitist Earl Warren, issued the desegregation law in 1954, and why Eisenhower and Kennedy enforced it by using Federal troops. It was to create more tension between Blacks and Whites. Incidentally, it was the Warren Court who prohibited prayer and the singing of Christmas carols in the schools. This was intended to weaken Christianity.

Jacob Schiff, the Rothschilds’ man in America, decided that the best way to create racial tension was to establish leadership among the Blacks. In 1909, he laid out plans for the National Association for the Advancement of Colored People (NAACP). It was the merging of the communist-controlled Niagara Movement, a group of Blacks led by W. E. B. DuBois; and a group of White social activists. In the beginning, the top leaders of the NAACP were a group of Jews appointed by Schiff. Their goal was to fight segregation and discrimination. They are the largest Black organization in the country, with well over 1500 chapters, and about a half-million members.

Communist Party members were told to join the NAACP, in order to infiltrate them. The Communist Party platform stated: “The Negro race must understand that capitalism means racial oppression, and communism means social and racial equality.”

Manning Johnson, who held the highest position a Black could have in the Communist Party, said in his 1958 book *Color, Communism and Common Sense*, that he quit because he felt Russia was attempting to involve them in a bloody revolution where as many as five million Blacks would die. Another Negro Communist, Leonard Patterson, testified on November 18, 1950: “I left the Communist Party because I became convinced ... that the Communist Party was only interested in promoting among the Negro people a national liberational movement that would aid the Communist Party in its efforts to create a proletarian revolution in the United States that would overthrow the government by force and violence through bloody full-time revolution, and substitute it with a Soviet form of government with a dictatorship of the proletariat.”

The May 1968 issue of *Political Affairs*, the voice of the Communist Party, wrote after the death of Rev. Martin Luther King, Jr.: “The Reverend Martin Luther King, Jr., the voice, inspiration and symbol of the Negro people’s struggle for freedom and equality, is dead ... The man who, more than anyone else, personified the heroic determination of the Black people to win their liberation now. One of humanity’s great leaders has been silenced forever ... We must see that his memory not be desecrated. We must not fail to do all in our power to realize the dream for which he died.”

King, the most powerful Black leader in the country, was a pawn of the Illuminati. He supported North Vietnam during the War and was photographed in 1957 at the Highlander Folk School, a communist training school in Tennessee, with Abner Berry, who held a post on the Central Committee of the Communist Party. The Joint Legislative Committee on Un-American Activities reported that his Southern Christian Leadership Conference was “substantially under the control of the Communist Party through the influence of the Southern Conference Educational Fund and the communists who manage it”. King had connections with over 60 communist front organizations. Nine of his closest aides were high-ranking communist activists and one of those later became an aide to Rev. Jesse Jackson. Stanley Levison, who had been a King advisor since 1956, had been involved with the Communist Party up to 1955, and brought other known communists onto King’s staff.

Rev. Uriah J. Fields, King’s secretary during the early years, wrote about him: “King helps to advance Communism. He is surrounded with Communists. This is the major reason I severed my relationship with him during the fifties. He is soft on Communism.” Karl Prussion, an FBI agent who infiltrated the Communist Party, and for five years attended meetings in California, testified in 1963: “I further swear and attest that at each and everyone of the aforementioned meetings, one Reverend Martin Luther King was always set forth as the individual to whom Communists should look and rally around in the Communist struggle on many racial issues.” Julia Brown, a former Communist, said: “We were told to promote Martin Luther King to unite Negroes and also Whites behind him ... He was taking directions from Communists. I know for a fact the Communists would never have promoted him, financed him and supported him if they couldn’t trust him. I am certain as I can be that he knew what he was doing.”

Although a 1977 court order sealed the FBI’s extensive surveillance records on King in the National Archives for 50 years, a book by Sen. Jesse Helms in 1998 called *The King Holiday and Its Meaning* said that Charles D. Brennan, an Assistant Director of the FBI who was personally involved in the surveillance,

characterized his activities as “orgiastic and adulterous escapades” in which he could be “bestial in his sexual abuse of women”. He also observed that “King frequently drank to excess.” The 1981 book by David Garrow, called *The FBI and Martin Luther King, Jr.* told of King’s liaisons with prostitutes and the misappropriation of Southern Christian Leadership Conference funds. The FBI investigation had led J. Edgar Hoover to say that “King is a tom cat with obsessive degenerate sexual urges,” and President Lyndon Johnson to call him a “hypocrite preacher”.

The oldest Jewish service organization, known as the B’nai B’rith (which means ‘Son of the Covenant’) was a secret Masonic order founded by twelve wealthy American Jews in New York in 1843. In 1913, Schiff, along with Chicago author and attorney Sigmund Livingston, reorganized the group and established the Anti-Defamation League of the B’nai B’rith (ADL) to fight anti-Semitism and religious prejudice. They have been used as an instrument to convince people that an attack on the Rothschilds and the Illuminati is a direct attack on the Jewish people. They are the most powerful Jewish organization in the world, with chapters in 44 countries. In the United States, they have over 2,000 agencies, about 25 regional offices and a membership of a half-million. Its leaders had controlled the NAACP, the Urban League, and other Black organizations, and often worked closely with the ACLU. Their influence on advertising with some major department stores, hotel chains and major corporations has been able to slant the media toward Blacks. Nearly half of their annual budget comes through donations from non-Jews.

The American League to Limit Armaments was established on December 18, 1914, a spin-off of the Emergency Peace Federation, led by communist Louis Lochner. The League was organized by Jane Addams, John Haynes Holmes, George Foster Peabody, Stephen Wise, L. Hollingsworth Wood and Morris Hillquit, all communists and socialists. In 1915, they changed their name to the American Union Against Militarism, establishing a Civil Liberties Bureau to oppose draft laws. The director of the Bureau, socialist Roger Baldwin, reorganized it into the National Civil Liberties Bureau, and in 1920, with the help of Jane Addams, Clarence Darrow, Norman Thomas, Felix Frankfurter and Arthur Garfield Hays, founded the American Civil Liberties Union (ACLU). Their goal was to fight for “the rights of man (as) set forth in the *Declaration of Independence* and the *Constitution*”.

The original National Committee of the ACLU included Elizabeth Gurley Flynn and William Z. Foster, who both later became Chairmen of the Communist Party; communist Scott Nearing; and Norman Thomas, Socialist Party Chairman. Since the 1920s, 80% of its National Committee members had Communist connections. In 1935, Baldwin said: “I am for socialism, disarmament and ultimately for abolishing the State itself as an instrument of violence and compulsion. I seek the social ownership of property, the abolition of the propertied class and social control of those who produce wealth. Communism is the goal.”

In 1920, a Joint Committee of the New York State Legislature reported that the ACLU “in the last analysis is a supporter of all subversive movements; and its propaganda is detrimental to the interests of the State. It attempts not only to protect crime, but to encourage attacks upon our institutions in every form.” A September, 1923 report by the United Mine Workers of America, said that the group “is working in harmony and unity with the Communist Superstructure in America ... conducting a nationwide campaign for the liberation of Bolshevik agents and disloyal agitators who have been convicted under the

wartime laws or the syndicalist laws of different States for unpatriotic or revolutionary activities.”

A January, 1931 report by the Special House Committee to Investigate Communist Activities in the United States, said: “The American Civil Liberties Union is closely affiliated with the Communist movement in the United States ... it is quite apparent that the main function of the ACLU is to attempt to protect Communists in their advocacy of force and violence to overthrow the government...” The California Fact-Finding Committee on Un-American Activities reported in 1943: “The American Civil Liberties Union may be definitely classed as a Communist front ....” Dr. J. B. Matthews, Chief Investigator for the House Special Committee on Un-American Activities, said in January, 1955: “In 37 years of history of the Communist movement in the United States, the Communist Party has never been able to do as much for itself as the American Civil Liberties Union has done for it.”

The ACLU is made up of about 200,000 members, with an army of 3,000 unpaid volunteer attorneys and chapters in 47 states. They are a finger organization of the Illuminati and are most noted for their cases involving the separation of church and state. They have defended the rights of Jehovah Witnesses to refrain from saluting the flag and to protect the rights of the Nazis and KKK to organize and speak freely. They have become the most powerful weapon against the Church, and Christian tradition, in this country.

THE ELECTORAL COLLEGE

Another contributing factor to Wilson’s election to the Presidency, and how the Illuminati controls the American electorate today, is accomplished through a process known as the Electoral College.

Because delegates to the Constitutional Convention, which met in Philadelphia in 1787, thought that the general public lacked the insight and the judgment necessary to elect a President, and could be easily misled by irresponsible candidates, they enacted the Electoral College to do the job.

The President and Vice-President are the only public officials in the country who are not elected through a direct vote of the people. Each party, in every state, has a slate of electoral candidates, based on the number of representatives it has in Congress. They are known as the Electoral College. Presently, there are 100 Senators and 435 Representatives in the United States for a total of 538 (includes 3 votes from the District of Columbia) electoral votes.

The electors of the Party receiving the highest vote are elected and meet on the first Monday, after the second Wednesday in December, to vote for their party’s nominees. Even though the members of the Electoral College are pledged to vote for the presidential candidate of their Party, they are not constitutionally bound to do so and can change their mind at any time. Technically, however, a candidate wins all of the state’s electoral votes, if he wins a majority of the popular votes. If a presidential candidate has the largest popular vote, but doesn’t obtain the necessary electoral votes, he doesn’t win the Presidency. This happened in 1824, 1876, 1888, and 2000. If no candidate has a majority, then the House of Representatives chooses a President from the three highest candidates, with all the Representatives from each state combining to cast one vote for each state. If a Vice-Presidential candidate receives no clear majority, then the Senate chooses from the top two, with each Senator casting an individual vote.

Therefore, the candidate’s objective is not to win a majority of the popular vote, but a majority of the

electoral votes, which is 270. Thus, if a candidate could be guaranteed just eleven states (leaving 267 remaining electoral votes in 39 states, and the District of Columbia), he could be guaranteed the Presidency: California (55), Texas (34), New York (31), Florida (27), Pennsylvania (21), Illinois (21), Ohio (20), Michigan (17), New Jersey (15), Georgia (15), and North Carolina (15). Combined, these states have 271 electoral votes.

That is why you see a concentration of effort in

On Thursday, Canadian Prime Minister Steven Harper received an award named for Woodrow Wilson, the American President who confessed, “I have unwittingly ruined my country.”

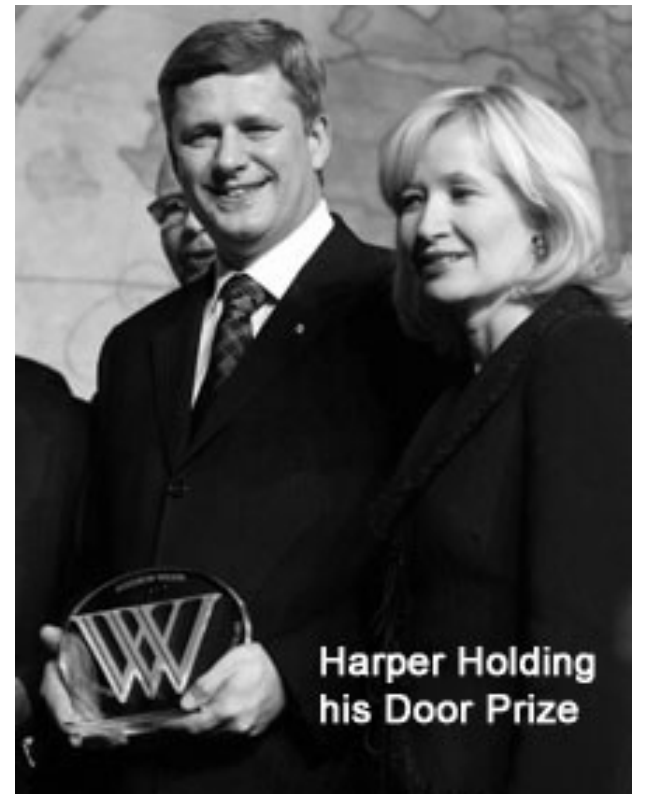
2. After Israel leveled Lebanon, killing 1100 civilians in retaliation for the capture of two soldiers, Harper described Israel’s reaction as “measured”. His

## OUR REPUBLIC—GOING, GOING .... GONE

*There is no week nor day nor hour when tyranny may not enter upon this country—if the people lose their confidence in themselves—and lose their roughness and spirit of defiance.—Walt Whitman*

What many have known unofficially has now become official. The “Spirit of ’76” took its last breath and expired with the passing of the Military Commissions Act of 2006. Fueled by two Supreme Court decisions, *Hamdi v. Rumsfeld* and *Hamdan v. Rumsfeld*, which held that a prisoner has the right of *habeas corpus* and can challenge his detention before an impartial judge and that the military commissions set up to try detainees violated both the *Uniform Code of Military Justice* and the *Geneva Convention*, this utterly frightening Act legalizes the torture of U.S. citizens, abandons the *Geneva Convention*, allows the President to declare virtually anyone to be an “enemy combatant”—artists, writers, scientists, protestors or anyone who does not agree with the pro-war stance of the current regime, and suspends all civil rights for prisoners through the nullification of the Writ of *Habeas Corpus*.

Hard to believe? Not really! Here’s one passage: “No person may invoke the *Geneva Conventions* or any protocols thereto in any *habeas corpus* or other civil action or proceeding to which the United States, or a current or former officer, employee, member of the Armed Forces, or other agent of the United States is a party as a source of rights in any court of the United States or its States or territories.”

Clearly this pernicious administration is “paranoia on steroids” and according to William Rivers Pitt from truthout.org, “Underneath all this is the definition of “enemy combatant” that has been established by this legislation. An “enemy combatant” is now no longer just someone captured “during an armed conflict” against our forces. Thanks to this legislation, George W. Bush is now able to designate as an “enemy combatant” anyone who has “purposefully and materially supported hostilities against the United States”.

Consider that language a moment. “Purposefully and materially supported hostilities against the United States” is in the eye of the beholder, and this administration has proven itself to be astonishingly impatient with criticism of any kind. The broad powers given to Bush by this legislation allow him to capture, indefinitely detain, and refuse a hearing to any American citizen who speaks out against Iraq or any other part of the so-called “War on Terror”.

If you write a letter to the editor attacking Bush, you could be deemed as purposefully and materially supporting hostilities against the United States. If you organize or join a public demonstration against Iraq, or against the administration, the same designation could befall you. One dark-comedy aspect of the legislation is that senators or House members who publicly disagree with Bush, criticize him, or organize investigations into his dealings could be placed under the same designation. How ironic that Congress has thusly granted King George the power to have themselves locked up.

According to Mike Adams of Counterthink.org this Act would also “grant blanket immunity to all U.S. military personnel who have committed war crimes under the *Geneva Convention*. Such immunity would extend to present and future war crimes as well. In

other words, the United States will now officially harbor and support war criminals. In the context of international law, the United States is effectively declaring itself to be a criminal state that will respect no international law. Just as frighteningly, the new Act would utterly nullify the courts and make it illegal for the judicial branch of government to interfere with the imprisonment and torture of anyone, thus affecting a dangerous power shift from the judicial branch of government to the executive branch.”

Here’s another passage: **“No court, justice, or judge shall have jurisdiction to hear or consider any claim or cause of action whatsoever, including any action pending on or filed after the date of the enactment of the Military Commissions Act of 2006, relating to the prosecution, trial, or judgment of a military commission under this chapter, including challenges to the lawfulness of procedures of military commissions under this chapter.”**

Once a stalwart for the guarantees of personal liberty the suspension of the Writ of *Habeas Corpus* guarantees that a person can no longer face their accuser. No longer will we have the right to a trial by our peers or even stand in representation of ourselves. Flimsy, fraudulent and illegally obtained evidence will be the rule of the day. How will we counter any accusations from someone with an agenda such as a disgruntled ex-wife or husband, or a neighbor that thinks you’re anti-America without the command of the *habeas corpus*? Winston Churchill said that “the power of the executive to cast a man into prison without formulating any charge known to the law, and particularly to deny him the judgment of his peers, is in the highest degree odious, and the foundation of all totalitarian government whether Nazi or Communist.” Now the Bush regime must be lumped into this category.

Can this insidiousness continue? Apparently so. Chris Floyd, an American journalist, says that “underlying this edifice of tyranny is the prerogative of presidential murder. Perhaps the enormity of this monstrous perversion of law and morality has kept it from being fully comprehended. It sounds unbelievable to most people: a president ordering hits like a Mafia don? But that is our reality, and has been for five years.”

Even though, on September 17, 2001, Bush signed a “presidential finding” authorizing the CIA to assassinate those whom Bush had designated as a terrorist, this idea of “targeted killing” was not an entirely new concept as evidenced by Bill Clinton’s White House legal goons who drew up memos asserting the president’s right to issue “an order to kill an individual enemy of the United States in self-defense”, as reported by the *Washington Post* in October 2001. According to Floyd the first officially confirmed use of this power was the killing of an American citizen, along with several foreign nationals, by a CIA drone missile in Yemen on November 3, 2002. A similar strike occurred on December 4, 2005, when a CIA missile destroyed a house and purportedly killed Abu Hamza Rabia, a suspected al-Qaeda figure. But the only bodies found at the site were those of two children, the houseowner’s son and nephew, *Reuters* reports. The grieving father denied any connection to terrorism. An earlier CIA strike on another house missed Rabia but killed his wife and children, Pakistani officials reported. He goes on to state that “there is simply no way of knowing at this point how many people have been killed by American agents operating outside all judicial

process. Most of the assassinations are carried out in secret: quietly, professionally. As a Pentagon document uncovered by the *New Yorker* in December 2002 revealed, the death squads must be “small and agile” and “able to operate clandestinely, using a full range of official and non-official cover arrangements to ... enter countries surreptitiously.”

Recall Bush’s State of the Union address in January 2003 as the minds of American citizens were being molded to accept the destruction of another civilization—glowing and strutting like a Bantee chicken, Bush squawked his terror war triumphs claiming that “more than 3,000 suspected terrorists” had been arrested worldwide— “and many others have met a different fate. Let’s put it this way. They are no longer a problem.”

Chris Floyd bottom lines it rather succinctly by stating, “in other words, the suspects—and even Bush acknowledged they were only suspects—had been murdered. Lynched. Killed by agents operating unsupervised in that shadow world where intelligence, terrorism, politics, finance and organized crime meld together in one amorphous, impenetrable mass. Killed on the word of a dubious informer, perhaps: a tortured captive willing to say anything to end his torment, a business rival, a personal foe, a bureaucrat looking to impress his superiors, a paid snitch in need of cash, a zealous crank pursuing ethnic, tribal or religious hatreds—or any other purveyor of the garbage data that is coin of the realm in the shadow world.”

This raw, arbitrary power continues unabated because too many Americans with their vain and arrogant patriotism retain allegiance to an illusory idea and have forgotten the meaning of the “Spirit of ’76”.

## MORE STOCK MARKET MANIPULATION

*There is a very easy way to return from a casino with a small fortune: go there with a large one.—Jack Yelton*

With the Plunge Protection Team (PPT) working overtime to ensure a giddy atmosphere at election time in November one has to wonder how long investors will let the foxes guard the hen house by relying on this PPT to look out for their best interests when it appears that the market is an emperor with no clothes, merely keeping up appearances.

Never mind that on September 29, 2006 the government reported that inflation is the highest it’s been in 11 years. Normally this bit of information would have a substantially negative impact on the market but not so with the PPT at the helm. Never mind that national housing sales have plunged and prices are showing their first declines in more than a decade, or that the index of leading economic indicators has declined for seven straight months. Across the board the economic news is atrocious—everything is pointing to a recession. Never mind that the Dow Jones Industrial Average reached an all-time new high a few days later on October 3, 2006. The show must go on!

How do you explain the Dow levitating in the stratosphere when 21 of the 30 Dow stocks are down 20% or more from their all-time high? Is the only thing standing between the current market and a crash the upcoming elections?

If you look at the PPT, a.k.a. the Counterparty Risk Management Policy Group, you will find a bevy of special interests most assuredly dedicated to covering their assets. Their web site at CRMPolicyGroup.org has the domain holder being Goldman Sachs with members coming from banking and financial gorillas such as JP Morgan Chase & Co., Citigroup Inc., TIAA-CREF, Lehman Brothers, Morgan Stanley, amongst others and oddly enough the Deutsche Bank.

Just how unrealistic are the numbers? According to Michael Nystrom of BullNotBull.com:

“... [I]f the Dow were to make a new high, it would be a phony new high, since adjusted for inflation,



we are nowhere near the old highs. Using the Fed’s very own CPI Inflation calculator (thanks to George Ure at UrbanSurvival.com for keeping a handy link to this calculator right on his homepage) we find that we’d need a 13,817 Dow today to equal the 11,750 Dow of 2000. Put another way, today’s Dow High of 11,754 is equal to only a Dow of 9,995 in 2000. Pfffttt—we didn’t even make Dow 10K!

“If you calculate the Dow using real money—gold—you find an even worse picture. Measured in gold, today’s Dow is equivalent to only about 5,100! Using an average gold price of \$275 in 2000, we establish our year 2000 benchmark: 10,750/275 = 39. Using today’s gold price of \$580, we have 10750/580 = 18.5. From 39 to 18.5 is a 52.5% drop, which is equivalent to only Dow 5K!”

E.J. Ekker, President of the Global Alliance Investment Association, in a memorandum dated December 18, 2000 continues with the market casino theme by stating:

“Over the years the Big Banks and Brokerages have turned the world’s stock and commodities markets into giant casinos wherein they always have the position of the ‘House’ because they can make, and change, the rules. They have invented and introduced ‘new products’ by the dozen till only they can remember how to turn a profit with each one. They have common stock, preferred stock, convertible stock, Class A, B & C stock, voting and non-voting stock. They have bond types, rates and maturities by the bushel: straight, convertible, sinking fund, zero coupon, tax free, and on and on. They have partnerships, limited partnerships, real estate investment trusts and mutual funds by the thousands. And finally, and so far the worst, they have derivatives, an illusory device that can allow them to borrow (leverage), with the connivance of a bank or group of banks, as much as 2000 times the money they have as collateral. Quite often their collateral is gold, leased from some central bank whose uninformed Board of Governors, in the spirit of competition, is striving to make money with the central bank’s reserves. (No central bank should ever be allowed to make a ‘profit’. A central bank is a necessary public service, not a ‘profit center’ to be manipulated by foreigners, i.e., the Big Banks.)

“The whole stock market idea has been perverted into a trading market designed to steal the money of honest investors and the companies of honest entrepreneurs; any person bringing his new, fresh money to the typical stock market is 99% sure of losing some, or all of it.

“A properly structured and managed stock market would be a wonderful device through which to permit the people to participate in the ownership and profitability of the company for which they work. Stock is a useful means of raising capital to start or expand a company. Bonds can pay higher rates of interest than banks to dedicated ‘savers’, and they deliver a more dependable stream of income than stocks when that is the need. The structural changes needed to turn a casino stock market into a marvelous vehicle to fetch even the poorest of the poor into ownership and participation in a more modern society are very few. (1) All foreign ownership should be excluded and, as soon as feasible, by using the GAIA collateral the corporations can begin repurchasing their stock for later distribution to their employees. (2) Stocks and bonds should not be used as collateral for a loan—ever—but especially not to purchase stock, i.e., no pyramiding. (3) Stock should make a profit for its owner only when it rises, and so-called ‘short sales’ to make money because a stock declines in price should be prohibited. Those three simple changes will eliminate as much as 90% of the skullduggery from a domestic stock market and cause the departure of most of the dishonest brokers and traders.”

The gift to clean up this sordid mess is at hand! What are YOU dreaming about?

IS BACK PAIN A STATE OF MIND?

John E. Sarno, MD, Professor of Clinical Rehabilitation Medicine at New York University School of Medicine, and Attending Physician at The Rusk Institute of Rehabilitation Medicine at New York University Medical Center is a pivotal figure in the arena of pain management because of his outside-the-box approach to the diagnosis and management of back pain.

Dr. Sarno has pioneered the diagnosis of tension myositis syndrome (TMS) as a mind-body disorder causing chronic back, neck and limb pain in patients for which standard medical treatments were not working, and has treated over ten thousand of his patients at the Rusk Institute for over three decades.

His two most well-known books, *Healing Back Pain: The Mind-Body Connection* and *The Mindbody Prescription: Healing the Body, Healing the Pain*, advance the theory that most back pain is triggered by psychological origins instead of by a physiological defect.

He believes there is internal rage and anger in the brain, and that these are responsible for symptoms of back pain, not structural defects. “It becomes clear why the brain produces these symptoms: They are intended to be a distraction to make sure your internal rage does not come out. The unconscious has been described by some writers as a kind of ‘maximum-security prison’ where the brain keeps undesirable feelings or dangerous feelings repressed. ... [O]ther ‘equivalent’ physical states ... seem to be serving the same psychological purpose ... [gastroesophageal] reflux ... ; irritable bowel syndrome; headaches; common allergies; hayfever and asthma ... common skin disorders like eczema and others. The skin is a great area that the brain uses to create symptoms. These conditions all serve the same purpose: to keep one’s attention focused on one’s body. This is important in medicine. It’s all so universal, and it’s important to make the right diagnosis. If you ... attribute the pain to something structural, or if you say, ‘The reflux is due to your stomach acting up and you have to take this drug or that drug,’ then people will continue to have symptoms. This is why the back pain problem is of epidemic proportions in the United States.”

While Dr. Sarno claims to not have received any flak from his medical peers they choose to simply ignore him.

THE DISMISSAL OF CHRISTOPHER BOLLYN

As many people are already aware, we were recently put in a difficult position and felt it had become necessary to distance ourselves from Christopher Bollyn. At first we stood by Christopher following his brutal attack at the hands of the police. We published articles

written by him about the terrible incident—even going so far as to add supplementary reports corroborating the view that the police assault could have been provoked by Christopher’s writings. [*JS: Lisa Guliani of WingTV.net recorded an interview with Lt. Russo of Hoffman Estates Police Dept. and his story was quite different as reported by Bollyn. The truth may lie somewhere in the middle as there are many things in Bollyn’s account that seemed very odd. In addition, we offered to help him with legal bills by collecting money for his defense. We even paid some medical bills related to the incident. So far, we have given him \$4,500 for his legal bills and \$1,100 for doctor’s fees. In addition, we have approximately \$4,000 more we will be giving him in the coming days.

We also approached the Foundation to Defend the First Amendment (FDFA) to assist Christopher’s legal defense. FDFA was willing to provide a direct payment of \$5,500 to any attorney retained by Christopher.

However, Christopher seemed hesitant to provide us the name of any attorney, despite the fact that immediately after Christopher’s arrest we gave him at least three valuable contacts for legal assistance in the Chicago area.

We have already engaged Christopher in constructive dialogue, asking him to stand up for the integrity of the newspaper we have all worked so hard to establish. Sadly, our talks came to nothing, as we learned last week that Christopher published a story on the Internet that had a direct link to another site that questioned our credibility, honesty and integrity. This same site has also published false and malicious attacks on many other people and organizations in the alternative media and 9-11 truth movement. For us, that was the straw that broke the camel’s back.

We all considered Christopher more than just a colleague; he was our friend. So it was with heavy hearts that we had to make the decision to terminate him. All of the money that has been collected so far for Christopher will go to him. However, new donations that have recently come in are being returned as we cannot continue to help someone who could not stand up for us.

The discussion with Christopher is now over, but that does not mean we have closed the door forever on him. If Christopher wants to come back to *AFP*, all we have asked of him is to give us the same support that we have shown him by publicly stating he believes in *AFP*’s integrity and credibility.

In addition, we ask that Christopher denounce these absurd charges that we are “controlled by Zionists”. He knows they are preposterous, because there is no evidence to substantiate this claim. [*JS: Bollyn seems to have come from nowhere to the world of journalism. In 2000 he was working with IBM Global Network Services and in June of that year took a position with The Spotlight, AFP’s predecessor. The following year The Spotlight was defunct. Next item in his bio: “born in Chicago in 1957 and grew up in Schaumburg Township where he attended area schools until 1975 when he graduated from James B. Conant High School and began an extended sojourn in Europe and the Middle East. During several summers he traveled from Norway to the Middle East on bicycle trips, crossing Germany, Switzerland, Italy, the Balkans, Greece, Turkey and a number of Middle Eastern countries. Several summers were spent working as a lifeguard on an Israeli kibbutz in the Jordan Valley.” How does an 18-year-old kid have this kind of an adventure when coming from a family with apparently modest means? Bollyn describes his childhood home as “a simple Hoffman-Rosner suburban Chicago tract home that my late parents bought in 1957, but it’s home.” What about the several summers on an Israeli Kibbutz? The \$64,000 question is who is really controlled by the Zionists?*]

*This notice will be construed as a continuation of compliance with provisions necessary to establish presumed fact (Rule 301, Federal Rules of Civil Procedure, and attending State rules). If all interested parties fail to rebut any given allegation or matter of law addressed herein, the position will be construed as adequate to requirements of judicial notice, thus preserving fundamental law. At the end of April 2006 a certain agency of Global Alliance Investment Association (which shall remain unnamed for now) was approached by an agent of the IRS with an allegation of possibly unlawful activity and a request to submit a comprehensive list of documents for review. Global Alliance Investment Association shares with Cosmos Seafood Energy Marketing, Ltd. the status of Creditor with regard to the United States Treasury (documented by cross resolutions which have been previously publicly noticed). The Internal Revenue Service is the collection agent of the United States Treasury (for the Federal Reserve System and International Monetary Fund—and ultimately the International Bankers), i.e., the debtors. Thus, the action of the IRS was a case of the debtor making demands of the creditor. Our initial response was to both Mr. John Snow, then Secretary of the Treasury, along with a Notice to Cease and Desist Actions against the Creditor to the Internal Revenue Service’s Mr. Gerald Reese. Mr. Snow immediately resigned as did the General Counsel. There has been no protest against the Cease and Desist Notice. In late July, however, a letter from a Special Agent of the Treasury Inspector General Tax Administration (TIGTA) suggested that the letter to Gerald Reese could be construed as “an attempt to interfere with administration of internal revenue laws through corrupt or forcible interference”. There is nothing, of course, either corrupt or forcible about our contractual, commercial position. Our response to the agent’s suggestion is contained in our letter of July 21 to J. Russell George, the head of TIGTA and the agent’s top boss. There has been no protest or response of any kind to that communication.

**This letter along with a copy of the Notice to Cease and Desist Actions Against the Creditor at the top of page 15 was sent by certified mail to then Secretary of the Treasury John Snow and was signed as received May 23, 2006. Mr. Snow resigned immediately.**

If we do not hear back from you within ten (10) days, it is presumed you take no exception to the foregoing facts AND that you accept responsibility for ensuring appropriate treatment by TIGTA of our officers, employees and agents in accordance with the immunities, exemptions and privileges spelled out in Article VI of our Articles of Incorporation. We expect compliance with the Cease-and-Desist Notice received by (now former) Secretary of the Treasury John Snow on May 23, 2006 without protest.

**Checklist for Adherence to Corporate Formalities**

Proper operation of a corporation can make the difference between having a fortress-like shelter or a precariously balanced "house of cards". If you are operating a Nevada corporation, you might want to review this checklist to determine for yourself which you are building:

- Read and understand the Articles of Incorporation and Bylaws and act in conformance with them.
- Read the governing law for the corporation: *Nevada Revised Statutes (NRS), Chapter 78.*
- Include reports of officers and committees in the corporate records.
- Record all major decisions of Directors in corporate resolutions or meeting minutes.
- Document contracts, even (perhaps especially) verbal ones, within the corporate records.
- Correctly handle and document corporate loans, making interest payments as required.
- Properly maintain the corporation's books and accounting records.
- Whenever signing on behalf of the corporation, indicate title; do not sign personally or you may forego the inherent liability protection normally afforded by Nevada's statutes.

**Additionally, if stock is issued:**

- Hold annual meetings of stockholders.
- All actions of stockholders must be done by vote and duly recorded.
- Give proper notice or use appropriate waiver of notice (usually specified in the Bylaws) for stockholders' meetings.
- Elect directors as necessary and conduct other business in appropriate meetings, duly recorded.
- Hold regular meetings of the Board of Directors, at least annually.
- Give proper notice or use appropriate waiver of notice (usually specified in the Bylaws) for directors' meetings.
- Elect officers and conduct other business in the manner specified in the Articles of Incorporation and the corporation's Bylaws.
- Record proper minutes of such meetings.
- Maintain the stock ledger properly.
