A Pocket Veto occurs when the President fails to sign a bill within the 10 days allowed by the Constitution.

a pocket veto to take effect.

If Congress is in session and the president fails to sign the bill, it becomes law without his signature.

Now to the current specifics.

From the U.S. Constitution Article 1, Section 7: "...If any Bill shall not be returned by the President within ten Days (Sundays excepted) after it shall have been presented to him, the Same shall be a Law, in like Manner as if he had signed it, unless the Congress by their Adjournment prevents its Return, in which Case it shall not be a Law.'

Since Congress cannot vote while in adjournment, a pocket veto cannot be overridden. A pocket veto is a legislative maneuver in American federal lawmaking. Constitution requires the President to sign or veto any legislation placed on his desk within ten days (not including Sundays). If he does not, then it becomes law by default. The one exception to this rule is if Congress adjourns before the ten days are up. In such a case, the bill does not become law; it is effectively, if not actually, vetoed. Ignoring legislation, or "putting a bill in one's pocket" until Congress adjourns is thus called a pocket veto.

Congress passed 6166 on September 29th, presented it to the President on October 10th, and adjourned on October 13th. Bush signed it on October 17th, the week after Congress had adjourned, thereby rendering it "vetoed" by constitutional standards.

On September 6, 2006, President Bush asked Congress to pass the Military Commission Act of 2006. This Act—among other things—sought to re-define U.S. obligations under Common Article 3 of the *Geneva Conventions*, international treaties signed by every country in the world. Common Article 3 places an absolute prohibition on inhumane treatment of detainees during an armed conflict.

Specifically, the President wanted Congress to replace the absolute prohibition on inhumane treatment of Common Article 3 with a "flexible" standard, which would assess on a case-by-case basis whether particular conduct would amount to cruel, inhuman or degrading treatment. Human Rights First criticized the Administration's proposal for adding ambiguity to an otherwise clear standard of Common Article 3, and [said it] would open the door to more Abu Ghraib-style abuses.

In response to the administration's proposal, more than 45 retired senior military leaders wrote to members of the U.S. Senate expressing their opposition to redefining Common Article 3 on the grounds that it would compromise the safety of U.S. Service men and women. They were joined by former Secretary of State Colin Powell and former U.S. Chairmen of the Joint Chiefs of Staff John Vessey, Hugh Shelton and William Crowe, who also sent letters expressing their opposition to redefining Common Article 3.

Spearheaded by Republican Senators John McCain, John Warner, and Lindsey Graham, the Senate Armed Services Committee passed an alternative bill, sponsored by McCain, Warner, and Graham, that preserves Common Article 3. The Administration then agreed to negotiate with the key Senators, and a compromise was reached.... Human Rights First opposed the final version of the Military Commissions Act, however, because it contained a number of provisions that raised serious concerns about compliance with the Geneva Conventions and with fundamental fair trial and due process principles. Among the most troubling aspects of the Military Commissions Act are provisions that purport to:

Grant unprecedented and unchecked authority to the Executive Branch to label as "unlawful enemy combatants", and possibly to detain indefinitely, an overly broad range of people, including U.S. citizens and legal permanent residents inside the United States;

Deny independent judicial review, through Habeas [Corpus], of detentions of U.S. legal permanent residents and non-citizens;

Limit the sources of law to which the courts may look and the scope of review on appeal;

Narrow the scope of the War Crimes Act and seek to eliminate accountability for past violations of the law by the president and his administration;

Permit evidence obtained through coercion to be used in the military commission proceedings, with certain limitations;

Permit the introduction of classified evidence against the accused even if the accused has not had the opportunity to review and challenge the "sources, methods or activities" by which the government acquired the evidence;

Restrict full disclosure to the accused of exculpatory evidence;

Give the Secretary of Defense authority to deviate from time-tested military justice standards for fair trials.

... In the recent case of Hamdan v. Rumsfeld ... the Supreme Court clearly identified several variances between the "military commission" process being utilized by the present administration [before being legalized by the War Commissions Act—but the same practices and procedures] and the trial process contemplated by the Geneva Convention. Should it turn out that the most recent legislation implements that same, or a very similar, "military commission" trial process [which it DOES], already characterized by the Court as "illegal", then the question arises as to whether legislation that strays from the Geneva Convention standards is federal law. ...

There is no question that the War Commissions Act violates international treaties. As reported in the Irish Examiner on October 27:

... Martin Scheinin, the United Nations' expert on protecting human rights in the fight against terrorism, said the Military Commissions Act signed into law earlier this month by U.S. President George Bush contains provisions "incompatible" with U.S. obligations to adhere to treaties on human rights and humanitarian law.

"One of the most serious aspects of this legislation is the power of the president to declare anyone, including U.S. citizens, without charge as an 'unlawful enemy combatant'—a term unknown in international humanitarian law," said Scheinin, a legal expert from Finland.

... He also deplored the denial of the habeas corpus rights of foreigners—including legal, permanent U.S. residents—to challenge the legality of their detention, "in manifest contradiction with" the International Covenant on Civil and Political Rights, a treaty the U.S. ratified in 1992.

One of the primary reasons HR 6166 was vehemently opposed by the 45 retired senior military leaders (along with, notably, even SIR Colin Powell)

The United States went "Bankrupt" in 1933 and was declared so by President Roosevelt by Executive Orders 6073, 6102, 6111 and Executive Order 6260 (see: Senate Report 93-549, November 19, 1973, pgs.187 & 594 [where it discusses] the Trading With The Enemy Act, Sixty-Fifth Congress, Sess.1, Ch. 105, 186, October 6, 1917), and as codified at 12U.S.C.A. 95a.

The several States of the Union then pledged the faith and credit thereof to the aid of the National Government, and formed numerous socialist committees, such as the "Council of State Governments", "Social Security Administration" etc., to purportedly deal with the economic "Emergency"

... On October 28, 1977 the passage of **Public** Law 95-147, 91 Stat. 1227 declared most banking institutions, including State banks, to be under direction and control of the corporate "Governor" of the International Monetary Fund (see: Public Law 94-564, Legislative History, pg. 5942, United States Government Manual 1990/91, pgs. 480-481). [RK: The IMF is the TRUSTEE in these BANKRUPTCY proceedings. The Secretary of the Treasury receives his paycheck from the **International Monetary Fund.**]

... The United States as a Corporation, (22U.S.C.A. 286e, et seq.) and "State" (C.R.S.24-36-104, C.R.S.24-60-1301(b)) had declared "insolvency" (see: 26L.R.C. 1659(g)(1), U.C.C.1-201(23), C.R.S.39-22-103.5, Westfall vs. Braley, 18 Ohio 188, 75 Rm. Dec. 509, Adams vs. Richardson, 337 S.W. 2d 911 Ward vs. Smith, 7 Wall 447).

statutes delegate to the President extraordinary powers, ordinarily exercised by the Congress, which affect the lives of American citizens in a host of all-encompassing manners. This vast range of powers, taken together, confer enough authority to rule the country without reference to normal constitutional process.

*Under the powers delegated by* these statutes, the President may: seize property, organize and control the means of production; seize commodities; assign military forces abroad; institute martial law; seize and control all

transportation and communications; regulate the operation of private enterprise; restrict travel; and in a plethora of particular ways control the lives of all American citizens.

The "Introduction", on page 1, begins with a phenomenal declaration, to wit:

A majority of the people of the United States have lived all of their lives under emergency rule. For 40 years, freedoms and governmental procedures guaranteed by the Constitution have varying degrees been abridged by laws brought into force by statutes of national emergency...

The Internal Revenue Service entered into a "service agreement" with the U.S. Treasury Department (see: Public Law 94-564, Legislative History, pg. 5967, Reorganization Plan No. 26) and the Agency for International Development, pursuant to Treasury Delegation Order No. 91.

The Agency For International Development is an international paramilitary operation (see: Department of the Army Field Manual (1969) FM 41-10, pgs. 1-4, Sec. 1-7(b) & 1-6, Section 1-10(7)(c)(1), 22U.S.C.A. 284), and includes such activities as "Assumption of full or partial executive, legislative, and judicial authority over a country or area." (See: FM 41-10, pg. 1-7, Section 110(7)(c)(4)) also see, Agreement Between The United Nations And The

be further observed that the "Agreement" regarding the headquarters district of the United Nations was NOT agreed to (See: Congressional Record—Senate, December 13, 1967, Mr. Thurmond), and is illegally in the Country in the first instant.

The international organizational intents, purposes and activities include complete control of "public finance" i.e. "control, supervision, and audit of indigenous fiscal resources; budget practices, taxation, expenditures of public funds, currency issues, and banking agencies and affiliates". (See: FM 41-10, pgs. 2-30 through 2-31, Section 251, Public Finance.)

This of course complies with Silent Weapons For Quiet Wars Research Technical Manual TM-SW7905.1, which discloses a declaration of war upon the American people (see: pgs. 3 & 7), monetary control by the internationalists through Revenue Service. It should be further noted that Congress has appropriated, transferred, and converted vast sums to foreign powers (see: 22U.S.C.A. 262c(b)) and has entered into numerous foreign taxing treaties (conventions) (see: 22U.S.C.A. 285g, 22U.S.C.A. 287j) and other Agreements, which are solicited and collected pursuant to 26I.R.C. 6103(k)(4).

Along with the other documentary evidence information, etc. solicited and collected by the Internal submitted herewith, this should absolve any further doubt as to the true character of the party. Such

(See also: The United States Government Manual 1990/91, pg. 385, also see: The Ron Paul Money Book, supra, pgs. 250, 251.)

It is worthy of note that each and every attorney/ representative, judge or officer is required to file a "Foreign Agents Registration Statement" pursuant to 22U.S.C.A. 611(c)(1)(iv) & 612, if representing the

interests of a Foreign Principal or Power. (See: 22U.S.C.A. 613, Rabinowitz vs. Kennedy, 376 U.S. 605, 11 L. Ed. 2d 940, 18U.S.C.A. 219 & 951.)



income is earmarked for recurrent monthly expenses ... Short of moving out of the house, withdrawing their children from preschool, or cancelling the insurance policy altogether, they are stuck ... Today's family has no margin for error ... Their basic situation is far riskier than that of their parents a generation earlier."

# Final Warning: Part 9b

Chaper 5 of David Allen Rivera's Final Warning: A History of the New World Order presents extensive background coverage of the Fabian and Rhodes Societies before getting into the "meat" of the matter: the Council on Foreign Relations. For now we will bypass the more historical information (Part 9a) to move directly into the USA-impacting CFR information. [QUOTING, emphasis added:]

#### **CHAPTER FIVE** THE COUNCIL ON FOREIGN RELATIONS

... On October 26, 1973, in a Washington Star article called "Has President Nixon Gone Crazy?" syndicated columnist Carl Rowan wrote: "... in the face of a vote to impeach he might try, as 'commanderin-chief' to use military forces to keep himself in power." In another article called "The Pardon" in the August 1983 edition of the Atlantic Monthly, Seymour Hersh, one of Nixon's Joint Chiefs of Staff, wrote that in a December 22, 1973 meeting:

"He kept on referring to the fact that he may be the last hope, (that) the eastern elite was out to get him. He kept saying, 'This is our last and best hope. The last chance to resist the fascists' (of the left). His words brought me straight up out of my chair. I felt the President, without the words having been said, was trying to sound us out to see if we would support him in some extra-constitutional action ... (Secretary of Defense James) Schlesinger began to investigate what forces could be assembled at his order as a counterweight to the Marines, if Nixon-in a crisischose to subvert the Constitution. The notion that Nixon could at any time resort to extraordinary steps to preserve his presidency was far more widespread in the government than the public perceived ...'

He felt it would be led by General Robert Cushman, the Marine Representative on the Joint Chiefs of Staff, who had been loyal to Nixon ever since he had been his military aide while he was the Vice President under Eisenhower. Schlesinger, in July 1974, believing the Washington contingent of Marines to be the probable force used in a coup attempt, began developing a strategy to bring in the Army's 82<sup>nd</sup> Airborne Division from Fort Bragg, North Carolina.

On August 2, 1974, Secretary of State Henry Kissinger admitted that General Haig had informed him that Nixon was considering the idea of surrounding the White House with troops. In an August 27, 1974 article in the Washington Post called "Military Coup Fears Denied", the fact was revealed that: "Defense Secretary James Schlesinger requested a tight watch in the military chain of command to ensure that no extraordinary orders went out from the White House during the period of uncertainty (and) that no commanders of any forces should carry out orders which came from the White House, or elsewhere, outside the normal military channels.'

Tantamount to a military coup, and contrary to the Constitution, the Joint Chiefs of Staff sent a secret communiqué to all Commanders of the U.S. military forces around the world: "Upon receipt of this message you will no longer carry out any orders from the White House. Acknowledge receipt."

Rather than a plot by the Illuminati to militarily take over the government, it seemed to be more of an attempt by Nixon to keep from getting pushed out of office by the powers that actually run this country. In the end, he knew what kind of power he was dealing with and resigned his office on August 9th, rather than risk what remaining credibility he had by trying to grab what he could not hold. His resignation also prevented an impeachment trial, which may have allowed secret information to come to light.

#### THE CFR AND THEIR GOALS

The CFR's "1980s Project" evolved from a Council Study Group on International Order, which had met from 1971-73. They sought to duplicate the success they had achieved with the War & Peace Studies and their concentration was to be on creating a new political and economic system that would have global emphasis. Miriam Camps, former Vice-Chairperson of the State Department's Policy Planning Council, recorded the group's discussion in a report called *The Management of* Independence, which called for "the kind of international system which we should be seeking to nudge things".

In the fall of 1973, the 1980s Project was initiated and to accommodate it, the CFR staff was expanded and additional funds raised, including \$1.3 million in grants from the Ford, Lilly, Mellon and Rockefeller Foundations. The Coordinating Committee had 14 men with a full-time staff; plus 12 groups, each with 20 members; in addition to other experts and advisors who acted as consultants to the project. Some of the reports produced: Reducing Global Inequities, Sharing Global Resources, and Enhancing Global Human Rights.

Stanley Hoffman, a chief participant of the Project, wrote a book in 1978 called Primacy or World Order, which he said was an "illegitimate offspring" of the Project. Basically, it was a summary of the Project's work and concluded that the best chance for foreign policy success was to adopt a "world order policy".

When Jimmy Carter was elected to the Presidency in 1976, some of the Project's strongest supporters, such as Cyrus Vance, Michael Blumenthal, Marshall Shulman, and Paul Warnke, went to the White House to serve in the new Administration.

In 1979, the Project was discontinued for being too unrealistic, which meant it was too soon for that kind of talk.

The CFR headquarters and library is located in the five-storey Howard Pratt mansion (a gift from Pratt's widow, who was an heir to the Standard Oil fortune) at 58 E. 68th Street in New York City (on the corner of Park Ave. and 68th Street), on the opposite corner of the Soviet Embassy to the United Nations. They are considered a semi-secret organization whose 1966 Annual Report stated that members who do not adhere to strict secrecy can be dropped from their membership. On the national level, the Business Advisory Council and the Pilgrim Society are groups which form the inner circle of the CFR, while on the international level, it's the Bilderbergers.

James P. Warburg (banker, economist, a member of FDR's brain trust and son of Paul M. Warburg) of the CFR told a Senate Foreign Relations Committee on February 17, 1950: "We shall have world government whether or not we like it. The only question is whether world government will be achieved by conquest or consent.

The Chicago Tribune printed an editorial on December 9, 1950 which said: "The members of the Council are persons of much more than average influence in the community. They have used the prestige that their wealth, their social position, and their education have given them to lead their country towards bankruptcy and military debacle. They should look at their hands. There is blood on them—the dried blood of the last war and the fresh blood of the present one."

They have only been investigated once and that was in 1954 by the Special House Committee to Investigate Tax-Exempt Foundations (the Reece Committee), [which] said that the CFR was "in essence an agency of the **United States Government"**. The Committee discovered that their directives were aimed "overwhelmingly at promoting the globalistic concept".

"The most powerful clique in these (CFR) groups have one objective in common: they want to bring about the surrender of the sovereignty and the national independence of the U.S. They want to end national boundaries and racial and ethnic loyalties supposedly in increase business and ensure world peace. What they strive for would inevitably lead to dictatorship and loss of freedoms by the people. The CFR was founded for 'the purpose of promoting disarmament and submergence of U.S. sovereignty and national independence into an all-powerful oneworld government'."

On September 1, 1961 the Christian Science Monitor printed the following statement: "The directors of the CFR make up a sort of Presidium for that part of the Establishment that guides our destiny as a nation."

On December 23, 1961, columnist Edith Kermit Roosevelt (granddaughter of President Theodore Roosevelt) wrote in the *Indianapolis News* that CFR policies "favor ... gradual surrender of United States sovereignty to the United Nations". Researcher Dan Smoot, a former FBI employee, said their goal was "to create a one-world socialist system and make the United States an official part of it".

Rep. John R. Rarick of Louisiana said in 1971:

"The CFR, dedicated to one-world government, financed by a number of the largest tax-exempt foundations, and wielding such power and influence over our lives in the areas of finance, business, labor, military, education and mass communication-media, should be familiar to every American concerned with good government and with preserving and defending the U.S. Constitution and our free-enterprise system. Yet, the nation's right-to-know machinery, the news media, usually so aggressive in exposures to inform our people, remain conspicuously silent when it comes to the CFR, its members and their activities. The CFR is the establishment. Not only does it have influence and power in key decision-making positions at the highest levels of government to apply pressure from above, but it also finances and uses individuals and groups to bring pressure from below, to justify the high level decisions for converting the U.S. from a sovereign Constitutional Republic into a servile member state of a one-world dictatorship."

Phyllis Schlafly and Rear Admiral Chester Ward (former Judge Advocate General of the Navy from 1956-60), who was a member of the CFR for 16 years, wrote in their 1975 book, Kissinger on the Couch, that the CFR's "purpose of promoting disarmament and submergence of U.S. sovereignty and national independence into an all-powerful one-world government is the only objective revealed to about 95 percent of 1,551 members (1975 figures). There are two other ulterior purposes that CFR influence is being used to promote; but it is improbable that they are known to more than 75 members, or that these purposes ever have even been identified in writing." The book went on to say that the "most powerful clique in these elitist groups have one objective in common—they want to bring about the surrender of the sovereignty and the national independence of the United States." Ward's indictment of the group revealed their methods: "Once the ruling members of the CFR have decided that the U.S. Government should adopt a particular policy, the very substantial research facilities of CFR are put to work to develop arguments, intellectual and emotional, to support the new policy and to confound and discredit, intellectually and politically, any opposition."

The published accounts of CFR activities greatly understate their power and influence on national and foreign policy. They have been called the "invisible government" or a front for the intellectual leaders who hope to control the world through the Fabian technique of "gradualism". Besides their involvement in the government, they hold key positions in all branches of A July 1958 Harper's magazine article said: the media, including the control or ownership of major

television and radio stations.

The New York Times wrote: "The Council's membership includes some of the most influential men in government, business, education and the press (and) for nearly half a century has made substantial contributions to the basic concepts of American foreign policy." Newsweek called the Council's leadership the "foreign policy establishment of the U.S.". Well-known political observer and writer Theodore White said: "The Council counts among its members probably more important names in American life than any other private group in the country." In 1971, J. Anthony Lukas wrote in the New York Times Magazine: "If you want to make foreign policy, there's no better fraternity to belong to than the Council."

From 1928-72, nine out of twelve Republican Presidential nominees were CFR members. From 1952-72, CFR members were elected four out of six times. During three separate campaigns, both the Republican and Democratic nominee were, or had been a member. Since World War II, practically every Presidential candidate, with the exception of Johnson, Goldwater and Reagan, has been [a member].

The position of Supreme Allied Commander has usually been held by CFR members, like Gen. Dwight D. Eisenhower, Gen. Matthew B. Ridgeway, Gen. Alfred M. Gruenther, Gen. Lauris Norstad, Gen. Lyman L. Lemnitzer, Gen. Andrew J. Goodpaster, and Alexander M. Haig, Jr. Most of the superintendents at the U.S. Military Academy at West Point have been members.

In Sen. Barry Goldwater's 1979 memoir, With No Apologies, he wrote: "When a new President comes on board, there is a great turnover in personnel but no change in policy." That's because CFR members have held almost every key position, in every Administration, from Franklin D. Roosevelt to Bill Clinton. During that period, every Secretary of State, with the exception of Cordell Hull, James F. Byrnes and William Rogers, has been [a member]. Every Secretary of Defense, from the Truman Administration up to the Clinton Administration, with the exception of Melvin Laird, has been [a member]. Since 1920, most of the Treasury Secretaries have been members; and since the Eisenhower Administration, nearly all of the National Security Advisors have been members.

Curtis Dall wrote in his book, FDR: My Exploited Father-in-Law: "For a long time I felt that FDR had developed many thoughts and ideas that were his own to benefit this country, the USA. But, he didn't. Most of his thoughts, his political 'ammunition' as it were, were carefully manufactured for him in advance by the CFR-One World money group."

Anderson (Secretary of the Treasury), Lewis Straus (Secretary of Commerce), Allen Dulles (head of the OSS operation in Switzerland during World War II who became Director of the CIA, and President of the CFR). John F. Kennedy Administration

When CFR member John F. Kennedy became President, 63 of the 82 names on his list of prospective State Department officials were CFR members. John Kenneth Galbraith said: "Those of us who had worked

Schlesinger, Jr. (Special White House Assistant and noted historian), Thomas K. Finletter (Ambassador to NATO and the Organization for Economic Cooperation and Development), George Ball (Under Secretary of State for Economic Affairs), McGeorge Bundy (Special Assistant for National Security, who went on to head the Ford Foundation), Robert McNamara (Secretary of Defense), Robert F. Kennedy (Attorney General), Paul H. Nitze (Assistant Secretary of Defense), Charles E. Bohlen (Assistant Secretary of State), Walt W. Restow (Deputy National Security Advisor), Roswell Gilpatrick (Deputy Secretary of Defense), Henry Fowler (Under Secretary of State), Jerome Wiesner (Special Assistant to the President), Angier Duke (Chief of Protocol).

For instance, the Spring 1991 issue called for a UN standing army, consisting of military personnel from all the member nations, directly under the control of the UN Security Council.

A major source of their funding (since 1953) stems from providing a "corporate service" to over 100 companies for a minimum fee of \$1,000 that furnishes subscribers with inside information on what is going on politically and financially, both internationally and domestically; by providing free consultation, use of their extensive library, a subscription to Foreign Affairs and by holding seminars on reports and research done for the Executive branch. They also publish books and pamphlets and have regular dinner meetings to allow speakers and members to present positions, award study fellowships to scholars, promote regional meetings and stage round-table discussion meetings.

Being that the Council on Foreign Relations was able to infiltrate our government, it is no wonder that our country has been traveling on the course that it has. The moral, educational and financial decline of this nation has been no accident. It has been due to a carefully contrived plot on behalf of these conspirators, who will be satisfied with nothing less than a one-world government. And it is coming to that. As each year goes by, the momentum is picking up and it is becoming increasingly clear what road our government is taking. The proponents of one-world government are becoming less secretive, as evidenced by George Bush's talk of a "New World Order". The reason for that is that they feel it is too late for their plans to be stopped. #### <u>CHAPTER 14</u> THE FAILED TREASURE HUNT

After a successful military career, U.S. Army Major General John K. Singlaub dedicated himself to conservative causes and anti-communist movements. After all, the battle-scarred veteran served as Chairman of the World Anti-Communist League (WACL) and headed its American chapter. His close buddy, Lieutenant General Daniel O. Graham, erstwhile Director of the Defense Intelligence Agency (DIA), became its Vice Chairman.

Until 1986, Singlaub pursued his anti-communist activities working with friends from the private sector to gather unofficial worldwide support and assistance for the Nicaraguan Contras. It was around this time that Singlaub's attention "was unexpectedly diverted from Central America to Southeast Asia", thanks to an American treasure-salvage group called Nippon Star, whose chief investors included a reputable couple named Harrigan from Memphis, who touched base with Singlaub concerning their work to uncover hidden Japanese war booty in the Philippines.

With John Harrigan were John Granbush, Tom Polk, Allan Forringer, Ron Healy and John Voss. All were connected to the National Commodity and Barter Association, based in Denver. Its members were primarily active in the Mormon Church. Granbush, the Association's President, took a special interest in the treasure-hunting activities and helped finance the operation for some time.

According to Charles McDougald, Singlaub was not one given to "flights of fancy or chasing rainbows". So why did he decide to join a treasure hunt that would take him halfway around the world?

"The Harrigans produced credible documents that estimated upwards of 300 tons of bullion and other gold which had reached the Philippines in 1941." This was Singlaub's reply. Like McDougald, the retired General was convinced that Marcos' fortune (which he estimated at \$12 billion) came from the legendary Yamashita Treasure. The Japanese Imperial Army's field commanders "looted the national treasures, private banks and temple complexes in Hong Kong, Burma, IndoChina and the Dutch East Indies, and shipped hundreds of tons of gold bullion and golden temple artifacts for safekeeping in their proposed future colony, the Philippines," says Singlaub.

McDougald insists that a man like Singlaub, whose military career is "the stuff of legend" and who once belonged to the CIA, would not be talking openly about the so-called "Asian loot" if he did not have the correct information in his possession. Thus, everything he said about Yamashita's gold hoard must be true.

[H: Let me also assure you that someone like the one you recognize as Russell Herman would not be holding—as per treasure dealers and V.K. Durham—objects worth a nation's ransom. Among those things listed by V.K. are Ming Dynasty robes, ivory ceremonial cups, diamonds (some from the third eye of Buddhas), etc.—along with some dandy, if not too colorful wall hangings. A lot of this treasure held by Herman came from temples along the old "Burma"

There is no question that these things exist, readers, but what is the "game" all about? Well, no, it was not so that we could go to look for treasure. The Treasure is already found, friends, and it belonged to God. Man can play his games, but ultimately it will return to God in proper form and in proper use as originally planned. And no, Ekkers are not treasure hunters nor finders, although a lot of pretty interesting stuff has been run by them. They came to Southeast Asia to seek neither treasure nor gold. Wow, doesn't that blow a hole in the story of Martin, Neil and fellow "watchers"? They already held the prize and had no idea of how these things would come to play out around them.

And yes, indeed, it is now dispersed so greatly and widely as to be an interesting safety net, woven of a thousand strands of silk thread. The only gold desired by Ekkers is that which backs loans and allows some projects to be developed—by the people to whom this wealth belongs. There is no intervention in political squabbles nor are there any clandestine "arrangements". There are some legal and lawful ventures put to document—and records set forth in the public domain for the purposes presented.

Is there "treasure" in those hills around the countryside? Yes. Is there a lot of stuff in those infamous tunnels? Yes, and there is lots more in those Atmospherian sub-oceanic conclaves. We leave the loot and the treasure to the looters and treasure holders and hunters. We also leave the false paper and documents to the printers and scams (of which the abundance of same runs into the billions of \$\$\$) to the scam artists. This is neither our business nor our interest, so don't believe the garbage you hear from such as the mis- dis-information kids. And we note that today marks a year since the team split and the run-out on Ekkers happened. And yes, it has been a difficult and painful year, aided-and-abetted in the hurt by other members of the trusted friendship circle. But as the cycles pass, so too does the integrity prove itself. Oh, well.]

The Japanese plan to annex the Philippines failed because the advancing American forces "cut off the Philippines before the Japanese could ship their gold back to Japan". Faced with the dark prospects of defeat, "General Yamashita dispersed the assembled treasure around the islands, where it was buried in 172 carefully chosen sites," adds Singlaub. An elite team of geologists and miners performed the burial operations.

Singlaub's group discovered one underwater site in Calatagan Bay (Batangas)—a shaft blasted seventy feet deep into a coral reef. "Japanese records indicated five tons of gold bullion and several barrels of precious stones had been deposited there... by General Yamashita's staff, who used coded maps and ledgers, which were flown back to Japan before the capitulation," Singlaub explains.

Nippon Star eventually gave up the Calatagan site excavation. "Progress was slow and costly," writes McDougald. "This haphazard stop-and-go operation went on until finally they decided that another site might be easier."

Singlaub was convinced that Marcos had managed to "rake off" a dozen or so of the biggest sites. In his estimation, over a hundred sites were left untouched. The problem was that several of the most promising sites *Nippon Star* had staked out were in remote provinces controlled by the New People's Army (NPA). "The group needed a qualified security adviser and offered me a

job," Singlaub explains. "What made the offer attractive was their promise to provide several percent of the eventual profit directly to the U.S. Council for World Freedom. I agreed to help them."

Singlaub periodically came to the Philippines to head the *Nippon Star* operations until it ran into what he claimed were "funding problems".

McDougald disagrees. The latter insists that "it was because of Singlaub's association with friends like (Ray) Cline... and his association with (Teddyboy) Locsin in the palace that a rumor was passed around that the operation was jointly sanctioned by President Reagan and President Aquino", and to disprove this, the whole thing had to be scrapped.

McDougald never admitted that President Aquino knew about the salvage. But Singlaub swears that all he did was "to build better bridges to the Philippine Government" by "giving periodic and detailed reports of our activities to Teodoro Locsin, Jr.", a key adviser to President Aquino.

McDougald's denials worked well for him. In the end, "Charles McDougald, the American treasure hunter who dug up Fort Santiago and Napindan Channel," was reported by the *Manila Standard*'s Ariel Bocobo as "living in style in the U.S." McDougald "has homes in snooty Hillsborough in the San Francisco Bay area, in Beverly Hills in Los Angeles and in Dasmarinas Village in Makati." McDougald "mysteriously disappeared after his diggings were suddenly stopped," adds Bocobo. "He did not even bother to restore the mess he has created in his diggings. Emmanuel Soriano, former National Security Adviser, clammed up after his American partner returned to the U.S."

There are speculations that McDougald has discovered part of the fabulous Marcos Gold Hoard. Does this mean that the "Asian loot" which the presidential treasure hunter mentioned in his book is the same chain of properties suddenly acquired by him after the great Manila caper?

#### MAHDI MANIA IN IRAN

All national institutions of churches, whether Jewish, Christian, or Turkish, appear to me no other than human inventions, set up to terrify and enslave mankind, and monopolize power and profit.—Thomas Paine

Iranian President Mahmoud Ahmadinejad has tossed a new word into the political arena: mahdaviat which is a technical religious term in Iranian Shi'a Islam meaning "belief in and efforts to prepare for the Mahdi". Believing followers of any Mahdi claimant can be referred to as Mahdawis (or Mahdavis); their belief, faith or school of thought is thus Mahdaviat (or Mahdawia(t) and similar transliterations, depending on Arabic, Persian or Urdu pronunciation).

In Islamic eschatology, which is concerned with the Qiyamah (end of the world and the final judgment of humanity), the Second Coming of Isa (a derivation of Esu Immanuel perhaps?) is preceded by the appearance of a figure known as the Mahdi or "rightly-guided one". Shi'a Muslims believe this person is the same as the 12<sup>th</sup> Imam (also *Imam Zaman*), who was hidden by God following the death of his father in 874 and will reappear as "the restorer of religion and justice who will rule before the end of the world".

According to Scott Peterson of the *Christian Science Monitor* the centrality of *mahdaviat* has some interesting implications for Ahmadinejad's policies. As mayor of Tehran, for example, Mr. Ahmadinejad appears to have in 2004 secretly instructed the city council to build a grand avenue to prepare for the Mahdi. A year later, as president, he allocated \$17 million for a blue-tiled mosque closely associated with mahdaviat in Jamkaran, south of the capital. He has instigated the building of a direct Tehran-Jamkaran railroad line. He also had a list of his proposed cabinet members dropped into a well adjacent to the Jamkaran mosque, it is said, to benefit from its purported divine connection.

What Mr. Peterson calls the "presidential obsession" with *mahdaviat* leads Mr. Ahmadinejad to "a certitude that leaves little room for compromise. From redressing the gulf between rich and poor in Iran, to challenging America and Israel and enhancing Iran's power with nuclear programs, every issue is designed to lay the foundation for the Mahdi's return." Thankfully even some Iranians worry that their president has no fear of international turmoil. Certain clerics quietly say they are worried about a leader who has become the foremost public advocate of Iran's nuclear program. "Some of us can understand why you in the West would be concerned. We, too, wonder about the intentions of those who are controlling this nuclear work", says a young Iranian mullah.

While Ahmadinejad has spoken some truths in the past is he able or willing to work towards justice and absolute peace that he speaks about by living within the laws of balance as set forth by our Creator Source? Anton La Guardia of London's Daily Telegraph says that the sneaking suspicion among Western officials is that "Iran's president actually relishes a clash with the West in the conviction that it would rekindle the spirit of the Islamic revolution and—who knows—speed up the arrival of the Hidden Imam."

Does this belief system have an eerily familiar tone? Is it any less extreme than the Christian fundamentalists and their rapture scenario complete with their unquestioning support of the "chosen ones" from Israel? Is not any religion for that matter a tool of Satan and his drummers?

#### RUSSIA PUSHES POPULATION GROWTH

Concerned over an estimated population decline of 700,000 people per year Russian President Vladimir Putin highlighted the problem of the country's birth rate among other issues in his May 10 State of the Nation address, and ordered the government to address the problem. The response has been a recently passed bill approving additional state measures to support families with children.

With a declining population seen as one of the main threats facing the country the 'maternity capital' bill is hoped to ease Russia's demographic meltdown. Health and Social Development Minister Mikhail Zurabov, said: "The state's total allocations [under the bill] will reach about 130 billion rubles [\$4.9 billion] in 2007 alone."

Women giving birth to their second and subsequent babies will receive certificates of 250,000 rubles [\$9,300], a sum that will be adjusted for inflation, as of January 1, 2007, allowing them to use these funds to pay for their child's way through school, or to improve the family's living conditions. Also approved were amendments to the tax code which frees the maternal capital from taxation.

Since the market reforms and economic hardships of the 1990s precipitated this decline in population the government has created other incentives aimed at rectifying the demographic crisis such as allocating 4.6 billion rubles (\$171.13 million) in 2007 on a voluntary repatriation program for Russians living abroad. "They [compatriots] will be assisted with their travel arrangements and primary accommodation, including the registration of their legal and social status, as well as with jobs, municipal and pension services, preschool, school and professional education," Putin said at the Second World Congress of Russians Abroad, held in St. Petersburg.

According to Kim Murphy of the Los Angeles Times, "The economic earthquake of Russia's transition from communism to capitalism plunged tens of millions into poverty overnight and changed the value systems upon which many had planned their lives. A small minority, mostly in urban centers such as Moscow and St. Petersburg, were able to exploit the absence of rules in the chaotic 1990s to become fabulously wealthy. But such a profound social transition, coming at the end of a century of war, revolution, and ruthless social experimentation, condemned a great many more to a deep malaise. Those who lost out have proved susceptible to drinking, smoking and other habits that killed millions of Russians even in the best of times. In more extreme cases, they kill themselves.'

Russia's suicide rate, at about 36 per 100,000 people, is second only to that of Lithuania, according to the Serbsky National Research Center for Social and Forensic Psychiatry. In some remote areas of Russia, the rate exceeds 100 per 100,000.

Some say the cause of Russia's problems can be found in communism's willful destruction of generations of the country's most capable and adaptable people. "Seventy-five years of Bolshevik life in this country led to the formation of a tribe of people which was cultivated to listen to orders, and fulfill them," said Alexander Gorelik, a St. Petersburg physician. Stalinism, he said, aimed for "the planned and gradual physical destruction of the most moral, the most creative group of the population".

"There is such a thing as a will for life," he said. "And the whole trouble is that the Russian public in general, and especially the male population, has a big deficiency in this area."

Historically, with Russia and China being the equalizer to the Khazar Zionist plague, and with NATO playing "Stratego" around Russia maybe some of the things she does take on a new meaning.

The term 'oligodynamic' [silver refers to] solutions in which the metal ion concentration is many orders of magnitude below that which would be lethal to higher life forms. Silver has been used to preserve beverages, treat infections, purify water and accelerate the healing of wounds. Also, most antibiotics that kill bacteria will not kill fungus/ yeasts, protozoal parasites or viruses; antifungal antibiotics will not kill bacteria, viruses, parasites, etc. And virtually all known viruses are immune to virtually all known antibiotics."

"Silver is unique among antimicrobial agents in its broad spectrum of action. It has been claimed to kill some 650 different disease organisms. Erap and Binay are two politicians steeply identified with the masses and whose political durability in fact, can only be explained by the depth and intensity with which the masses identify with them. In fact, Erap and Binay command a monopoly of that identification and one will be hard put naming any other who would even distantly approximate the position which the fallen President and the Makati mayor occupy in the mind and heart of the underclass.

Can Malacañang be assured that when Erap's masa and Binay's masa converge toward a combined assault on Malacañang, the AFP will remain united behind Malacañang? When that point comes, Malacañang can't even be assured that Gen. Hermogenes Esperon Jr. will stick by his commander-in-chief.

There is only one way, of course, that the bloody logic of the convergence can be aborted, and that is if the Armed Forces, at this stage, were to withdraw its institutional support for Malacañang, as it did in Edsa I and Edsa II. But will it this time?

We don't know, and nobody can say because unlike her then incumbent predecessors in office, Marcos and Erap, GMA appears to have perfected the skill of maintaining the Palace hold on the AFP. And that in the face of the continuous expression of dissent and factionalism within the AFP.

Ironically, it isn't really GMA that's on the spot. All she has to do is maintain her ground and keep on doing what she has been doing all along to maintain the institutional loyalty of the AFP.

It is actually Erap and Binay who are on the spot. For the overriding political question now is what do Erap and Binay do? Keep on shouting for GMA to resign? Well, there's nothing that can make GMA resign except possibly a declaration by the AFP that it is withdrawing its loyalty and support from its Commander-in-Chief.

If Erap and Binay really want to see GMA resign, they both will have to take the fateful step of jointly calling on the AFP to withdraw its support from Malacañang. And then see what happens. But they simply will have to make the move — call on the AFP to withdraw support from Malacañang — if they are to show to all and sundry that they mean what they say when they say GMA should be out.

So far neither Erap nor Binay has issued that fateful call. And the question is, will they dare issue that call? That's what their followers expect them to do. But that doesn't necessarily mean they will do it.

At the end of April 2006 a certain agency of Global Alliance Investment Association (which shall remain unnamed for now) was approached by an agent of the IRS with an allegation of possibly unlawful activity and a request to submit a comprehensive list of documents for review.

Global Alliance Investment Association shares with Cosmos Seafood Energy Marketing, Ltd. the status of Creditor with regard to the United States Treasury (documented by cross resolutions which have been previously publicly noticed). The Internal Revenue Service is the collection agent of the United States Treasury (for the Federal Reserve System and International Monetary Fund—and ultimately the International Bankers), i.e., the debtors. Thus, the action of the IRS was a case of the debtor making demands of the creditor.

Our initial response was to both Mr. John Snow, then Secretary of the Treasury, along with a Notice to Cease and Desist Actions against the Creditor to the Internal Revenue Service's Mr. Gerald Reese. Mr. Snow immediately resigned as did the General Counsel. There has been no protest against the Cease and Desist Notice.

In late July, however, a letter from a Special Agent of the Treasury Inspector General Tax Administration (TIGTA) suggested that the letter to Gerald Reese could be construed as "an attempt to interfere with administration of internal revenue laws through corrupt or forcible interference". There is nothing, of course, either corrupt or forcible about our contractual, commercial position.

Our response to the agent's suggestion is contained in our letter of July 21 to J. Russell George, the head of TIGTA and the agent's top boss. There has been no protest or response of any kind to that communication.

# Lawful Avoidance Of Key IRS Designations

**Budget's "Tip of the Week" #8:** 

Avoiding the IRS Designations of:

"Personal Service Corporation", "Personal Holding Company" and "Controlled Group"

The tax advantages of properly operated Nevada corporate shelters may be secondary to the benefits of liability protection, asset protection and privacy but they are worth discussing all the same, especially since many tax professionals don't seem to "get it".

The IRS will tag a corporation as a "Personal Holding Company" and assess a surcharge of 39.6% on undistributed earnings in cases where more than 60% of the corporation's income is derived from "passive" sources such as dividends, interest and rental income. The IRS applies a designation of "Personal Services Corporation", assessing all income at a flat rate of 35%, in cases where a C corporation is engaged in the performance of personal services (consulting-type work) and where such services are performed by employee-owners. Yet another IRS designation is that of "Controlled Group", based on complicated rules for determining allowable cross-ownership of corporations, whereby the IRS seeks to lump all of the income into a single, consolidated return—resulting in the highest possible tax rate, of course.

Each of these designations is based on the corporation's OWNERSHIP. How very fortunate, then, that ownership of Nevada corporations is statutorily permitted to be very PRIVATE: It is not a matter of public record, only of the protected (by *NRS 78.257*) internal records of the corporation.

To be considered a "Personal Holding Company" a corporation must be owned by five or fewer stockholders. It is totally permissible for a corporation to earn 100% of its income from passive sources, as long as it is owned by six or more stockholders. It is similarly easy to avoid the designation of "Personal Services Corporation": Don't own the stock! "Controlled Group" status is also very easily avoided with Nevada corporations: Simply ensure that no entity owns 80% or more of any other entity and that in brother-sister corporate relationships there are six or more stockholders. As no liability is attached to stock ownership, surely you could find a trustworthy friend or six who wouldn't mind holding stock in the corporation? If not, give us a call—we know of hundreds of corporations in similar circumstances.

With regard to "Controlled Group" status, the IRS has from time to time invoked *Section 482* of the *Infernal Revenue Code*, which lumps together income from corporations if they APPEAR to act out of a unity of interest. To our knowledge, however, even this blanketing regulation is relatively easily overcome, as long as the corporations act in their own, separate, well-documented self-interest.
