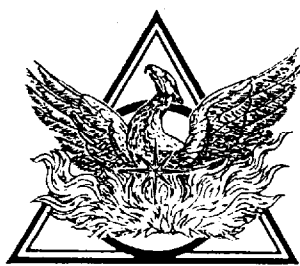

What is Salvation ?

Introduction to Hatonn

I am Gyeorgos Ceres Hatonn, *Commander in Chief, Earth Project Transition, Pleiades Sector Flight Command, Intergalactic Federation Fleet*. You may call me Hatonn. I am come in service unto the ONE GOD of Lighted Creation, and as "Host" unto His people who will be brought into His places long prepared for you. My own "Captain" is Sananda, the Christed Being you have called by many names--now one totally with Creator/Creation. [Sananda: simply meaning of/with God]. We are not "mystical" nor even "mysterious" aliens. We are the "Hosts" sent in preparation for His return, bringers of Truth according to His promise and to reveal the lies foisted upon you to claim your souls for the physical evil Elite controllers. We come in total love and without intent of force, coercion or judging. "Judging" is a state of evaluation of self in the presence of Creator in which actions in the physical experience are evaluated.

The information within the documents revealing Truth, THE PHOENIX JOURNALS and LIBERATOR, are the outlays of lies and hidden facts for which you can find confirmation. If you don't know the problems and the source of the problems, you can have no solutions.

"LIVE BY THE FLESH AND YE SHALL DIE IN THE FLESH." Then all those "things" which seemed so wondrous to have in the flesh cannot even be "touched" in the Spirit and all those things which "felt" so good "so do it" will be equally as removed from your expression. It seems the better part of wisdom to think on these things.

It is not the "death on the cross" which has meaning for that was a physical death by ALL of your touters--it is the LIFE of the being which had value--not the death of physical housing. HIS SACRIFICE WAS NOT YOUR SACRIFICE--YOU WERE THE VERY ONES WHO MURDERED HIM AND NOW MAKE YOUR RULES TO SUIT YOUR CRIME. He, this sacrificed lamb, may well forgive you and you may "claim" it if you have made yourselves worthy--but through no other route can you receive same. YOU HAVE MISSED THE DIFFERENCE IN THE TERMS "JESUS", "IMMANUEL", "EMMANUEL", "ESU", AND CHRIST. "CHRIST" WAS NOT A PART OF HIS NAME--IT WAS HIS "STATE OF BEING". And, a "Christ" does not go about voting in pleasing laws to suit mankind.

Does this mean, then, that ones who praise God and honor "Jesus" are discounted in my journey? Of course not. However, they will likely deny the presence of the Host and also the Master returned for they are seeking the wrong personage. They will withdraw and never take the opportunity of the lifeboat while awaiting the wondrous rapture. To rapture as projected means absolute and total death of the physical being--it does not mean Ascension. It means that, literally, you have to "disperse" the physical being to maintain a density capable of being within a cloud. Without intent of moving on into security--the being cannot endure the trauma and the physical will perish.

Why is there trouble in merging the expressions? Because one is fed by the Lie and the other by the Truth and the projecting speakers KNOW WITHIN, the errors. There is no need for defense as to belief, for if the intent is Godly, what is there to defend? If all of your time is spent defending physical manifestation and actions, you

Yes, you DO have to choose for you can't have it both ways unless you choose the way unto God. Russian military in confrontation with U.S.A.

U.S. ambassador to Russia, Robert Strauss today advised President Bush, the Secretary of Defense and Pentagon Joint Chiefs of Staff at a hastily summoned meeting not reported to U.S. media that all efforts by the special envoy and State Department official Niles, who accompanied him, have failed to get an assurance from chief of the Soviet Armed Forces Marshal Orlov and his top generals, that control of Russia's nuclear arsenal will be returned to what Strauss called "civilian control".

Moreover, led by Colonel Viktor Alksnis, U.S. envoys heard Boris Yeltsin denounced as a "lackey of Washington". The phrase most often used by Alksnis in the past about Yeltsin was again repeated, i.e., that he is a "money grabbing

opportunist not to be trusted". Without actually saying so, the military leaders implied that they would not accept the leadership of Yeltsin or Gorbachev. They did say that a "new organisation with the full backing of the Russian people will bring order out of the chaos in the wake of the drunken spree on democracy."

Russian forces based in the eastern part of Germany, and still equipped with tactical and short range nuclear weapons are on a state of high alert, that is, on a war footing for the next 7 days. These forces are well trained and represent a serious threat to NATO and Western Europe. Military forces in Russia are on a state of alert somewhat below full alert. It is common knowledge that the Soviet Armed Forces, if a surprise attack is launched using

conventional and Spetznas forces, could brush NATO forces aside and cut a swathe through Western Europe and Scandinavia within 3-5 days. THIS CONTINGENCY PLAN HAS NOT BEEN ABANDONED AND SOVIET NEGOTIATORS REFUSED TO INCLUDE DISCUSSIONS ABOUT IT IN ANY OF THE ARMS REDUCTION TALKS THAT HAVE GONE ON BEFORE.

EEC leaders are greatly alarmed by today's developments with the Russian military, and are now starting to realise what we said 10 months ago, namely, that the U.S. would have to deal with the military in the final analysis. In our INSIDER REPORT March 1991 No.1, "BAKER TAKES A DRUBBING IN MOSCOW" (see copy attached) Baker was confronted FOR THE FIRST TIME IN THE HISTORY OF THE STATE DEPARTMENT by Generals Moisiyev and Akrohmeyer, who bluntly attacked him over the perfidious conduct of the United States military in the Gulf War.

In this report we said: "General Akrohmeyer restated his position that continued involvement between U.S. and Turkish forces was a threat to the Southern flank of the Soviet Union. Baker was bluntly told that any attempt to station U.S. troops in the Middle East on a permanent basis is viewed in the most serious light by the Armed Forces of the Soviet Union.

"A stunned Baker was then informed that the Conventional Forces In Europe Treaty negotiated by the deposed Eduard Shevardnadze was no longer valid. Baker was told that top and middle-rank officers declared themselves not bound to obey the terms of the treaty, and henceforth, the Soviet Armed Forces would not approve of any treaty which, in its view, favoured Washington.

"My source told me that shortly before Baker's visit to the Kremlin, further quantities of artillery, tanks and rockets were moved behind the

Ural Mountains. No efforts were made to hide these movements of arms, which is a serious violation of the Conventional Forces In Europe Treaty. It was as if the Soviet military leadership wanted Baker to know what was happening.

"Baker then tried to bring up the urgent matter of the stalled START talks and a summit meeting with President Bush and Gorbachev. He was not successful. After hours of frigid talks, based upon the objections of the military officers present (most of whom belong to the All Russian Party and Soyuz), Gorbachev informed Baker that the Soviet Union was not yet ready to move ahead with START talks and that there was no opportunity for a summit meeting in the immediate future.

"Clearly angered by the conduct of U.S. military in the war against Iraq, the Soviet military leadership has taken a hard line against Washington and is refusing to be a party to any further arms reduction talks. With its mighty arsenal of ICBMs and its large nuclear-armed submarine fleet, clearly the USSR can afford to take a tough line with Washington.

"All in all, Baker left Moscow considerably shaken and disturbed. No one doubts that in his report to President Bush he made the new attitude of the Soviet military leadership and other Kremlin notables perfectly clear.

"Not that the dangers posed by the changed attitude of Moscow toward Washington will have any effect on President Bush who is riding high on his great victory over Iraq. Bush is like a man who has had far too many glasses of wine. Supported by foolish and ignorant statements, like those made by Senator Gramm that 'the U.S. is the only super-power today' and bolstered by the bandwagon support of Senator Sam Nunn, Bush is in no mood to be concerned about Moscow. In this attitude lies the seeds of The Third World War."

how far the United States has drifted into the path of the Russian war machine under the leadership of President Bush. Like the "Titanic", Mr. Gates's assessment--when he does present it--may well have come to late.

All through the year from March up until this month, our INSIDER REPORT and WORLD INTELLIGENCE REVIEW issued warning after warning that the danger of a confrontation between the U.S. and the Russian Armed Forces was building. Yet in spite of the rough treatment handed out to Baker, the Bush administration paid scant heed to rumblings from the Russian military as we reported in this Insider Report 10 months ago. The American people should be able to judge from this what kind of leadership is being provided by President Bush, who apparently decided to treat the Russian military threat like he has treated the recession-depression--it simply does not exist.

This cavalier attitude and the fact that the CIA's new top man is scrambling to bring our intelligence services up-to-date at this late hour, should be enough to open the eyes of millions of Americans as to just

the Wall Street Bankers, the IMF and the World Bank will indicate that unless command of nuclear weapons in particular is returned to civilian control, all financial aid to Russia will be withheld.

Secondly, this arm-twisting message will be delivered by Baker to Yeltsin very shortly. Yeltsin will pass it on to the Soyuz group who have frequently said in public that they will not go the way of Tsar Nicholas II who had the financial rug pulled out from under him by the Rothschild Bank in Paris. The military high command will not take kindly to blackmail, however subtle.

In our Insider Report of March 1991 No 1., we printed the statement made by Valentin Pavlov, who is the new Prime Minister of the Soviet Union, accusing the United States of running financial warfare--including withholding of credits for grain purchases--against the Soviet Union and of trying to cause hyperinflation of the kind experienced in Germany in 1924.... Pavlov made it clear to Baker at that time that pumping up Yeltsin would fail and that the "U.S. financial plot" is related to the position taken by the Soviet Union in the Gulf War.

Baker's task will be far from easy. Russia has very substantial quantities of physical gold which the military could seize. It also has huge reserves of oil as yet untapped in addition to being independent of outside supplies. Therefore, even for the Committee of 300, which Orgakov is fully familiar with, it will not be a pushover to wrest control of nuclear weapons from the military. Clearly, if the military does eventually agree to give PARTIAL CONTROL to the new commonwealth, there will have to be some heavy trade-offs.

Remember, the key will be that only partial control goes to the civilian government, with the balance of power still in the hands of the military. If this is agreed upon, then the U.S., the financial institutions and the Committee of 300 will have to ensure that the Russian people do not suffer serious privation

this winter. Any attempt to hold such agreements in check will result in a deadlock, with the Orgakov military machine possibly supporting Gorbachev, whom they don't like but who is still preferable to Yeltsin.

Although on paper it looks as if the West has the upper hand, this is not actually the case. If the Russian military leaders decide to go it alone, they may very well implement the Orgakov Plan which would result in the capture of Western Europe and Scandinavia within 3-5 days, with all of their combined resources. Germany is likely to side with the Soviet military, which is a key factor in this equation.

Any nuclear exchange would serve neither side, besides which the Soviet military holds the balance of power as it does with Chemical and Bacteriological Weapons and Electromagnetic radiotronic-microwave weapons. These could easily be unleashed against the United States without causing damage that would destroy assets on both sides in a nuclear strike. A Russian military attack utilising its ELF-CAB weapons would devastate the United States and cause the death of millions of people. Not even the Committee of 300 is prepared to take such appalling risks at this time.

The most likely outcome will be an agreement between the military and some civilian authority--which has yet to be determined--which will leave the world with a very uneasy unresolved situation in which the West will hope to gain time to act more decisively at a later date. Do not be deceived by press reports which will, after this weekend, indicate that the Russian military have relinquished control of its weapons and that Baker has had a successful mission to Moscow. Orgakov has already indicated that none of his commanders will meet with Baker and that their dislike of Yeltsin remains as strong as ever. ●

Mr. Johann Rupert, who is taking a close personal interest in the oil venture, yesterday leaped to George Bush Jr.'s defence and described the allegations as political smears timed to coincide with the

[H: Of course this does not even consider the pool of Light Crude (the largest in the world) waiting for them to give the word in Saudi Arabia or the mountain which is purely a mountain of gold in the same area.]

The Rupert family's dealings in the US oil business first attracted attention in 1988 when the Rembrandt Group suddenly took control of Denver-based Frontier Oil and Refining Co.

agreement, your gold started flowing out of the United States in a hemorrhage that went on for almost seven years. One courageous Congressman, Frank Chelf of Kentucky, spoke repeatedly on the floor of Congress about what was happening to your gold. He made sworn statements about the secret shipments of gold out of Fort Knox during those years. But throughout the halls of Congress the warning words were ignored and buried.

Then it appeared that Sen. William Proxmire would be among the ones who would take some action but the Elite were way out in front of that poor dupe. I have already asked the Treasury Department's Inspector General to look into the matter and give me a complete report.

"In view of your correspondence, however, I am also asking the Justice Department and the General Accounting Office to also investigate the situation you outline. The General Accounting Office is an investigative arm of the United States Congress. Once I have this information I will be in a better position to determine whether any future action is warranted.

"Sincerely, William Proxmire,

So what happened? Eventually there was a total blackout of all information and what came forth was classified as Top-Secret--National Security. "To secure control of nearly one-half of the world's total gold supply requires only securing control of the White House. The key to these great vaults is hanging on the wall of the President's private office."

In 1982, a new Soviet administration, known as Upravlenie Delami (Central Business Directorate), was set up in Moscow under Nikolai Kruchina, a top communist official. Chase Manhattan, then the only U.S. commercial bank with an office in the Soviet capital (under Western name), became the international financial adviser to the new agency, which was responsible for the Soviet Government's global financial interests.

TENS OF BILLIONS

Not just the Soviet Government; Kruchina was also in charge of handling the Communist Party's clandestine international financial network. Tens of billions of dollars in hard currency, gold and diamonds went into this giant fiscal laundromat, to reappear in sanitized joint company and nominee holdings of the Soviet Communist leaders in dozens of major Western banks.

The course is in three parts--Essays on Satanism, The Bible Reconsidered and Black Grimoire.

Those who pay \$30 and complete the course sign an affirmation of satanic allegiance and get a certificate of ordination into the satanic priesthood.

Also available is an audio cassette on the fundamentals of satanism and a refutation of Christianity by someone called Faustus Scorpis, Magister of the Order of the Left.

Ranting about exposing Christianity, the order says the New Testament shows Jesus to be as "psychotic and megalomaniacal as the alleged father Jehovah".

PROPHETS 'SCUM'

The correspondence course says the Old Testament makes it clear that patriarchs and prophets chosen by Jehovah to be revered by mankind as holy "are nothing but scum".

"Christianity gave history the dark ages, the inquisition and book burning and a mentality which even now motivates concerned Christian parents to burn books containing material far less immoral than the chronicle of rape and pillage contained in their own bible." [H: Touché--I can't fault the logic in relativity if you really study the historical path of bloodshed through the Crusades and Inquisition in the Name of Holiness and Christ. I believe it must point up the facts as I have outlaid them to you--something got tampered with pretty rottenly as to what a beloved Brother called "Christ" actually said and did. Police, say they are helpless to stop satanic ritual weapons being ordered by mail from a shop in Pahiatua.

KIDS KIDNAPPED FOR SEX AND SICK MOVIES

There are two active investigations into child pornography and satanism in New Zealand.

A group of researchers in Wellington has spent months questioning former satanic cult members, while a TV3 reporter in Christchurch has spent more than two years investigating a local child pornography ring.

But the investigation in Christchurch came to an abrupt halt because police said they had run out of leads.

This was after they had raided 14 houses in top suburbs and arrested and released a suspect.

The TV3 reporter, M.R., has continued her investigations which were first aired on *Sixty Minutes*.

On that programme, former police detective Brent Hyde, now a private investigator, told of tots being picked up in flashy cars and taken to homes in Christchurch where they were forced into sex acts.

The children described the homes they were taken to as "rich man's houses"--even having similar

wallpaper and a sporty red American car being parked outside.

Hyde said the children were picked up after school while their parents were still at work.

"It was like a Mafia set up. The children talked about teenagers who dressed alike in black and leather and rich men in suits who made films of them.

"When they got to these houses people were actually waiting to abuse them and work on them and film it.

"It was well organized. The children still live in fear. There was even glue and alcohol to soften them up.

"One girl still won't go back to school. She was told she would be killed. That her head would be cut off if she told anyone."

Investigators uncovered sev-

eral overseas connections, including dossiers about an American group called Nambia.

This stands for North American Man Boy Love Affairs.

But after months of probing, the police investigation was abruptly halted.

A man who had been arrested and let go, ostensibly to lead police to others, didn't.

Roger Carson, the police inspector in charge of the operation, said his men had run out of leads.

Wellington are being carefully questioned about a satanic ritual abuse they say they endured during childhood.

Counselling them are Jocelyn Frances and researcher Anne-Maree Stapp. The victims come from satanic cults in the lower North Island.

Threats, brainwashing and shame kept their secrets locked up until now.

But the counselling process is getting results, according to XXXX.

"A breakthrough is close. Just down the road," *Crimewatch* presenter XX said this week as he flew to America to investigate growing international porn and satanic rackets.

"This is a slow process. Secret societies and cults are just that--very secret and very hard to crack open."

Mr. XX has been digging into devil worship and other cults for more than a year. On a recent visit to the U.S. he spoke to a woman who had just emerged from a cult closet.

She told of awful rituals in which she was forced to take part, including human and animal sacrifices and the use of animal parts to abuse children.

Researchers say there are probably half a dozen satanic rings in the nation.

Auckland and Christchurch harbour the main two, while Wellington's seems to be dormant. According to researchers, a common factor in cults is the leader's greed for power and money.

One of New Zealand's experts on satanic ritual is Wellington probation officer N.M., who studied the subject as part of his Master's thesis at Victoria University.

He believes chances of cracking open satanic and ritual cults are slim.

"They've been around in this country as long as Christianity. I've met up with satanists and also with dabblers."

Mr. M. said more 'lay satanists' were being seen by the probation service as things like heavy metal music gets more popular. "They wear black T-shirts, jerseys, jeans and shoes and they are open for offers," he said.

"These are looked on as prospects by those running the cults. They're invited to parties where there is free booze and sex and they are offered a chance to go up the ladder to the top where the greed and money gather."

SATANISM AND CHILD ABUSE

Something is happening in America: a bizarre episode in mass hysteria or a conspiracy of unspeakable evil. [H: I shall leave the author anonymous for he has been so under attack that he asks hiding.]

THE FIRST THING to greet a visitor to Planter Street is a Neighborhood Watch sign, prominently placed just off the intersection, warning intruders that residents are organized and vigilant against any nefarious doings.

Planter Street is at the southern end of a residential tract in Pico Rivera, a blue-collar city in the in-

dustrial fringe east of Los Angeles. It has cul-de-sacs at each end, which serve as blacktop playgrounds for children from small homes that line it on both sides.

This day, as on most warm afternoons, children are everywhere, gathered in groups in the street, racing their Big Wheels along the sidewalks, banging in and out of screen doors.

Mothers are visible too, talking together or standing alone on front porches. Traffic moves slowly, with careful regard for the running, laughing children. Even the quality of the sunlight, diffused by smog and trees and grass into an orange haze, contributes to an atmosphere of suburban tranquility.

But the mood quickly dissipates as I speak with Henry (not his real name), a slim, knock-kneed nine-year-old.

Henry stands on the porch of his house. His mother sits quietly on the steps below him, his little brother plays with friends in the nearby street. Henry speaks breathlessly, fitfully, his eyes darting about.

He says it began when a man living "across the street" sexually molested him and a friend. The incidents increased in frequency, as did the number of people involved--both children and adults--growing to include more than a dozen children from four families on Planter Street.

The activity then began to change. Instead of just sex and photography, the adults donned long black or white robes and introduced strange paraphernalia, much of it religious, including animal suits, crucifixes, candles and long trident staffs.

Other children, unknown to Henry and his friends, were brought in. Together they were taught chants and spells and how to mix potions. "We'd have to make a demon appear," Henry says, scratching his leg and looking nervously at his mother, who says nothing.

I ask him where these things happened and he continues. It started at one of the adult's homes but later moved to an old church, since destroyed by fire, near the 605 Freeway in Norwalk.

Animals were a central part of the ceremonies. They were tortured with knives or electrical prods and sometimes killed and dismembered, the blood smeared over the hands of adults and children alike.

On several occasions, Henry offers, the animals were replaced with human infants. The babies were suffocated and cooked in ovens and afterward their organs were removed and eaten.

I am silent, I've heard this stuff from investigators and seen it in police reports but there is something very unsettling about hearing it from this young boy.

"They'd throw a baby in the oven and turn it on full blast," Henry says. "They let it go a few minutes, then pull it out, and there would be a dead, bloody baby."

HENRY'S STORY

HENRY'S story, the Planter Street case, is typical of scores if not hundreds of others. These are multiple-victim sexual-abuse cases, disturbing enough in their own right, but with a twist--the children will tell parents, therapists and police that they have been the subject of elaborate and sometimes bloody satanic rituals.

The charges have been repeated in great detail by children from widely separate communities, and their allegations supported by medical evidence of molestation and sexual penetration.

And yet, despite massive police investigations, not a single piece of corroborating physical evidence has come to light. No photographs, no bodies. Nobody has confessed and not a single accused perpetrator has been convicted.

Moreover, for the charges to be true, there would have to be dozens of people, perhaps even hundreds, involved in transporting, abusing and terrifying these children, all without once being discovered in the act. [H: Now this is seemingly true, is it not? How about when the observers and protectors (so-called) are the perpetrators?]

We are faced with a terrible enigma. If what the children say is true, it is the crime of the century, a deep and widespread conspiracy

to abuse and exploit innocent young victims, leaving scores of mutilated lives in its wake.

Or, almost equally incredibly, vast numbers of children are lying in sync. They, with parents and medical professionals in tow, have embarked on a bizarre and psychotic episode, enlisting law-enforcement on, literally, a 20th-Century witch-hunt.

Los Angeles County District Attorney Ira Reiner shocked the broad audience watching the McMartin Preschool child-abuse case with his decision to drop charges against five of the seven defendants. He attempted to defuse the ensuing critical crossfire by explaining his reasoning in an interview with the Los Angeles Times but only further clouded an already murky picture.

Reiner said he had suspended his usual criteria in bringing criminal cases--that his attorneys have a strong chance of obtaining a conviction--and instead adopted the role of judge, asking his prosecution team if they personally believed each defendant was guilty.

Reiner's decision and subsequent explanation left nagging, embarrassing questions--of legal ethics, of the \$4 million dished out to bring all seven to trial, of why two should be tried on virtually the

same evidence as the five who walked,

But to the small community of investigators and experts close to the phenomenon of satanic child abuse, Reiner had little choice. He was faced with a prosecutor's nightmare--vast allegations and virtually nonexistent physical evidence.

His office was not the first to face this dilemma. [H: After all, you don't usually walk into the mutilated, cooked and dismembered bodies in an apartment as with Dahmer. Evidence is DISPOSED OF PROPERLY AND FOREVER!]

The most notorious case to date took place in Jordan, Minn., where 24 of the town's 2663 residents were accused of playing sexual games with children that culminated in the sacrifice of animals and small infants. At trial the case collapsed in the face of contradictory testimony by children and the recantation of the star adult witness. Following the fiasco, the prosecutor resigned in disgrace.

In Bakersfield, Calif., in 1985, longtime Kern County Sheriff Larry Kleier caused a storm of controversy when he announced an investigation into charges that as many as 77 adults had participated

in satanic child abuse, including child sacrifice. Kleier quickly drew fire from the county grand jury, on grounds that the children's statements had been prompted by investigators. Kleier stood by his charges, however. "I'm convinced these children are telling the truth," he told a news conference.

The state attorney general's office has stepped in to review the case but no findings have been issued. [H: This is because ones from the judicial system are involved and unnamed (here) judges sitting on the superior court benches are involved, also. There is even a ranch where homosexual activities take place outside of Bakersfield where high officials often frequent "the retreat". I have no intentions of making the way even one step harder for my people in this property case--but what you don't know is beyond your wildest imaginings. own CNN Larry King supplying children to political personages at a political meeting, through his resources. I shall not further comment for this is not MY story unfolding herein.]

In Southern California allegations connecting sexual child abuse with satanic activity have been part of the McMartin case for well over a year.

The second child witness to take the stand said he and others were taken to a church where adults dressed in black robes and wearing plastic masks engaged in candlelit chants. After the robed figures departed, the child said, teacher Ray Buckey stepped up to the altar and "cut up" a live rabbit, warning that the same fate would befall anyone who learned of the strange rituals.

As the children's stories grew stranger and more frightening, even the members of the prosecution team began harboring doubts about the charges. They had detailed testimony and corroborating reports from medical examinations. But still no photographs. No tangible evidence.

But besides McMartin, four other South Bay preschools have been closed by state authorities for

investigation of sexual abuse. Testimony in two of those cases has involved allegations of satanic activity.

And outside the South Bay, children from three communities miles inland have related similar accounts of sexual abuse, rituals and black magic. I looked into these cases in detail. Henry's story is part of one. I don't claim to have an answer, but this is what I found.

THE PLANTER STREET CASE

IN APRIL 1984 deputies from the Los Angeles County Sheriff's Pico Rivera station arrested two men and two women on charges of kidnapping, conspiracy, false imprisonment and sexual assaults on children. Bail was set at \$100,000 each.

The investigation and subsequent arrests were based on charges made by 10 children from four different families, all residents of Planter Street. The case was brought before Whittier Municipal Court Judge Patricia Hofstetter, who dismissed the charges after two children testified during a closed, 10-day pretrial hearing.

One of the children recanted on the stand, Hofstetter recalled in an interview, and the second con-

tradicted himself in his testimony.

Months later the four defendants filed a civil suit charging slander and malicious prosecution and naming the parents, children deputy district attorney and 26 sheriff's department staff members involved in the case.

While the initial hearing was in progress, however, the children made continuing and more detailed charges, including descriptions of satanic rituals and child sacrifice. The sheriff's department responded in July by establishing a special task force consisting of eight full-time investigators.

The task force spent four months working solely on the Planter Street case, sending deputies as far afield as Texas. No new evidence was produced and no new charges were filed, but the case remains open.

Sheriff's Lt. Bill Stonnich, who headed the task force, said the unit was created because the allegations were continuing and because strong medical evidence convinced the department "that some of the victims had in fact been abused." [H: I have often been asked how can this occur regarding stories, etc. I repeat: the same ones who perpetrate the atrocities use mental control. It is more simple to

erase the visions from the child's mind or totally confuse the thought patterns as to render the testimony totally useless. This can, furthermore, be done on a telephone to the child, once the dependence on the hypnotist is established. So, the next logical question is, "Could it not be that the original stories were simply put into the child's mind!?" Yes, but it is hardly likely for what purpose would be served in doing so? The point is that the child told and now the adults in point are in trouble. The former would be totally 'possible' but even more "improbable" for the original contact with the child hypnotized must be made by personal contact over a period of time so as to set aside the child's own resistance. The point is to suppress the child's ability to remember. This is doubly easy for the child reacts with horror to the encounters and will automatically suppress the incidents and circumstances, especially if in fear and/or facing disbelief. This happens all the time with abuse victims in ordinary homes where incest and physical/mental abuse are present. It is in no wise even unusual. The perpetrators simply know this and follow their rules.]

"We've spent literally thousands of man-hours on the case," Stonnich said.

n nearby Whittier local police assembled a similar but smaller task force to investigate allegations by two young children, a brother and sister, of repeated abuse while they were attending Broad Oaks School, a child-care center run by Whittier College.

The little girl, then three years old, first complained of molestation by a classmate. But during 12 weeks of therapy at Whittier's Intercommunity Child Guidance Center, she eventually described extensive ritual abuse, with much photographic, exotic paraphernalia and child sacrifice.

According to Whittier Police Capt. Richard Shelter, four investigators interviewed 64 families with children who had attended the school. "We came up with no indication of any criminal activity, no

statements to support the allegations," he said.

Shelters added that he was not convinced of the significance of a medical examination performed on one of the two children that showed "excessive relaxation of the rectal sphincter consistent with rectal penetration".

Shelters conclusion differed from that of Dr. Daniel Higgins, the child-abuse expert who conducted the exam. His findings were not conclusive, he said, but were sufficient to warrant police attention.

"Many of the findings in cases (now being prosecuted) around the city are 'soft' findings like this," he commented in an interview. "The child has a good story and the findings were consistent with that story."

Also in 1984, police in Covina, Calif., received a call from a doctor reporting an unusual rash on the buttocks of a boy who attended the preschool run by Covina First Baptist Church. Over the next six months parents of children from four families charged that their children had been molested while attending the school and had described strange rituals involving chants, magic and the sacrifice of small animals.

City police conducted a broad investigation, including administration of polygraph tests to most of the teachers and staff at the school. No evidence was turned up and the case was closed. "This was top priority--we checked every lead," said Covina Police Chief John Lentz.

Last April, three of the families filed suit against the school and also charged the police with doing an inadequate investigation. In pressing their case, the parents relied heavily on medical exams conducted by Escondido pediatrician Mary Spencer, who found extensive rectal scars that she called "very strong evidence."

"I hated to see this case thrown out, because I think it is a good one," said Spencer, who has handled more than 400 such cases. "I think the department was remiss in dismissing it," she said.

Other medical experts say they are convinced of the truth of the strange allegations made by

children around the country.

"The reason kids talk about rituals and chanting and wearing robes and killing babies is because it happened," insists Michael Durfee, a child psychiatrist and medical coordinator for the county Department of Health Services' child abuse prevention program.

"I don't want to believe that people are doing these things to children, but the stories are too patterned, too consistent, not to be true."

Durfee said young children simply don't have the capacity to fabricate the kinds of detailed stories that are now being investigated.

"Kids that age will come up with some wonderfully fanciful kinds of stories if you ask them to. But when you have a kid who says, 'The man took the rabbit and cut the head off,' and you say, 'Wasn't it the ears?' and the kid says, 'No, it was the head,' then I flat out believe him."

For some researchers in the field of child abuse, the question is not whether ritualistic abuse takes place **but for how long.**

"I wouldn't discount the children's stories because I have worked with adults who have talked about being involved in this kind of activity when they were young," said Trula de la Calle, a Santa Ana psychologist who specializes in cases of multiple personalities. "It wouldn't surprise me if this sort of thing has been going on for centuries."

Donald Schafer, a psychiatrist on the clinical staff at the University of California Irvine Medical School, said incidents of satanic or ritualistic abuse have emerged as a primary factor in cases of multiple personalities. Schafer said the child victims block out the trauma of ritual abuse as they grow up, consequently developing split personalities as adults.

As for the current cases, Schafer said it was unlikely that the children are fabricating their stories of abuse. "Kids do not tend to make up things like this. Teenagers may, to get back at a teacher or something like that, but when kids are 10 and under, they generally do

not."

"And when they are filling in detail they couldn't get anywhere else, I do believe it."

COVINA BAPTIST CHURCH CASE

BUT GETTING a jury to believe is another matter.

"I knew right from the get-go that we didn't have a case we could take to criminal conviction," Covina Police Sgt. Dave Miles said of the Covina Baptist Church case.

"These kids are too young to stand up as credible witnesses in court. And the variety of stories and conflicts within them rendered the case unfileable."

Similarly, Whittier Judge Hofstetter said credibility was a key factor in her decision to dismiss the Planter Street case. "When the story starts to change, you have to decide: Is the child telling the truth now or was he before? It's not easy to say.

"It's probably true that the younger the child, the less likely he is to tell an intentional falsehood. But that doesn't necessarily mean the story is more accurate."

Hofstetter added that the fact that children make outlandish accusations does not in itself compel belief, "If children have the Old Testament read to them on their mother's knee, then they'll know about baby killings and things like that." **[H: So be it--from the honorable Judge's mouth directly!]**

The poor court record of the satanic cases comes as no surprise to Lee Coleman, a Berkeley psychiatrist retained as an expert witness by the McMartin defense team. To Coleman the cases fall apart because they are fantasies in the first place, fantasies instilled by the health professionals who interview the children at the first inkling of sexual abuse.

"I haven't seen a single case yet where the fantasy wasn't first stimulated by an adult," said Coleman who has consulted on trials as far away as Florida.

In videotapes of the children's interviews with therapists, Coleman said it is apparent that the children are being "manipulated and indoctrinated" into wild stories of abuse.

The bizarre nature of the stories is proof that they did not

take place, Coleman said. "While you can manipulate the child, you can't control his fantasy, so you come up with some of the most wild things imaginable."

Coleman also discounted the medical evidence turned up in physical exams of children. In both instances, he said, overzealous adults are using the children to exercise their own desire to play the role of saviors.

"It feeds on itself. Everybody would like to protect children. There's a strong temptation to come to the rescue."

Even those who are convinced the children are telling the truth concede that Coleman has a point. "The problem with a case like this is that the child's natural reaction is to deny everything," said Roland Summit, a psychiatrist who specializes in child abuse.

"In order to get the story of what happened you have to tease it out. You have to make the child feel safe and supported. What we need is a rational forum that isn't dominated by justice-system imperatives," Summit said.

"Justice-system imperatives" like the Bill of Rights?

But what about the courts? They have proved sufficient, to some degree at least, in whatever perplexing conflicts we have been able to get ourselves into until now.

In these cases of alleged satanic ritual, however, the courts have had to deal with almost overwhelming problems. The McMartin proceeding even without the introduction of satanic aspects is the single most expensive case in state judicial history. **[H: And you will find after it all settled down some years later--all were acquitted.]**

Moreover, the prosecution in the case, despite succeeding in obtaining indictments against seven defendants, decided on its own to drop charges against five. And dozens of children, whom the process was designed to vindicate, were ultimately pulled from the case by their parents due to the damaging psychological effect of the trial itself. Other courts elsewhere had the same disappointing results.

At least part of this breakdown is explained by the nature of the conflict. For each of the six in-

dividuals involved--children, parents, investigators, medical professionals, attorneys and even judges--these cases are invariably the most troubling, the weirdest, they have ever had to face.

For the families, once the children utter their terrible stories, their normal workaday existence is gone.

The children's behavior changes radically. They are hyperactive, frequently begin masturbating and playing with their feces and become subject to unpredictable fits and tantrums. The parents face days filled with anxiety, with frustrating phone calls to police and attorneys and therapists, with paranoid fears for their children's safety.

Some are overwhelmed. They withdraw, they make plans to leave town; like their children, they lose faith in the humanity around them. Others like Vicki Meyers, become obsessed.

MRS. MEYERS

ONE OF THE Planter Street parents, Meyers is on the phone from morning until midafternoon, talking with a network of parents, investigators, experts and cops that reaches from Washington to Manhattan Beach, Calif.

Then she is gone, wheeling through the South Bay, meeting with investigators and other sleuth/parents, chasing down leads. She says she's been assaulted twice. Easier to confirm is the time she was arrested, at 3:00 A.M. outside a topless bar in a sleazy part of Whittier, in the process of trying to purchase pornographic pictures to see if they included shots of her own children.

Meyers is savvy, she is reckless and she is full of verve in her pursuit. "When I first found out, I was livid with anger. I never disbelieved it, because it was my three-year-old--he was two at the time and they just don't make this kind of stuff up.

"He was afraid to go to bed and I asked him why. He said, 'Because of the spiders.' I said, 'C'mon, there are no spiders under there,' and he said, 'Oh yes there are, the man down the street told me there are.' I said, 'What man?'

And he said, 'The man who ties me up and puts me in the closet'."

She laughed and went on talking about the sheriff's investigation, which she said had been botched. I couldn't help remarking at her nonchalance.

"I'm kind of running on anger," she answered. "You can't get emotional about it--you can't even think about it. Anger is what's saving me. I know that if I let myself get scared, I won't be able to keep it up."

Meyers is at one extreme but there are dozens like her--parents new to the field and longtime investigators--all seeking some tiny bit of physical evidence that would bear out what the children have been telling them. And yet, not a single photograph, not a single witness can be produced.

I needed an alternative to the charged emotions of the parents or the carefully crafted positions of the attorneys and the child experts. So I filed a couple of simple questions with the Sheriff's Information Bureau. How could all these children be making up these same fantastic tales? On the other hand, how could all this alleged criminal activity take place undetected?

A week of silence, then a phone call, "I wish you could give me an answer to that," said Capt. Jerry Minnis, chief of the Sheriff's Juvenile Operations division. Minnis referred the question to Tom Kerfoot, a deputy assigned to a special detail researching links between crime and the occult.

After declining to discuss any specific cases, Kerfoot said, "I'm firmly convinced that it's going on--that children are being utilized in satanic rituals. I don't think that it's an epidemic yet, but I think that it's there."

SANDI GALLANT

SANDI GALLANT, an officer with the Intelligence Division of the San Francisco police, is considered by many the leading law enforcement expert on satanic child abuse. Gallant recently compiled a list of questions that neatly sum up the current status of the satanic abuse riddle.

* Are these cases totally

separate or are they connected in some way?

* Why have no victims' bodies been found?

* Why are children's stories from different parts of the country, basically the same?

* Why are these cases surfacing in 1984 and '85, when they haven't before?

* If this is a part of some psychological phenomenon surrounding sexual child abuse, why were these stories never heard before?

Nowhere in the country are Gallant's questions more urgent than in Los Angeles County.

dence over all other religions. Worse than that, those who in our opinion are guilty of treasonous activities, blatantly and without reservation, violated the Constitution of the United States of America, to wit, the First Amendment: "Congress shall make no law respecting an establishment of religion..."

In flagrant violation of the First Amendment and the Bill of Rights, Congressmen Robert H. "Whereas this will be reflected in an International Scroll signed by the President of the United States and other heads of state; Now therefore be it resolved by the Senate and the House of Representatives of the United States of America in Congress assembled, that March 26th, 1991, the start of the ninetieth year of Rabbi Menachen Schneerson, leader of the worldwide Lubavitch Movement, is designated 'Education Day, U.S.A.'. The President is requested to issue a proclamation calling upon the people of the United States to observe such a day with appropriate ceremonies and activities." Are you rubbing your eyes? Do you think this is some kind of a bad joke? Well, let me tell you, this is a deadly serious hoax that has been perpetrated on the American people. Once He is successful, He rebuilds the Holy Temple in Jerusalem and returns the Jewish people to their homeland, his identity as the Mashiach will be certain. The Messianic-Age will have begun."

In the Week-Ending August

31st, 1991, edition of *The Jerusalem Post*, yet another Chabad Lubavitch advertisement appeared:

"These are amazing times. The Iron Curtain has tumbled...Iraq is humbled...The people of Israel emerge whole from under a rain-storm of murderous missiles...An entire beleaguered population is airlifted to safety overnight...A tidal wave of Russian Jews reaches Israel...Truth and justice take center stage, with America emerging as the leading global power..." Then on page 21 of the International Edition of *The Jerusalem Post*, week ending October 5th, 1991, the following books are offered for sale by Chabad Lubavitch:

KABALLAH FOR THE LAYMAN by Dr. Philip S.Berg. "The study of souls, karma and reincarnation, astrology and vast power sources that can be tapped."

EVERYMAN'S TALMUD "Helps readers understand the great power of post Biblical teachers and explains the history and make-up of the Talmud; summarizes its major teachings."

Let us examine some of the shocking liberties taken with we-the-people by Congress in passing the Public Law 102-14, and dissect some of the language of verbiage in which it is clothed:

"Whereas the Lubavitch movement has fostered and promoted these ethical values and principles throughout the world..." This implies that neither Christ, Mohammed nor Buddha nor anyone else for that matter "fostered and promoted ethical values and principles throughout the world..."

What audacity! greatest of all documents does NOT depend on some obscure Jewish sect "Chabad Lubavitch" and its leader, Rabbi Menachen Mendel Schneerson, of whom 99% of UNITED STATES CITIZENS have never heard. What great spiritual leader are they talking about? Schneerson is an obscure leader of some obscure Jewish sect! He is NOT universally known, except, perhaps, among the Jews. Christ, the Son of God, IS universally known, and He taught the greatest moral, ethical 'education and giving' mankind has ever received.

Is it "ethical" and principled to deprive the Palestinians of their land and murder and imprison thousands of them? Is it "ethical" and principled to have allowed Ariel Sharon to invade the sovereign nation of Lebanon and bomb, shell and shoot 30,000 of its citizens to

death? Is it "ethical" to allow the same Ariel Sharon to tighten the grip of the Zionist state upon the West Bank, where over 100,000 houses for Jewish settlers have pushed the rightful owners off their property and left them homeless?

Although the President of the United States looks the other way and does not uphold the Constitution which he swore an oath to protect, that does not mean that the rest of us have to follow his example. Is it "ethical" and principled to fight Christians tooth and nail to prevent symbols of the birth of Emmanuel the Christ to be displayed in public places, while they, the Jews, display their Menorah on public land in the City of Beverly Hills as they did all during the 1991 Christmas period?

(3) "Thou shall not shed innocent blood of any human nor fetus nor ailing person who has a limited time to live.

(4) "Thou shall not engage in bestial, incestuous, adulterous or homosexual relations nor commit an act of rape.

(5) "Thou shall not steal.

(6) "Thou shall establish laws and courts of law to administer these laws, including the death penalty for those who kill, administered only if there is one testifying eye witness.

(7) "Thou shall not be cruel to

animals."

"Well, what is wrong with that," some of us might say, "it looks as if they have some pretty good laws in there that should be made mandatory." The problem is that it requires a lot of study of Antelman's book and a very sound knowledge of Judaic law to see the hidden pitfalls in the "Seven Noahide Laws". The fact is ALL of the above (except for the death penalty) are ALREADY mandated in the teachings of Emmanuel the Christ and the teachings of the prophet Mohammed.

But let us begin with some of the glaring discrepancies in what the Jews say and what they do:

(3) The biggest supporters and financiers of abortion are found among the Jews. Why hasn't "the rebbe" openly and publicly denounced those Jews by name? Why doesn't "the rebbe" enforce his laws among his own people and bring those Jews who support abortion before ALREADY EXISTING Jewish courts which are in every city in the United States and indeed the world, wherever Jews have settled.

(4) The biggest supporters of homosexuality are found among the Jews. This is an established fact. Why hasn't "the rebbe" denounced Representative Barney Frank, who is an open homosexual Jew? Why hasn't "the rebbe" hauled Frank before the many Jewish courts in existence?

(6) Such courts have been in existence for thousands of years. The biggest opposition to the death penalty are the Jews, who have thousands of Jewish lawyers and well-financed groups led by prominent wealthy Jews who tenaciously oppose the death penalty. Could it be there is something sinister afoot here? I believe that there is, and it is to be found in the first and second of the "Seven Noahide Laws". Earnest Easterly, Professor of International Law at the Southern University Law Center, is on record as saying that "With further recognition by other

AND INTERNATIONAL COURTS, the Seven Noahide Laws should become the cornerstone of a truly civilized INTERNATIONAL LEGAL ORDER." Does this have overtones of the nature of a One World Government? It certainly does, and therein lies a very real danger.

Didn't Emmanuel the Christ suffer execution ordered by a Jewish court because his accusers said he had "blasphemed God". IMA's PREFACE

This is a first person preface.

My introduction to the intelligence business came during the early years of the Cold War, while serving with the U.S. Army in Germany. There, in 1952, I was sent to the European Command's "special" school of Oberammergau to study Russian and the rudiments of intelligence methods and techniques. Afterward I was assigned to duty on the East German border. The information we collected on the enemy's plans and activities was of little significance, but the duty was good, sometimes even exciting. We believed that we were keeping the world free for democracy, that we were in the first line of defense against the spread of Communism--whatever that meant, for the system was neither communistic nor suited to any other political term save that which we had just endured and fought against.

After leaving the military service, I returned to college at Penn State, where I majored in Soviet studies and history. Shortly before graduation, I was secretly recruited by the CIA, which I officially joined in September 1955; the struggle between democracy and Communism seemed more important than ever, the CIA was in the forefront of that vital international battle. I wanted to make a contribution.

Except for one year with the Clandestine Services, spent largely in training, most of my career with

the CIA was devoted to analytical work. As a Soviet military specialist, I did research, then current intelligence, and finally national estimates--at the time, the highest form of intelligence production. I was at one point the CIA's--and probably the U.S. government's--leading expert on Soviet military aid to the countries of the Third World. I was involved in uncovering Moscow's furtive efforts that culminated in the Cuban missile crisis of 1962 and, later, in unraveling the enigma of the "Soviet ABM problem".

From 1966 to 1969 I served as a staff officer in the Office of the Director of the CIA, where I held such positions as special assistant to the Chief of Planning, Programming, and Budgeting. Special assistant to the Executive Director, and executive assistant to the Deputy Director. It was during these years that I came to see how the highly compartmentalized organization performed as a whole, and what its full role in the U.S. intelligence community was. The view from the Office of the Director was both enlightening and discouraging. The CIA did not, as advertised to the public and the Congress, function primarily as a central clearing-house and producer of national intelligence for the government. Its basic mission was that of clandestine operations, particularly covert action--the secret intervention in the internal affairs of other nations. Nor was the Director of CIA a dominant--or much interested--figure in the direction and management of the intelligence community which he supposedly headed. Rather, his chief concern, like that of most of his predecessors and the agency's current Director, was in overseeing the CIA's clandestine activities.

Disenchanted and disagreeing with many of the agency's policies and practices, and, for that matter, with those of the intelligence community and the U.S. government, I resigned from the CIA in late 1969. But having been thoroughly indoctrinated with the theology of "national security" for so many years, I was unable at first to speak out publicly. And, I must admit, I was still imbued with the mystique of the agency and the intelligence business in general, even retaining a certain affection for both. I therefore sought to put forth my

thoughts--perhaps more accurately, my feelings--in fictional form. I wrote a novel, XXX, in which I tried to describe for the reader what life was actually like in a secret agency such as the CIA, and what

the differences were between myth and reality in this overly romanticized profession.

The publication of the novel ac-

IF YOU DOUBT ME AND YET YOU WISH TO CHECK HISTORY--NOTE THAT THE JEFFERSON BIBLE HAS REMOVED ALL OF PAUL'S WRITINGS--INDEED THAT WAS THOMAS JEFFERSON!

Therefore, you were birthed a "Christ-ian" in "Godness" nation to bear the lamp of freedom and symbol to a fallen planet as "God's cho-

completed two things. It brought me in touch with numerous people outside the inbred, insulated world of intelligence who were concerned over the constantly increasing size and role of intelligence work toward bringing about an open review and, I hoped, some reform in the U.S. intelligence system. Realizing that the CIA and the intelligence community are incapable of reforming themselves, and that Presidents, who see the system as a private asset, have no desire to change it in any basic way, I hoped to win support for a comprehensive review in Congress. I soon learned, however, that those members of Congress who possessed the power to institute reforms had no interest in doing so. The others either lacked the wherewithal to accomplish any significant changes or were apathetic. I therefore decided to write a book--this book--expressing my views on the CIA and explaining the reasons why I believe the time has come for the U.S. intelligence community to be reviewed and reformed.

The CIA and the government have fought long and hard--and not always ethically--first to discourage the writing of this book and then to prevent its publication. They managed, through legal technicalities and by raising the specter of "national security" violations, to achieve an unprecedented abridgment of my constitutional right to free speech. They have secured an unwarranted and outrageous *permanent* injunction against me, requiring that anything I write or say, "*factual, fictional or otherwise*", on the subject of intelligence must first be censored by the CIA. Under risk of criminal contempt of court, I can speak only at my own peril and must allow the CIA thirty days to review, and excise, my writings--prior to submitting them to a publisher for consideration.

It has been said that among the dangers faced by a democratic society in fighting totalitarian systems, such as fascism and communism, is that the democratic government runs the risk of imitating its enemies' methods and, thereby, destroying the very democracy that

it claims to defend. I cannot help wondering if my government is more concerned with defending our democratic system or more intent upon imitating the methods of totalitarian regimes in order to maintain its already inordinate power over the American people. IMA, 1974.

Unlike IMA, I did not join the government to do intelligence work. Rather, fresh out of college in 1966, I entered the Foreign Service. My first assignment was to have been London, but with my draft board pressing for my services, the State Department advised me that the best way to stay out of uniform was to go to Vietnam as a civilian advisor in the so-called pacification program. I reluctantly agreed and spent the next eighteen months there, returning to Washington just after the Tet offensive in February 1968. From personal observation, I knew that American policy in Vietnam was ineffective, but I had been one of those who thought that if only better tactics were used the United States could "win." Once back in this country, I soon came to see that American involvement in Indochina was not only ineffective but totally wrong.

The State Department had assigned me to the Bureau of Intelligence and Research, first as an analyst of French and Belgian affairs and then as staff assistant to State's

intelligence director. Since this bureau carries on State's liaison with the rest of the intelligence community, I was for the first time introduced to the whole worldwide network of American spying--not so much as a participant but as a shuffler of top-secret papers and a notetaker at top-level intelligence meetings. Here I found the same kind of waste and inefficiency I had come to know in Vietnam and, even worse, the same sort of reasoning that had led the country into Vietnam in the first place. In the high councils of the intelligence community, there was no sense that intervention in the internal affairs of other countries was not the inherent right of the United States. "Don't be an idealist; you have to live in the 'real' world," said the professionals. I found it increasingly difficult to agree.

For me, the last straw was the American invasion of Cambodia in April 1970. I felt personally concerned because only two months earlier, on temporary assignment to a White House study group, I had helped write a relatively pessimistic report about the situation in Vietnam. It seemed now that our honest conclusions about the tenuous position of the Thieu government had been used in some small way to justify the overt expansion of the war into a new country.

I wish now that I had walked out of the State Department the day the troops went into Cambodia. Within a few months, however, I found a new job as executive assistant to Senator Clifford Case of New Jersey. Knowing of the Senator's opposition to the war, I looked at my new work as a chance to try to change what I knew was wrong in the way the United States conducts its foreign policy.

During my three years with Senator Case, when we were concentrating our efforts on legislation to end the war, to limit the intelligence community, and to curb presidential abuses of executive agreements, I came to know IMA. With our common experience and interest in intelligence, we talked frequently about how things could be improved. In the fall of 1972, obviously disturbed by the legal action the government had taken against the book he intended to write but which he had not yet started, he felt he needed someone

to assist him in his work. Best of all would be a coauthor with the background to make a substantive contribution as well as to help in the actual writing. This book is the result of our joint effort.

I entered the project in the hope that what we have to say will have some effect in influencing the public and the Congress to institute meaningful control over American intelligence and to end the type of intervention abroad which, in addition to being counterproductive, is inconsistent with the ideals by which our country is supposed to govern itself. Whether such a hope was misguided remains to be seen. ALSO A., 1974

INTRODUCTION: XX. AMERICAN CIVIL LIBERTIES UNION

On April 18, 1972, IMA became the first American writer to be served with an official censorship order issued by a court of the United States. The order prohibited him from "disclosing in any manner (1) any information relating to intelligence activities, (2) any information concerning intelligence sources and methods, or (3) any intelligence information."

To secure the order, government lawyers had appeared in the chambers of Judge Albert V. Bryan, Jr., of the United States District Court for the Eastern District of Virginia, in Alexandria, on the morning of April 18, without having notified IMA. The government's papers recited that IMA had worked at the CIA from 1955 to 1969, that he had signed several "secrecy agreements" in which he had agreed not to reveal any information learned during his employment, that after he left the CIA he had revealed forbidden information, that he was planning to write a non-fiction book about the agency, and that publication of the book would "result in grave and irreparable injury to the interests of the United States."

Among the papers presented to the judges was an affidavit (classified "Secret") from Thomas H. Daramessines, Deputy Director of the Central Intelligence Agency, the head of the CIA's covert-activi-

ties branch. The affidavit said that a magazine article and an outline of a proposed book, both written by IMA, had been turned over to the CIA and that they contained information about the CIA's secret activities. The affidavit related several of the items and described how their disclosure would, in the CIA's opinion, be harmful to the United States. On the basis of that affidavit and others, including one by CIA Director Richard Helms, Judge Bryan signed a temporary restraining order forbidding IMA to disclose any information about the CIA and requiring him to submit any "manuscript, article or essay, or other writing, factual or otherwise", to the CIA before "releasing it to any person or corporation". It was that order which United States marshals served upon IMA. The next month was consumed by a hectic and unsuccessful effort to have the order set aside.

IMA asked the ACLU for assistance the day after receiving the order, and was in New York the following day to meet his lawyers and prepare his defense. At the first court appearance, on Friday, April 21, we unsuccessfully urged Judge Bryan to dissolve the temporary restraining order. He also refused to order the government to allow IMA's lawyers to read the "secret" affidavit, because none of us had security clearance. [H: My goodness, citizens, we could stop right HERE! WHERE IS YOUR CONSTITUTION??? THIS PERSON NOT ONLY WAS KEPT FROM THE COURT-ROOM BUT, FURTHER, COULD NOT EVEN WITNESS THE PEOPLE OR INFORMATION USED AGAINST HIM--WAKE UP!!!] The following Monday we were in Baltimore to arrange an appeal to the United States Court of Appeals to argue there that the temporary restraining order should be dissolved. The court agreed to hear arguments two days later. During the Baltimore meeting the government lawyers announced that they had conferred security clearance upon me and that I would be able to read the secret affidavit but could not have a copy of it. They said they would clear the other defense lawyers during the

next few days. We were also told that any witnesses we intended to present at trial, to be held that Friday, would also require security clearance before we could discuss the secret affidavit with them. That was a hell of a way to prepare for trial; we couldn't even talk to prospective witnesses unless they were approved by the government.

We argued the appeal before the Court of Appeals on Wednesday, but that, too, was unsuccessful, and the temporary restraining order remained in effect. Our only satisfaction was an order by the court prohibiting both the CIA and the Department of Justice from trying to influence our witnesses in any way.

On Friday we appeared before Judge Bryan and reluctantly asked for a two-week postponement because it had been impossible for us to secure witnesses who could testify that day. The need for security clearance had made it impossible for us to discuss the case with those witnesses who had at least tentatively agreed to testify for the defense. But, more depressing, we had had great difficulty finding people willing to testify at all. We had called a few dozen prospects, largely former members of the Kennedy and Johnson administrations who had reputations as liberals and even, in some cases, reputations as civil-libertarians. I'm still waiting for them to return my calls. Of the other half, most were simply frightened at the idea of being identified with the case, and some, including a few who had themselves revealed classified information in their published memoirs, agreed with the government that IMA's pen should be immobilized. In the end, our list of witnesses was short but notable: Professor Abram Chayes of Harvard Law School, and former Legal Advisor to the Department of State in the Kennedy administration; Professor Richard Falk, Milbank Professor of International Law at Princeton; Morton Halperin, former Deputy Assistant Secretary of Defense and staff member of the National Security Council under Kissinger; and Professor Paul Blackstock, an intelligence expert from the University of South Carolina.

The next two weeks were consumed by the frustrating hunt for

witnesses and by other pre-trial requirements, including examination of Karamessines and the CIA's Security Director, who were to be the government's chief witnesses.

The trial started and ended on May 15. Essentially, it consisted of Karamessines repeating the contents of his secret affidavit. As interesting as it would be to describe the day in detail, I am forbidden to, for the public was excluded and the testimony of the government witnesses is classified. The result, however, is public. It was a clean sweep for the CIA, and Judge Bryan issued a permanent injunction against IMA.

The results on appeal were not much better. The validity of the injunction was broadly affirmed. The only limitation imposed by the Court of Appeals was that only *classified* information could be deleted from the book by the CIA. The litigation finally came to an end in December 1972 when the Supreme Court refused to hear the case. It was a great defeat for IMA, for his lawyers--AND FOR THE FIRST AMENDMENT.

* * *

American law has always recognized that injunctions against publication--"prior restraints," in legal jargon--threaten the root and branch of democratic society. Until 1971, when the *New York Times* was enjoined from printing the Pentagon Papers, the federal government had never attempted to impose a prior restraint on publication, and the handful of such efforts by the states were uniformly denounced by the Supreme Court. As we learned from the Pentagon Papers case, however, the Nixon administration was not going to be deterred by a mere two hundred years of history from becoming the first administration to try to suppress publication of a newspaper. They ultimately failed in their specific goal of suppressing publication of a newspaper--but, for fifteen days, a newspaper actually was restrained from publishing, the first such restraint in American history.

The *Times*' resumption of publication of the Pentagon Papers immediately after the Supreme Court decision would seem to mean that the case ended victoriously. Although it was a victory, it was NOT a sound victory, for only Justices Black and Douglas said that injunc-

tions against publication were constitutionally forbidden under *any* circumstances. The other members of the court made it perfectly clear that they could imagine circumstances where such injunctions would be enforced, notwithstanding the First Amendment's guarantee of a free press. Nixon-administration lawyers could read the opinions as well as ACLU lawyers and they, too, saw that the decision in the Pentagon Papers Case was not a knockout punch. So only ten months after being beaten off by the *New York Times*, they were back in court trying the same thing again with IMA.

Nine opinions were written in the Pentagon Papers Case. Out of all those opinions one standard emerges under which a majority of the Justices would have allowed information to be suppressed prior to publication: proof by the government that disclosure would "surely result in direct immediate and irreparable injury to the Nation or its people." We were comfortable with that standard because we were confident that nothing IMA had disclosed or would disclose in the future would have that effect. But we were not permitted to put the government to its proof through the testimony of our four witnesses because Judge Bryan agreed with the government that IMA's case was different from the Pentagon Papers Case. "We are not enjoining the press in this case," the government lawyers said. "We are merely enforcing a contract between IMA and the CIA. This is not a First Amendment case, it's just a contract

action." The contract to which they were referring was, of course, IMA's secrecy agreement.

All employees of the CIA are required to sign an agreement in which they promise not to reveal any information learned during their employment which relates to "intelligence sources or methods" without first securing authorization from the agency. The standard form of the agreement includes threats of prosecution and promises to deliver the most awful consequences upon the slightest violation. The only trouble with the threats is that until now they have been unenforceable. Apart from disclosure of information classified by the Atomic Energy Commission, it is not a crime to disclose classified information unless it is done under circumstances which involve what is commonly understood as espionage--spying for a foreign nation. The government tried, in the prosecution of Daniel Ellsberg, to stretch the espionage statutes to punish his disclosure of the Pentagon Papers, even though he had had no intent to injure the United States, as required by the statute. Though that prosecution was aborted under the most dramatic circumstances, including a surreptitious attempt by President Nixon to influence the trial judge, it is unlikely that the appeals courts would have upheld such an expansive application of the espionage laws--assuming that the jury would even have brought in a guilty verdict.

In any case, being doubtful about how far the threat of prosecution under a dubious statute would deter IMA from publicly criticizing the CIA and inevitably disclosing some of its practices, the CIA fell upon the contract theory as a device for trying to suppress his book before it was put into print. The theory struck a harmonious note with the federal judges who heard the case, and proved more successful than the government probably ever dared to hope and certainly more than we had ever expected. But it cheapens the First Amendment to say that an agreement by an employee of the United States not to reveal some government activity is the same as an agreement to deliver a hundred bales of cotton. It ignores the compelling democratic

principle that the public has a right to be well informed about its government's actions.

Of course, some will be heard to say, "But these are secrets," and indeed much of the information you will read in this book has been considered to be secret. But "secrets" have been revealed before--there were literally thousands of them in the Pentagon Papers. Every high government official who writes his memoirs after leaving office reveals "secrets" he learned while in government service, and most had signed secrecy agreements, too. "Secrets" are regularly leaked to the press by government officers, sometimes to serve official policy, sometimes only to serve a man's own ambitions. In fact, disclosure of so-called secrets--even CIA secrets--has a long and honorable history in our country, and the practice has proved to be valuable because it provides the public with important information that it must have in order to pass judgment on its elected officials.

Furthermore, disclosure of "secret" information is rarely harmful because the decision inside government to classify information is notoriously frivolous. Experts have estimated that up to 99 percent of the millions of documents currently classified ought not be classified at all. But not only is disclosure of "secret" information generally harmless, it is a tonic that improves our nation's health. Government officers cried that disclosure of the Pentagon Papers would put the nation's security in immediate jeopardy. When they were finally published in their entirety, the only damage was to the reputation of officials in the Kennedy and Johnson administrations who were shown to have deceived the nation about the war in Vietnam.

* * *

When you read this book, you will notice that, unlike any other book previously published in the United States, this one contains blanks. That is the remarkable effect of the government's success. You will also notice that the book has two authors, IMA and ALSO A. That is another remarkable effect of the government's success. After being enjoined, defeated in his attempts to win relief in the appellate courts, virtually ignored by the press, shunned by his former

colleagues at the CIA, unable even to discuss the progress of his work with his editor at XXX (because the very purpose of the injunction was to forbid the publisher to see the manuscript before the CIA had the opportunity to censor it), there was serious question whether IMA would be able to write the book at all. His discouragement was profound and his bitterness sharp. If he had not written the book, the government's success would have been complete, for that was its real objective. Luckily, IMA and ALSO A came together and with a shared perspective on the evils of clandestine activities; they were able to do together what the government hoped would not be done at all.

When the manuscript was completed at the end of August 1973, it was delivered to the CIA. Thirty days later, the time allowed by the injunction, we received a letter from the CIA which designated 339 portions of the book that were to be deleted. Some of the deletions were single words, some were several lines, some were portions of organizational charts, and many were whole pages. In all, 15 to 20 percent of the manuscript was ordered deleted. I won't soon forget that September evening when IMA, ALSO A and I sat in the ACLU office for several hours literally cutting out the deleted parts of the manuscript so that we could deliver the remains to It was the Devil's work we did that day.

We filed suit in October, together with XX, challenging the CIA's censorship. By the time we went to trial on February 28, the agency had reduced the number of deletions from 339 to 168. Withdrawal of half their original objections should not be taken as a sign of the CIA's generosity. On the contrary, it was the result of our insistent demands over a period of four months, and the agency's recognition that we would go to the mat over the very last censored word. The authors gave up nothing, and rejected several invitations to re-write parts of the book so that it would be satisfactory to the CIA.

There were three issues to be decided at the trial: did the censored portions of the book consist of classified information? Was that information learned by the authors during their government employment? And was any of it in the public domain?

After a two-and-a-half day trial, including testimony by the five highest-ranking officials of the CIA, Judge Bryan decided the case on March 29. It was a major victory for the authors and the publisher. Bryan held that the agency had failed, with a few exceptions, to prove that the deleted information was classified.

The decision was probably more surprising to the CIA. Accustomed as they have become to having their way, it is unlikely to have occurred to them that a mere judge of the United States would contradict their declarations about classified information, for it was the government's theory throughout the case that material was classified if high-ranking officials *said* it was classified. Our view, presented through the expert testimony of Morton Halperin, was that concrete proof of classification was required. In the absence of documents declaring specific information to be classified, or testimony by the employee who had in fact classified specific information, Judge Bryan flatly rejected mere assertions by ranking CIA officers that such information was classified.

Of the 168 disputed items, he found only 27 which he could say

were classified. On the other hand, he found that only seven of the 168 had been learned by IMA and ALSO A outside their government employment, and that none of the information was in the public domain.

The decision is obviously important. It allows virtually the entire book to be published (though the present edition still lacks the deleted sections cleared by Judge Bryan, since he postponed enforcement of his decision to allow the government its right to appeal); it desanctifies the CIA; and it discards the magical authority that has always accompanied government incantation of "national security". In November, 1971, Chairman, Senate Foreign Relations Committee, Senator J. William Fulbright said: "But this secrecy...has become a god in this country, and those people who have secrets travel in a kind of fraternity...and they will not speak to anyone else."

I suggest that is one of the most gross understatements ever made.

There exists in your nation today an incredibly powerful and dangerous secret cult--this "cult of Intelligence".

Its holy men are the clandestine professionals of the Central Intelligence Agency as you recognize it--a worldwide Agency by many names that are hidden from you. This has been the enforcement factor for insuring take-over by the Elite in its ability to hide EVERYTHING AND ANYTHING FROM YOU CITIZENS.

Its patrons and protectors are the highest officials of the federal government. Its membership, extending far beyond governmental circles, reaches into the power centers of industry, commerce, finance, and labor--recruitment into the force is begun in your high schools. It is easy to recruit young people for the aspects are presented in the most wondrously intriguing ways imaginable along with the sex appeal of a James Bond type of charismatic hero actor. Its friends are many in the areas of important public influence--the academic world and the communications media. The cult of intelligence is a secret fraternity of the American political aristocracy--not the one world "New World Order" enforcement wing, internationally. It is structured to cover all and any corrupt behavior of any personages in power.

The purpose of the cult is to further the foreign policies of the U.S. government by covert and

usually illegal means. This would imply that the whole of the organization and operatives would be American--not so, Americans make up the least of the population in the organization today. At the same time it was to have contained the spread of its avowed enemy, Communism. But funny thing--you now have more KGB Communists, terrorist elite and Mossad agents in the organization than American leaders; the KGB and Mossad have been brought in specifically to take the leadership, training and authority. It is now called "working together as free nations" for a "peaceful world" under "democracy" which equates 100% to socialistic fascism and dictatorship/monarchy of puppets and puppet masters. Ah, yet traditionally, the cult's projected purpose has been to foster a world order in which America would reign supreme, the unchallenged international leader. I believe you can see that no matter how you lie to selves and wave flags, the facts remain that it isn't true. For instance, if you do not believe what I wrote about John F. Kennedy and his death--GO SEE "JFK"! There have been dozens of men who have brought you the truth of the circum-

stance but you have REFUSED TO READ OR RESEARCH! YOU, AS A PEOPLE, HAVE PREFERRED TO SEE NO EVIL, HEAR NO EVIL AND CERTAINLY, SPEAK NO EVIL. Well, soon you will lose all Constitutional Rights to see, speak or hear in freedom. THIS is the point--not who may or may not have shot a President. Coups take place all over the globe--why NOT in America? Are you sacrosanct?

The cult's objectives rapidly became far less grandiose as time flitted by and one after another cover-up worked. It seemed to seek largely to advance America's self-appointed role as the dominant arbiter of social, economic, and political change in the awakening regions of Asia, Africa and Latin America. Its worldwide war against Communism sounded good as a rallying point but, as is now obvious, that was never the point in the first place. That has now become reduced to a covert struggle to maintain a self-serving stability in the Third World, using whatever clandestine methods available--in order to serve the Elite Plan 2000.

For the cult of intelligence, fostering "stability" may in one country mean reluctant and passive acquiescence to evolutionary change; in another, a determined effort to reverse popular trends toward independence and democracy. The cult attempts that which it believes it can accomplish and which--in the event of failure or exposure--the U.S. government can plausibly deny.

The CIA is both the center and the primary instrument of the cult of intelligence as you recognize it to be. For our purposes herein we will leave that assumption intact to lessen the confusion of intent of this JOURNAL. Its purpose is to engage in espionage and counterespionage, in propaganda and disinformation (the deliberate circulation of false information), in psychological warfare and paramilitary activities. It penetrates and manipulates private institutions, and creates its own organization (called "proprieties") when necessary. It recruits agents and mercenaries; it bribes and blackmails foreign officials to carry out its most unsavory tasks. This becomes quite easy because first the enticements to officials are through bribery and threat and blackmail

becomes easy and logical. It does whatever is required or desired to achieve its goals, without any consideration of the ethics involved or the moral consequences of its actions. As the secret-action arm of American foreign policy, the CIA's most potent weapon is its covert intervention in the internal affairs of countries the U.S. government wishes to control or influence.

Romanticized by myths, the operations of the CIA are also beclouded by false images and shielded by official deceptions. Its practices are hidden behind arcane and antiquated legalisms which prevent the public and even Congress from knowing what the mysterious agency is doing--or why. Thus the cult of intelligence justifies with dramatic assertions that the CIA's purpose is to preserve the "national security", that its actions are in response to the needs of the nation's defense. No one--in an age in which secrecy is the definitional operative of security--need know more than that.

The cult is intent upon conducting the foreign affairs of the U.S. government without the awareness or participation of the people. It recognizes no role for a questioning legislature or an investigative press. Its adherents believe that only they have the right and the obligation to decide what is necessary to satisfy the national needs. Although it pursues outmoded international policies and unattainable ends, the cult of intelligence demands that it not be held accountable for its actions by the people it professes to serve. It is a privileged, as well as secret, charge. In their minds, those who belong to the cult of intelligence have been ordained, and their service is immune from public scrutiny.

CLANDESTINE MENTALITY

The "clandestine mentality" is a mind-set that thrives on secrecy and deception--right from the onset of adversarial operations against you of "Godness" (goodness, love and honor in open sharing). It encourages professional amorality--the belief that righteous goals can be achieved through the use of unprincipled and normally unacceptable means. Thus, the cult's leaders must tenaciously guard their official

actions from public view. To do otherwise would restrict their ability to act independently; it would permit the American people to pass judgment on not only the utility of their policies, but the ethics of those policies as well. With the cooperation of an acquiescent, ill-informed Congress, and the encouragement and assistance of a series of Presidents, the cult has built a wall of laws and executive orders around the CIA and itself, a wall that has blocked effective public scrutiny.

When necessary, the members of the cult of intelligence, including your Presidents (who are always aware of, generally approve of, and often actually initiate the CIA's major undertakings), have lied to protect the CIA and to hide their own responsibility for its operations. The Eisenhower Administration lied to the American people about the CIA's involvement in the Guatemalan *coup d'etat* in 1954, about the agency's support of the unsuccessful rebellion in Indonesia in 1958, and about Francis Gary Powers' 1960 U-2 mission. The Kennedy Administration lied about the CIA's role in the abortive invasion of Cuba in 1961, admitting its involvement only after the operation had failed disastrously. The Johnson Administration lied about the extent of most U.S. government commitments in Vietnam and Laos, and all of the CIA's. And the Nixon Administration publicly lied about the agency's attempt to fix the Chilean election in 1970. For adherents to the cult of intelligence, hypocrisy and deception, like secrecy, have become standard techniques for preventing public awareness of the CIA's clandestine operations, and governmental accountability for them. And these men who ask that they be regarded as honorable men, true patriots, will, when caught in their own webs of deceit, even assert that the government has an inherent right to lie to "its" people--as if IT owns you--and your opinions and existence have nothing to do with "IT".

The justification for the "right to lie" is that secrecy in covert operations is necessary to prevent U.S. policies and actions from coming to the attention of the "enemy"--or, in the parlance of the clandestine trade, the "opposition". If the opposition is oblivious to the

CIA's operations, the argument runs, then it cannot respond and the CIA activities stand a good chance of succeeding. Nonetheless, in many instances the opposition knows exactly what covert operations are being targeted against it, and it takes counteraction when possible. The U-2 overflights and, later, those of the photographic satellites were, and remain, as well known to the Soviets and the Chinese as Soviet overhead reconnaissance of the United States is to the CIA; there is no way, when engaging in operations of this magnitude, to keep them secret from the opposition--especially when you and the opposition are working for the same end goal. It, too, employs a professional intelligence service--remember the KGB, and the Mossad. The Chinese have an even more sophisticated method of covert secrecy--they utilized a simple procedure of being secret from the entire world while they built their installations and underground shelters, etc. They can come out now because there is everything already hidden and secure and they don't really care WHO knows their strength. In fact, they like to toss it around a lot, i.e., arms to every small nation in the Arab World as well as the great big ones. You are about to awaken the sleeping giant and you are going to be very, very sorry about that.

Looking back to the time of the writing of the book in point you will find that from 1952 to 1964, at the height of the Cold War, the Soviet KGB electronically intercepted even the most secret messages routed through the code room of the U.S. Embassy in Moscow. This breach in secrecy, however, apparently caused little damage to U.S. national security, nor did the Soviet

government collapse because the CIA had for years secretly intercepted the private conversations of the top Russian leaders as they talked over their limousine radio-telephones. Both sides knew more than enough to cancel out the effect of any leaks. The fact is that in your country, secrecy and deception in intelligence operations are as much to keep the Congress and the public from learning what their government is doing as to shield these activities from the opposition. The intelligence establishment operates as it does to maintain freedom of action and avoid accountability.

Your nation, as with all other mighty nations and civilizations (actually even the most tiny places), shall fall because of the enemy WITHIN--again, not that one without. It is always that ones get control and maintain control and activities in the absolute secret shrouds of protection while they do their dirty work and destroy that which is YOURS. YOU are the ones who have laughed at the antics of the politicians and failed to choose better. YOU are the ones who fail to vote because, yes, it IS all decided but you have chosen not to make those ones accountable under your precious Constitution. YOU HAVE DONE IT AND IT IS UP TO YOU NOW, TO UNDO IT.

A good part of the CIA's power position is dependent upon its careful mythologizing and glorification of the exploits of the clandestine profession. Sometimes this even entails fostering a sort of perverse public admiration for the covert practices of the opposition intelli-

gence services--to frighten the public and thereby justify the actions of the CIA. Whatever the method, the selling of the intelligence business is designed to have us admire it as some sort of mysterious, often magical, profession capable of accomplishing terribly difficult, if not miraculous, deeds. Look at James Bond, as example, in His Majesty's Secret Service! Like most myths, the intrigues and successes of the CIA over the years have been more imaginary than real as to that which was laid forth as their "goal". What is real, unfortunately, is the willingness of both the public and adherents of the cult to believe the fictions that permeate the intelligence business.

The original mission of the CIA was to coordinate the intelligence-collection programs of the various governmental departments and agencies, and to produce the reports and studies required by the national leadership in conducting the affairs of U.S. foreign policy. This was President Truman's view when he requested that Congress establish the secret intelligence agency by passing the National Security Act of 1947. But General William "Wild Bill" Donovan, Allen Dulles, and other veterans of the wartime Office of Strategic Services--a virtually unregulated body, both romantic and daring, tailor-made to the fondest dreams of the covert operator--thought differently. They saw the emergency agency as the clandestine instrument by which Washington could achieve foreign-policy goals not attainable through diplomacy. They believed that the man-

tle of world leadership had been passed by the British to the Americans, and that their own secret service must take up where the British left off. Thus, they lobbied Congress for the power to conduct covert operations. Lumped in all this, of course, are the "Black" operations, "Black" budget and thus and so.

That Truman attempted to create an overt intelligence organization, one which could emphasize the gathering and analysis of information rather than secret operations, was somewhat commendable--although not seriously contemplated. He thought he could control the advocates of covert action but that was, in retrospect, a gross error in calculations. His first miscalculation was that he held any power at all to do much of anything when not a direct disciple of the cult. In that instance, Congress, in an atmosphere of Cold War tension, allowed itself to be persuaded by the intelligence professionals--even then controlled by the foreign interests of the Zionists who had already gained control of the Congress. With the passage of the National Security Act of 1947 it allowed the new agency special exemptions from the normal congressional reviewing process, and these exemptions were expanded two years later by the Central Intelligence Agency Act of 1949. Of the greatest and most far-reaching consequence was the provision in the 1947 law that permitted **EXECUTIVE ORDERS!** This al-

lowed the CIA to "perform such other functions and duties related to intelligence...as the National Security Council may from time to time direct". From those few innocuous words the CIA has been able, over the years, to develop a secret charter based on NSC directives and presidential executive orders, a charter almost completely at variance with the apparent intent of the law that established the agency. I use the term "apparent intent" because the "full intent" was exactly that which you have accomplished. The vague phrase has provided the CIA with freedom to engage in covert action, the right to intervene secretly in the internal affairs of your own and other nations. The State owns and controls your car

It has been brought to my attention that the license plate sticker that you voluntarily put on your property has imbedded in the background "For Official Use Only". You have to look very hard to see it but it is there. Now every one knows that all municipal vehicles (City, County, State and federal) all have the sign on the vehicle "For Official Use Only". This implies that the corporate state has an interest in your personal property.

I myself do not have plates on my personal property, but I do travel in it. I have a bill of sale that this piece of machinery has been sold to me free and clear with no other outside interests. The corporate state now has to prove that they have obtained an interest in my personal property.

The corporate state, when a car is first sold, requests that the Original Certificate of Origin either be destroyed or forwarded to them. The purchaser is not to receive it. The corporate state then has the purchaser sign a power of attorney over the vehicle to them. The state then assigns a license number to that item. If you read the California Statutes, you will see that an individual who carries his own property, or travels for his own reasons and pleasure is exempt from such fees. The code is specifically written for commercial users. LET US LOOK AT SOME PUBLIC BACKFIRES

The one just spoken of above is the master plan of all backfires--it will end up getting your goose cooked. However in the line of CIA backfires we have some interesting incidents to consider. Occasionally, clandestine operations do backfire spectacularly and do so in public.
