ON PLATE TECTONICS

In the early 1960s, the emergence of the Theory of Plate Tectonics started a revolution in the Earth sciences. Since then, scientists have verified and refined this theory, and now have a much better understanding of how the Earth has been shaped by plate-tectonic processes. We now know that, directly or indirectly, plate tectonics influence nearly all geologic processes, past and present. Indeed, the notion that the entire Earth's surface is continually shifting has profoundly changed the way we view the planet.

People benefit from, and are at the mercy of, the forces and consequences of plate tectonics. With little or no warning, an earthquake or volcanic eruption can unleash bursts of energy far more powerful than anything we can generate. While we have no control over plate tectonics, we now have the knowledge to learn from them. The more we know about plate tectonics, the better we can appreciate the grandeur and beauty of the land upon which we live, as well as the occasional violent displays of the Earth's awesome power.

Although the general idea of plate tectonics is now widely accepted, many aspects still continue to confound and challenge scientists. The Earth-science revolution launched by the theory of plate tectonics is not finished.

In geologic terms, a "plate" is a large, rigid slab of solid rock. The word "tectonics" comes from the Greek root "to build". Putting these two words together, we get the term "plate tectonics", which refers to how the Earth's surface is built of plates. The "theory of plate

yourself aiding-and-abetting criminal felony murder? tectonics" states that the Earth's outermost layer is fragmented into a dozen or more large and small plates that are moving relative to one another as they ride atop hotter, more mobile material. Before the advent of plate tectonics, however, some people already believed that the present-day continents were the fragmented pieces of preexisting larger landmasses ("supercontinents"). One of those supercontinents was Pangaea (meaning "all lands" in Greek), which figured prominently in the "theory of continental drift", the forerunner to the theory of plate tectonics.

> Plate tectonics is a relatively new scientific concept, introduced some 30 years ago, but it has revolutionized our understanding of the dynamic planet upon which we live. The theory has unified the study of the Earth by drawing together many branches of the Earth sciences, from paleontology (the study of fossils) to seismology (the study of earthquakes). It has provided explanations to questions that scientists had speculated upon for centuries—such as why earthquakes and volcanic eruptions occur in very specific areas around the world, and how and why great mountain ranges like the Alps and Himalayas formed.

> Why is the Earth so restless? What causes the ground to shake violently, volcanoes to erupt with explosive force and great mountain ranges to rise to incredible heights? Scientists, philosophers and theologians have wrestled with questions such as these for centuries. Until the 1700s, most Europeans thought that a biblical flood played a major role in shaping the Earth's surface. This way of thinking was known as "catastrophism", and geology (the study of the Earth) was based on the belief that all earthly changes were sudden and caused by a series of catastrophes.

> However, by the mid 19th Century, catastrophism gave way to "uniformitarianism", a new way of thinking centered around the Uniformitarian Principle, proposed in 1785 by James Hutton, a Scottish geologist. This principle is commonly stated as follows: "The present is the key to the past."

> Those holding this viewpoint assume that the geologic forces and processes—gradual as well as catastrophic—acting on the Earth today are the same as those that have acted in the geologic past.

The belief that continents have not always been fixed in their present positions was suspected long before the 20th Century; this notion was first suggested as early as 1596 by the Dutch mapmaker Abraham Ortelius, in his work Thesaurus Geographicus. Ortelius suggested that the Americas were "torn away from Europe and Africa...by earthquakes and floods" and went on to say: "The vestiges of the rupture reveal themselves, if someone brings forward a map of the world and considers carefully the coasts of the three continents." Ortelius' idea surfaced again in the 19th Century. However, it was not until 1912 that the idea of moving continents was seriously considered as a full-blown scientific theory—called Continental Drift—introduced in two articles published by a 32-year-old German meteorologist named Alfred Lothar Wegener. He contended that, around 200 million years ago, the supercontinent Pangaea began to split apart. Alexander Du Toit, Professor of Geology at Johannesburg University and one of Wegener's staunchest supporters, proposed that Pangaea first broke into two large continental landmasses, Laurasia in the northern hemisphere and Gondwanaland in the southern hemisphere. Laurasia and Gondwanaland then continued to break apart into the various smaller continents that

Wegener's theory was based, in part, on what appeared to him to be the remarkable fit of the South American and African continents, first noted by Abraham Ortelius three centuries earlier. Wegener was also intrigued by the occurrences of unusual geologic structures, and of plant and animal fossils found on the matching coastlines of South America and Africa, which are now widely separated by the Atlantic Ocean. He reasoned that it was physically impossible for most of these organisms to have swum or have been transported across the vast oceans. To him, the presence of identical fossil species along the coastal parts of Africa and South America was the most compelling evidence that the two continents were once joined.

In Wegener's mind, the drifting of continents after the break-up of Pangaea (Pan) explained not only the matching fossil occurrences, but also the evidence of dramatic climate changes on some continents. For example, the discovery of fossils of tropical plants (in the form of coal deposits) in Antarctica led to the conclusion what this frozen land previously must have been situated closer to the equator, in a more temperate climate, where lush, swampy vegetation could grow. Other mismatches of geology and climate included distinctive fossil ferns (Glossopteris) discovered in nowpolar regions, and the occurrence of glacial deposits in present-day arid Africa, such as the Vaal River valley of South Africa.

The "theory of continental drift" would become the spark that ignited a new way of viewing the Earth. But at the time Wegener introduced his theory, the scientific community firmly believed the continents and oceans to be permanent features on the Earth's surface. Not surprisingly, his proposal was not well received, even though it seemed to agree with the scientific information available at the time. A fatal weakness in Wegener's theory was that it could not satisfactorily answer the most fundamental question raised by his critics: What kind of forces could be strong enough to move such large masses of solid rock over such great distances? Wegener suggested that the continents simply plowed through the ocean floor, but Harold Jeffreys, a noted English geophysicist, argued correctly that it was physically impossible for a large mass of solid rock to plow through the ocean floor without breaking up.

Undaunted by rejection, Wegener devoted the rest of his life to doggedly pursuing additional evidence to defend his theory. He froze to death in 1930 during an expedition crossing the Greenland ice cap, but the controversy he spawned raged on. However, after his death, new evidence from ocean-floor exploration and other studies rekindled interest in Wegener's theory, ultimately leading to the development of the "theory of plate tectonics".

Plate tectonics have proven to be as important to the Earth sciences as the discovery of the structure of the atom was to physics and chemistry, and the theory of evolution was to the life sciences. Even though the theory of plate tectonics is now widely accepted by the scientific community, aspects of the theory are still being debated today. Ironically, one of the chief outstanding questions is the one Wegener failed to resolve: What is the nature of the forces propelling the plates? Scientists also debate how plate tectonics may have operated (if at

planets in our Solar System.

Continental drift was hotly debated off-and-on for decades following Wegener's death, before it was largely dismissed as being eccentric, preposterous and improbable. However, beginning in the 1950s, a wealth of new evidence emerged to revive the debate about Wegener's provocative ideas and their implications. In particular, four major scientific developments spurred the formulation of the plate-tectonics theory: (1) demonstration of the ruggedness and youth of the ocean floor; (2) confirmation of repeated reversals of the Earth's magnetic field in the geologic past; (3) emergence of the seafloor-spreading hypothesis and associated recycling of oceanic crust; and (4) precise documentation that the world's earthquake and volcanic activity is concentrated along oceanic trenches and submarine mountain ranges.

OCEAN FLOOR MAPPING

About two-thirds of the Earth's surface lies beneath the oceans. Before the 19th Century, the depths of the open ocean were largely a matter of speculation, and most people thought that the ocean floor was relatively flat and featureless. However, as early as the 16th Century, a few intrepid navigators, by taking soundings with hand lines, found that the open ocean can differ considerably in depth, showing that the ocean floor was not as flat as generally believed. Oceanic exploration during the next centuries dramatically improved our knowledge of the ocean floor. We now know that most of the geologic processes occurring on land are linked, directly or indirectly, to the dynamics of the ocean floor.

"Modern" measurements of ocean depths greatly increased in the 19th Century, when deep-sea line soundings (bathymetric surveys) were routinely made in the Atlantic and Caribbean. In 1855, a bathymetric chart published by U.S. Navy Lieutenant Matthew Maury revealed the first evidence of underwater mountains in the central Atlantic (which he called "Middle Ground"). This was later confirmed by survey ships laying the trans-Atlantic telegraph cable. Our picture of the ocean floor greatly sharpened after World War I (1913-18), when echo-sounding devicesprimitive sonar systems—began to measure ocean depth by recording the time it took for a sound signal (commonly an electrically generated "ping") from the ship to bounce off the ocean floor and return. Time graphs of the returned signals revealed that the ocean floor was much more rugged than previously thought. Such echo-sounding measurements clearly demonstrated the continuity and roughness of the submarine mountain chain in the central Atlantic (later called the Mid-Atlantic Ridge) suggested by the earlier bathymetric measurements.

In 1947, seismologists on the U.S. research ship Atlantis found that the sediment layer on the floor of the Atlantic was much thinner than originally thought. Scientists had previously believed that the oceans had existed for at least 4 billion years, so therefore the sediment layer should have been very thick. Why, then, was there so little accumulation of sedimentary rock and debris on the ocean floor? The answer to this question, which came after further exploration, would prove to be vital to advancing the concept of plate tectonics.

In the 1950s, oceanic exploration greatly expanded.

all) earlier in the Earth's history, and whether [or not] Data gathered by oceanographic surveys conducted by similar processes operate, or have ever operated, on other many nations led to the discovery that a great mountain range on the ocean floor virtually encircled the Earth. Called the Global Mid-ocean Ridge, this immense submarine mountain chain—more than 50,000 kilometers (km) long and, in places, more than 800 km across—zigzags between the continents, winding its way around the globe like a seam on a baseball. Rising an average of about 4,500 meters (m) above the sea floor, the Mid-ocean Ridge overshadows all the mountains in the United States, except for Mount McKinley (Denali) in Alaska (6,194 m). Though hidden beneath the ocean surface, the Global Mid-ocean Ridge system is the most prominent topographic feature on the surface of the Earth.

MAGNETIC STRIPING AND POLAR REVERSALS

Beginning in the 1950s, scientists, using magnetic instruments (magnetometers) adapted from airborne devices developed during World War II to detect submarines, began recognizing odd magnetic variations across the ocean floor. This finding, though unexpected, was not entirely surprising, because it was known that basalt—the iron-rich, volcanic rock making up the ocean floor-contains a strongly magnetic mineral (magnetite) and can locally distort compass readings. This distortion was recognized by Icelandic mariners as early as the late 18th Century. More importantly, because the presence of magnetite gives the basalt measurable magnetic properties, these newly discovered magnetic variations provided another means to study the deep ocean floor.

Early in the 20th Century, paleomagnetists (those who study the Earth's ancient magnetic field)—such as Bernard Brunhes in France (in 1906) and Motonari Matuyama in Japan (in the 1920s)—recognized that rocks generally belong to two groups, according to their magnetic properties. One group has so-called normal polarity, characterized by the magnetic minerals in the rock having the same polarity as that of the Earth's present magnetic field. This would result in the north end of the rock's "compass needle" pointing toward magnetic north. The other group, however, has reversed polarity, indicated by a polarity alignment opposite to that of the Earth's present magnetic field. In this case, the north end of the rock's compass needle would point south.

How could this be? The answer lies in the magnetite in volcanic rock. Grains of magnetite—behaving like little magnets—can align themselves with the orientation of the Earth's magnetic field. When magma (molten rock containing minerals and gases) cools to form solid volcanic rock, the alignment of the magnetite grains is "locked in", recording the Earth's magnetic orientation or polarity (normal or reversed) at the time of cooling.

As more and more of the sea floor was mapped during the 1950s, the magnetic variations turned out not to be random or isolated occurrences but, instead, revealed recognizable patterns. When these magnetic patterns were mapped over a wide region, the ocean floor showed a zebra-like pattern. Alternating stripes of magnetically different rock were laid out in rows on either side of the Mid-ocean Ridge—one stripe with normal polarity and the adjoining stripe with reversed polarity. The overall pattern, defined by these alternating bands of normally and reversely polarized rock, became known as the magnetic striping.

SEAFLOOR-SPREADING AND RECYCLING OF OCEANIC CRUST

The discovery of magnetic striping naturally prompted more questions: How does the magnetic striping pattern form? And, why are the stripes symmetrical around the crests of the mid-ocean ridges? These questions could not be answered without also knowing the significance of these ridges. In 1961, scientists began to theorize that mid-ocean ridges mark structurally weak zones, where the ocean floor is being ripped in two-lengthwise along the ridge crest. New magma from deep within the Earth rises easily through these weak zones and eventually erupts along the crest of the ridges to create new oceanic crust. This process, later called seafloor spreading, operating over many millions of years, has built the 50,000 km-long system of mid-ocean ridges.

This hypothesis was supported by several lines of evidence: (1) at or near the crest of the ridge, the rocks are very young, and they become progressively older away from the ridge crest; (2) the youngest rocks at the ridge crest always have present-day (normal) polarity; and (3) stripes of rock parallel to the ridge crest alternate in magnetic polarity (normal-reversed-normal, etc.), suggesting that the Earth's magnetic field has flipflopped many times. By explaining both the zebra-like magnetic striping and the construction of the Mid-ocean Ridge system, the seafloor spreading hypothesis quickly gained converts and represented another major advance in the development of the plate-tectonics theory. Furthermore, the oceanic crust now came to be appreciated as a natural "tape recording" of the history of the reversals in the Earth's magnetic field.

Additional evidence of seafloor spreading came from an unexpected source—petroleum exploration. In the years following World War II, continental oil reserves were being depleted rapidly and the search for offshore oil was on. To conduct offshore exploration, oil companies built ships equipped with a special drilling rig and the capacity to carry many kilometers of drill pipe. This basic idea later was adapted in constructing a research vessel, named the Glomar Challenger, designed specifically for marine geology studies, including the collection of drill-core samples from the deep ocean floor. [S: It was this Glomar Challenger of Howard Hughes' that actually got him deaded!] In 1968, the vessel embarked on a year-long scientific expedition, criss-crossing the Mid-Atlantic Ridge between South America and Africa and drilling core samples at specific locations. When the ages of the samples were determined by paleontologic and isotopic dating studies, they provided the clinching evidence that proved the seafloor spreading hypothesis.

A profound consequence of seafloor spreading is that new crust was, and is now, being continually created along the oceanic ridges. This idea found great favor with some scientists, who claimed that the shifting of the continents could be simply explained by a large increase in size of the Earth since its formation. However, this so-called "expanding Earth" hypothesis was unsatisfactory, because its supporters could offer no convincing geologic mechanism to produce such a huge, sudden expansion. [S: Besides, as the Earth "cools", it shrinks. Doesn't anybody in the scientific community recognize that, especially such as a Dr. Young?] Most geologists believe that the Earth has changed little, if at all, in size since its formation 4.6 billion years ago, raising a key question: How can new

crust be continuously added along the oceanic ridges without increasing the size of the Earth?

Princeton University geologist and Naval Reserve Rear horizontally past each other; Admiral) and Robert S. Dietz (a scientist with the U.S. Coast and Geodetic Survey, who first coined the term seafloor spreading). Dietz and Hess were among the small handful who really understood the broad implications of seafloor spreading. If the Earth's crust was expanding along the oceanic ridges, Hess reasoned, it must be shrinking elsewhere. He suggested that new oceanic crust continuously spread away from the ridges in a conveyor-belt-like motion. Many millions of years later, the oceanic crust eventually descends into the oceanic trenches—very deep, narrow canyons along the rim of the Pacific Ocean basin. According to Hess, the Atlantic Ocean was expanding while the Pacific Ocean was shrinking. As old oceanic crust was consumed in the trenches, new magma rose and erupted along the spreading ridges to form new crust. In effect, the ocean basins were perpetually being "recycled", with the creation of new crust and the destruction of old oceanic lithosphere occurring simultaneously. Thus, Hess' ideas neatly explained why the Earth does not get bigger with sea floor spreading, why there is so little sediment accumulation on the ocean floor and why oceanic rocks are much younger than continental rocks.

CONCENTRATION OF EARTHQUAKES

During the 20th Century, improvements in seismic instrumentation and greater use of earthquake-recording instruments (seismographs) worldwide enabled scientists to learn that earthquakes tend to be concentrated in certain areas, most notably along the oceanic trenches and spreading ridges. By the late 1920s, seismologists were beginning to identify several prominent earthquake zones parallel to the trenches that typically were inclined 40-60 degrees from the horizontal and extended several hundred kilometers into the Earth. These zones later became known as Wadati-Benioff zones, or simply Benioff zones, in honor of the seismologists who first recognized them, Kiyoo Wadati of Japan and Hugo Benioff of the United States. The study of global seismicity greatly advanced in the 1960s with the establishment of the Worldwide Standardized Seismograph Network (WWSSN) to monitor the compliance of the 1963 treaty banning above-ground testing of nuclear weapons. The much-improved data from the WWSSN instruments allowed seismologists to map precisely the zones of earthquake concentration worldwide.

But what was the significance of the connection between earthquakes and oceanic trenches and ridges? The recognition of such a connection helped confirm the seafloor-spreading hypothesis by pin-pointing the zones where Hess had predicted oceanic crust is being generated (along the ridges) and the zones where oceanic lithosphere sinks back into the mantle beneath the trenches.

Scientists now have a fairly good understanding of how the plates move and how such movements relate to earthquake activity. Most movement occurs along narrow zones between plates, where the results of platetectonic forces are most evident.

There are four types of plate boundaries:

- * DIVERGENT BOUNDARIES, where new crust is generated as the plates pull away from each other;
 - * CONVERGENT BOUNDARIES, where crust is

destroyed as one plate dives under another;

- * TRANSFORM BOUNDARIES, where crust is
- * PLATE BOUNDARY ZONES, broad belts in which boundaries are not well defined and the effects of plate interaction are unclear.

DIVERGENT BOUNDARIES

Divergent boundaries occur along spreading centers where plates are moving apart and new crust is created by magma pushing up from the mantle. Picture two giant conveyor belts, facing each other but slowly moving in opposite directions, as they transport newly formed oceanic crust away from the ridge crest.

Perhaps the best known of the divergent boundaries is the Mid-Atlantic Ridge. This submerged mountain range, which extends from the Arctic Ocean to beyond the southern tip of Africa, is but one segment of the global mid-ocean ridge system that encircles the Earth. The rate of spreading along the mid-Atlantic Ridge averages about 2.5 centimeters per year (cm/yr), or 25 km in a million years. This rate may seem slow by human standards, but because this process has been going on for millions of years, it has resulted in plate movements of thousands of kilometers. Seafloor spreading over the past 100 to 200 million years has caused the Atlantic ocean to grow from a tiny inlet of water between the continents of Europe, Africa and the Americas into the vast ocean that exists today.

The volcanic country of Iceland, which straddles the Mid-Atlantic Ridge, offers scientists a natural laboratory of studying, on land, the processes also occurring along the submerged parts of the spreading ridge. Iceland is splitting along the spreading center between the North American and Eurasian Plates, as North America moves

westward relative to Eurasia.

The consequences of plate movement are easy to see This question particularly intrigued Harry H. Hess (a neither produced nor destroyed as the plates slide around Krafla Volcano, in the northeastern part of Iceland. Here, existing ground cracks have widened and new ones appear every few months. From 1975 to 1984, numerous episodes of rifting (surface cracking) took place along the Krafla fissure zone. Some of these rifting events were accompanied by volcanic activity; the ground would gradually rise 1-2 m before abruptly dropping, signaling an impending eruption. Between 1975 and 1984, the displacements caused by rifting totaled about 7 m.


> In East Africa, spreading processes have already torn Saudi Arabia away from the rest of the African continent, forming the Red Sea. The actively splitting African Plate and the Arabian Plate meet in what geologists call a Triple Junction, where the Red Sea meets the Gulf of Aden. A new spreading center may be developing under Africa along the East African Rift Zone. When the continental crust stretches beyond its limits, tension cracks begin to appear on the Earth's surface. Magma rises and squeezes through the widening cracks, sometimes to erupt and form volcanoes. The rising magma, whether or not it erupts, puts more pressure on the crust to produce additional fractures and, ultimately, the rift zone.

> East Africa may be the site of the Earth's next major ocean. Plate interactions in the region provide scientists an opportunity to study first-hand how the Atlantic may have begun to form about 200 million years ago. Geologists believe that, if spreading continues, the three plates that meet at the edge of the present-day African continent will separate completely, allowing the Indian Ocean to flood the area and making the easternmost corner of Africa (the Horn of Africa) a large island.

OCEANIC-CONTINENTAL CONVERGENCE

If, by magic, we could pull a plug and drain the Pacific Ocean, we would see a most amazing sight—a number of long, narrow, curving trenches, thousands of kilometers long, and 8 to 10 km deep, cutting into the ocean floor. Trenches are the deepest parts of the ocean floor and are created by subduction.

Off the coast of South America, along the Peru-Chile trench, the oceanic Nazca Plate is pushing into and being subducted under the continental part of the South American Plate. In turn, the overriding South American Plate is being lifted up, creating the towering Andes Mountains, the backbone of the continent. Strong, destructive earthquakes and the rapid uplift of mountain ranges are common in this region. Even though the Nazca Plate as a whole is sinking smoothly and continuously into the trench, the deepest part of the subducting plate breaks into smaller pieces that become locked in place for long periods of time, before breaking suddenly to generate large earthquakes. Such earthquakes are often accompanied by uplift of the land by as much as a few meters.

On 9 June 1994, a magnitude 8.3 earthquake struck about 320 km northeast of La Paz, Bolivia, at a depth of 636 km. This earthquake, with the subduction zone between the Nazca Plate and the South American Plate, was one of the deepest and largest subduction earthquakes recorded in South America. Fortunately, even though this powerful earthquake was felt as far

away as Minnesota and Toronto, Canada, it caused no major damage because of its great depth.

[S: Please note, as we have previously stated as to the local area in Tehachapi, as a for instance: The Mojave area will rise somewhat because of this subduction thrust—but the Tehachapi area is expected to RISE SOME 1200 FEET. AND THIS DAMAGE AND LOSS AT THIS TIME—CAUSED BY ONES TOUTING TO SERVE THE HOSTS—IS UNTHINKABLE. AND YOU WHO CONTINUE TO SUPPORT THIS UNLAWFUL AND YEA. EVEN CRIMINAL, ACTIVITY ARE AS GUILTY AS THE ONE WHO ACTUALLY TAKES THE MOVING CARTS OR EVEN A BLADE OF GRASS FROM THAT PROPERTY. BUT LET US CONTINUE. Oceanic-continental convergence also sustains many of the Earth's active volcanoes, such as those in the Andes and the Cascade Range in the Pacific Northwest. The eruptive activity is clearly associated with subduction, but scientists vigorously debate the possible sources of magma: Is magma generated by the partial melting of the subducted oceanic slab, or the overlying continental lithosphere, or both?

OCEANIC-OCEANIC CONVERGENCE

As with oceanic-continental convergence, when two oceanic plates converge, one is usually subducted under the other and, in the process, a trench is formed. The Marianas Trench (paralleling the Mariana Islands), for example, marks where the fast-moving Pacific Plate converges against the slower-moving Philippine Plate. The Challenger Deep, at the southern end of the Marianas Trench, plunges deeper into the Earth's interior (nearly 11,000 m) than Mount Everest, the world's tallest mountain and rises above sea level (about 8,854 m). [S: Yes, indeed, there are some VERY INTERESTING things in that trench—just like Hatonn told you before—very interesting.]

Subduction processes in oceanic-oceanic plate convergence also result in the formation of volcanoes. Over millions of years, the erupted lava and volcanic debris pile up on the ocean floor until a submarine volcano rises above sea level to form an island volcano. Such volcanoes are typically strung out in chains, called "island arcs". As the name implies, volcanic island arcs, which closely parallel the trenches, are generally curved. The trenches are the key to understanding how island arcs—such as the Marianas and the Aleutian Islandshave formed and why they experience numerous strong earthquakes. Magmas that form island arcs are produced by the partial melting of the descending plate and/or the overlying oceanic lithosphere. The descending plate also provides a source of stress as the two plates interact, leading to frequent moderate-to-strong earthquakes.

CONTINENTAL-CONTINENTAL CONVERGENCE

The Himalayan mountain range dramatically demonstrates one of the most visible and spectacular consequences of plate tectonics. [S: Please, local readers, PAY ATTENTION.] When two continents meet head-on, neither is subducted, because the continental rocks are relatively light and, like two colliding icebergs, resist downward motion. Instead, the crust tends to buckle and be pushed upward or sideways. The collision of India into Asia 50 million years ago caused the Eurasian Plate to crumple up and override the Indian Plate. After the collision, the slow, continuous convergence of the two plates, over millions of years, pushed up the Himalayas and the Tibetan Plateau to their present heights. Most of this growth occurred during the past 10 million years. The Himalayas, towering as high as 8,854 m above sea level, form the highest continental mountains in the world. Moreover, the neighboring Tibetan Plateau, at an average elevation of about 4,600 m, is higher than all the peaks in the Alps except for Mont Blanc and Monte Rosa, and is well above the summits of most mountains in the United States.

TRANSFORM BOUNDARIES

The zone between two plates sliding horizontally past one another is called a "transform-fault boundary". The concept of transform faults originated with Canadian geophysicist J. Tuzo Wilson, who proposed that these large faults or "fracture zones" connect two spreading centers (divergent plate boundaries) or, less commonly,

trenches (convergent plate boundaries).

Most transform faults are found on the ocean floor. They commonly offset the active spreading ridges, producing zigzag plate margins, and are generally defined by shallow earthquakes. However, a few occur on land; for example, the San Andreas fault zone in California. This transform fault connects the East Pacific Rise, a divergent boundary to the south, with the South Gorda/Juan de Fuca/Explorer Ridge, another divergent boundary to the north.

The San Andreas fault zone, which is about 1,300 km long and, in places, tens of kilometers wide, slices through two-thirds of the length of California. Along it, the Pacific Plate has been grinding horizontally past the North American Plate for 10 million years, at an average rate of about 5 cm/yr. Land on the west side of the fault zone (on the Pacific Plate) is moving in a northwesterly direction relative to the land on the east side of the fault zone (on the North American Plate).

Oceanic fracture zones are ocean-floor valleys that horizontally offset spreading ridges; some of these zones are hundreds to thousands of kilometers long and as much as 8 km deep. Examples of these large scars include the Clarion, Molokai and Pioneer fracture zones in the Northeast Pacific, off the coast of California and Mexico. These zones are presently inactive, but the offsets of the patterns of magnetic striping provide evidence of their previous transform-fault activity.

PLATE-BOUNDARY ZONES

Not all plate boundaries are as simple as the main types discussed above. In some regions, the boundaries are not well defined, because the plate-movement deformation occurring there extends over a broad belt (called a "plate-boundary zone"). One of these zones marks the Mediterranean-Alpine region between the Eurasian and African Plates, within which several smaller fragments of plates (microplates) have been recognized. Because plate-boundary zones involve at least two large plates and one or more microplates caught up between them, they tend to have complicated geological structures and earthquake patterns.

RATES OF MOTION

We can measure how fast tectonic plates are moving today, but how do scientists know what the rates of plate movement have been over geologic time? The oceans hold one of the key pieces to the puzzle. Because the ocean-floor magnetic striping records the flip-flops in the Earth's magnetic field, scientists, knowing the approximate duration of the reversal, can calculate the average rate of plate movement during a given time span. These average rates of plate separations can range widely. The Arctic Ridge has the slowest rate (less than 2.5 cm/yr), and the East Pacific Rise—near Easter Island in the South Pacific, about 3400 km west of Chile—has the fastest rate (more than 15 cm/yr).

Evidence of past rates of plate movement also can be obtained from geologic mapping studies. If a rock formation of known age—with distinctive composition, structure, or fossils—mapped on one side of a plate boundary can be matched with the same formation on the other side of the boundary, then measuring the distance that the formation has been offset can give an estimate of the average rate of plate motion. This simple but effective technique has been used to determine the rates of plate motion at divergent boundaries; for example, the

Mid-Atlantic Ridge and transform boundaries, such as the San Andreas Fault.

Current plate movement can be tracked directly, by means of ground-based or space-based geodetic measurements; geodesy is the science of the size and shape of the Earth. Ground-based measurements are taken with conventional, but very precise, ground-surveying techniques, using laser-electronic instruments. However, because plate motions are global in scale, they are best measured by satellite-based methods.

The late 1970s witnessed the rapid growth of space geodesy, a term applied to space-based techniques for taking precise, repeated measurements of carefully chosen points on the Earth's surface, separated by hundreds to thousands of kilometers. The three most commonly used space-geodetic techniques—very long baseline interferometry (VLBI), satellite laser ranging (SLR), and the Global Positioning System (GPS)—are based on technologies developed for military and aerospace research, notably radio astronomy and satellite tracking.

Among the three techniques, to date the GPS has been the most useful for studying the Earth's crustal movements. Twenty-one satellites are currently in orbit 20,000 km above the Earth, as part of the NavStar system of the U.S. Department of Defense. These satellites continuously transmit radio signals back to Earth. To determine its precise position on Earth (longitude, latitude, and elevation), each GPS ground site must simultaneously receive signals from at least four satellites, recording the exact tie and location of each satellite when its signal was received. By repeatedly measuring distances between specific points, geologists can determine if there has been active movement along faults or between plates. The separations between GPS sites are already being measured regularly around the Pacific Basin. By monitoring the interactions between the Pacific Plate and the surrounding, largely continental plates, scientists hope to learn more about the events building up to earthquakes and volcanic eruptions in the Pacific Ring of Fire. Space-geodetic data have already confirmed that the rates and direction of plate movement, averaged over several years, compare well with rates and direction of plate movement averaged over millions of years.

The vast majority of earthquakes and volcanic eruptions occur near plate boundaries, but there are some exceptions. For example, the Hawaiian Islands, which are entirely of volcanic origin, have formed in the middle of the Pacific Ocean more than 3,200 km from the nearest plate boundary. How do the Hawaiian Islands and other volcanoes that form in the interior of plates fit into the plate-tectonics picture?

In 1963, J. Tuzo Wilson, the Canadian geophysicist who discovered transform faults, came up with an ingenious idea that became known as the "hotspot" theory. Wilson noted that, in certain locations around the world, such as Hawaii, volcanism has been active for very long periods of time. This could only happen, he reasoned, if relatively small, long-lasting, and exceptionally hot regions—called "hotspots"—existed below the plates that would provide localized sources of high heat energy (thermal plumes) to sustain volcanism. Specifically, Wilson hypothesized that the distinctive linear shape of the Hawaiian Island-Emperor Seamounts chain resulted from the Pacific Plate moving over a deep, stationary hotspot in the mantle, located beneath the present-day position of the Island of Hawaii. Heat from this hotspot produces a persistent source of magma by

partly melting the overriding Pacific Plate. The magma, which is lighter than the surrounding solid rock, then rises through the mantle and crust to erupt onto the seafloor, forming an active seamount. Over time, countless eruptions cause the seamount to grow until it finally emerges above sea level to form an island volcano. Wilson suggested that continuing plate movement eventually carries the island beyond the hotspot, cutting it off from the magma source, and volcanism ceases. As one island volcano becomes extinct, another develops over the hotspot, and the cycle is repeated. This process of volcano growth and death, over many millions of years, has left a long trail of volcanic islands and seamounts across the Pacific Ocean

According to Wilson's hotspot theory, the volcanoes of the Hawaiian chain should get progressively older and become more eroded the farther they travel beyond the hotspot. The oldest volcanic rocks on Kauai, the northwesternmost inhabited Hawaiian island, are about 5.5 million years old and are deeply eroded. By comparison, on the "Big Island" of Hawaiisoutheasternmost in the chain and presumably still positioned over the hotspot—the oldest exposed rocks are less than 0.7 million years old, and new volcanic rock is continually being formed.

The possibility that the Hawaiian Islands become younger to the southeast was suspected by the ancient Hawaiians, long before any scientific studies were done. During their voyages, sea-faring Hawaiians noticed the differences in erosion, soil formation and vegetation, and recognized that the islands to the northwest (Nihau and Kauai) were older than those to the southeast (Maui and Hawaii). This idea was handed down from generation to generation in the legends of Pele, the fiery Goddess of Volcanoes. Pele originally lived on Kauai. When her older sister Namakaokahai, the Goddess of the Sea, attacked her, Pele fled to the Island of Oahu. When she was forced by Namakaokahai to flee again, Pele moved southeast to Maui and finally to Hawaii, where she now lives in the Halemaumau Crater at the summit of Kilauea Volcano. The mythical flight of Pele from Kauai to Hawaii, which alludes to the eternal struggle between the growth of volcanic islands from eruptions and their later erosion by ocean waves, is consistent with geologic evidence obtained centuries later that clearly shows the islands becoming younger from northwest to southeast.

Although Hawaii is perhaps the best known hotspot, others are thought to exist beneath the oceans and continents. More than a hundred hotspots beneath the Earth's crust have been active during the past 10 million years. Most of these are located under plate interiors (for example, the African Plate), but some occur near diverging plate boundaries. Some are concentrated near the mid-oceanic ridge system, such as beneath Iceland, the Azores and the Galapagos Islands.

A few hotspots are thought to exist below the North American Plate. Perhaps the best known is the hotspot presumed to exist under the continental crust in the region of Yellowstone National Park, in northwestern Wyoming. Here are several Calderas (large craters formed by the ground collapse accompanying explosive volcanism) that were produced by three gigantic eruptions during the past two million years, the most recent of which occurred about 600,000 years ago. Ash deposits from these powerful eruptions have been mapped as far away as Iowa, Missouri, Texas and even northern Mexico. The thermal energy of the presumed Yellowstone hotspot fuels more than 10,000 hot pools

mudpots (pools of boiling mud). A large body of magma, capped by a hydrothermal system (a zone of pressurized steam and hot water), still exists beneath the caldera. Recent surveys demonstrate that parts of the Yellowstone region rise and fall by as much as 1 cm each year, indicating the area is still geologically restless.

The tectonic plates do not randomly drift or wander about the Earth's surface; they are driven by definite, yet unseen, forces. Although scientists can neither precisely describe nor fully understand the forces, most believe that the relatively shallow forces driving the lithospheric plates are coupled with forces originating much deeper in the Earth.

WHAT DRIVES THE PLATES?

From seismic and other geophysical evidence and laboratory experiments, scientists generally agree with Harry Hess' theory that the plate-driving force is the slow movement of hot, softened mantle that lies below the rigid plates. This idea was first considered in the 1930s by Arthur Holmes, the English geologist, who later influenced Harry Hess' thinking about seafloor spreading. Holmes speculated that the circular motion of the mantle carried the continents along in much the same way as a conveyor belt. However, at the time that Wegener proposed this theory of continental drift, most scientists still believed the Earth was a solid, motionless body. We now know better. As J. Tuzo Wilson eloquently stated in 1968, "The Earth, instead of appearing as an inert statue, is a living, mobile thing." Both the Earth's surface AND its interior are in motion. Below the lithospheric plates, at some depth the mantle is partially molten and can flow, albeit slowly, in response to steady forces applied for long periods of time. Just as a solid metal like steel, when exposed to heat and pressure, can be softened and take different shapes, so too can solid rock in the mantle, when subjected to heat and pressure in the Earth's interior over millions of years.

The mobile rock beneath the rigid plates is believed to be moving in a circular manner, somewhat like a pot of thick soup when heated to boiling. The heated soup rises to the surface, spreads and begins to cool, and then sinks back to the bottom of the pot, where it is reheated and rises again. This cycle is repeated over and over to generate what scientists call "convective flow". While convective flow can be observed easily in a pot of boiling soup, the idea of such a process stirring up the Earth's interior is much more difficult to grasp. While we know that convective motion in the Earth is much, much slower than that of boiling soup, many unanswered questions remain: How many convection cells exist? Where and how do they originate? What is their structure?

Convection cannot take place without a source of heat. Heat within the Earth comes from two main sources: radioactive decay and residual heat. Radioactive decay, a spontaneous process that is the basis of "isotopic clocks" used to date rocks, involves the loss of particles from the nucleus of an isotope (the parent) to form an isotope of a new element (the daughter). The radioactive decay of naturally-occurring chemical elements-most notably: uranium, thorium, and potassium—releases energy in the form of heat, which slowly migrates toward the Earth's surface. Residual heat is gravitational energy left over from the formation of the Earth—4.6 billion years ago—by the "falling surface of Io, one of the moons of Jupiter and about the

and springs, geysers (like Old Faithful) and bubbling together" and compression of cosmic debris. How and why the escape of interior heat becomes concentrated in certain regions to form convection cells remains a mystery.

> Until the 1990s, prevailing explanations about what drives plate tectonics have emphasized mantle convection, and most Earth scientists believed that seafloor spreading was the primary mechanism. Cold, denser material convects downward, and hotter, lighter material rises because of gravity; this movement of material is an essential part of convection. In addition to the convective forces, some geologists argue that the intrusion of magma into the spreading ridge, provides an additional force (called "ridge push") to propel and maintain plate movement. Thus, subduction processes are considered to be secondary, a logical but largely passive consequence of seafloor spreading. In recent years, however, the tide has turned. Most scientists now favor the notion that forces associated with subduction are more important than seafloor spreading. Professor Seiya Uyeda (Tokai University, Japan), a worldrenowned expert in plate tectonics, concluded in his keynote address at a major scientific conference on subduction processes in June 1994 that "subduction...plays a more fundamental role than seafloor spreading in shaping the Earth's surface features" and "running the plate tectonic machinery". The gravity-controlled sinking of a cold, denser oceanic slab into the subduction zone (called "slab pull") is now considered to be the driving force of plate tectonics.

> We know that forces deep within the Earth's interior drive plate motion, but we may never fully understand the details. At present, none of the proposed mechanisms can explain all the facets of plate movement; because these forces are buried so deeply, no mechanism can be tested directly and proven beyond reasonable doubt. The fact that the tectonic plates have moved in the past and are still moving today is beyond dispute, but the details of why and how they move will continue to challenge scientists far into the future.

EXTRATERRESTRIAL PLATE TECTONICS?

The Earth may be unique in our solar system, because it appears to be the only planet that is still volcanically and tectonically active; the Earth, therefore, remains very much alive, while the others apparently have long ceased activity. Volcanic activity requires a source of internal heat, and it is the escape of this heat that fuels plate tectonics. While volcanism played a major role in the early history of Mars, the Moon and probably Mercury, their small sizes, relative to Earth, resulted in the loss of internal heat at a much faster rate. They have been inactive globes for the last billion years

Venus may still be active, though the evidence is questionable. In 1979, the Pioneer-Venus spacecraft measured a high amount of sulfur in the upper atmosphere of the planet; the sulfur amount then decreased over the next few years. This observation suggested that the high sulfur concentration measured in 1979 may have resulted from a catastrophic event, perhaps a volcanic eruption. Beginning in 1990, radar images made by the Magellan spacecraft revealed dramatic volcanic features and long, deep valleys similar in size and shape to oceanic trenches on Earth.

The Voyager spacecraft discovered several volcanic plumes rising many hundreds of kilometers above the size of our Moon. Scientists speculate that large pools of liquid sulfur may exist on Io, possibly heated by tidal forces resulting from gravitational attraction between Io and Jupiter. The thermal energy generated by such tidal forces may be enough to produce convection in Io's interior, although no one has clearly recognized any surface feature that may have formed from such convection.

The surface of Ganymede, another moon of Jupiter and about the size of Mercury, is broken into many plate-like blocks, with long, narrow depressions between some of them. Whether these surface features represent ancient "fossil" plate tectonics, or are actively forming, remains to be answered. Crucial to determining whether plate tectonics occur on Ganymede, is the search for evidence of a deep ocean beneath its icy surface. Such a body of water, if it exists, might contribute to internal convection.

The rate of heat loss is critical to a planet's tectonic activity. Size is one determining factor: Larger bodies lose heat more slowly and will, therefore, remain active longer. Another factor is composition, which influences the ability of a body to convect. For example, a liquid interior, such as may exist within Ganymede, is more likely to convect and drive plate tectonics than the "stony" interiors of the Moon, Mercury, Venus and Mars. The amount of radioactive elements present in the planet's composition also affects the likelihood of internal convection, because the decay of these elements produces heat. Apparently, the interiors of the Moon, Mercury and Mars are either too rigid, or have lost too much of their internal heat, to convect and drive plate tectonics.

Eventually the Earth, too, will lose so much heat that its interior will stop convecting. Earthquake and volcanic activity will then cease. No new mountains will form, and the geologic cycle of mountain building, erosion, sedimentation and soil formation will be disrupted and also will cease. Exactly how a cooleddown Earth will change surface conditions—and whether the Earth will still be habitable—nobody knows. Fortunately, these changes will not happen for many billions of years! [S: Yes, that's what the dinosaurs said, too.]

The tectonic plates do not randomly drift or wander about the Earth's surface; they are driven by definite, yet unseen, forces. Although scientists can neither precisely describe nor fully understand the forces, most believe plates are coupled with forces originating much deeper in the Earth.

AFTER EARTHQUAKES, TSUNAMIS FOLLOW

Tsunamis are giant sea waves generated by undersubmarine earthquakes are shallow-seated and strong enough (M7.0) to displace parts of the seabed and disturb the mass of water over it. Other sources of tsunamis include submarine or coastal landslides, pyroclastic flows and large-volume debris avalanches from oceanic and partly submerged volcanoes, and caldera collapse.

Although tsunamis may be triggered in various ways, their effects on the coastal areas are similar. The large waves of a tsunami are preceded by initial lowering of the water level—even beyond the lowest tidal levels attained at a given area. This phenomenon resembles the low tides which may have led other people to call tsunamis falsely as "tidal waves". During the retreat of the sea level, interesting sights are often revealed. Fishes may be stranded on dry land, thereby attracting people to collect them. Also, the usually underwater sandbars and coral flats may be exposed. These scenes tempt people to flock to the shoreline, thereby increasing the number of people at risk when the onrushing waves of a tsunami hit the area. After the retreat of the sea level, the large waves follow. The time interval between successive waves is usually from 20 to 30 minutes. On some occasions, as many as 16 cycles of small and large waves have been observed. This means that the hazard from a tsunami does not immediately dissipate after the first large waves, since several large waves may follow the first.

Similar to ripples caused by a stone dropped into a pail of water, tsunamis travel in all directions and to very far distances from the source sites. This means that tsunamis generated along the coast of California may travel to all the coastal areas around the Pacific Ocean and may reach the eastern shores of the Philippines within 16 hours.

Usual velocities for tsunamis vary from 700 to 800 kilometers per hour, depending on the water depth. In deep water, their velocity is drastically reduced. But an inverse pattern occurs for the tsunami height. In the open ocean, the waves may be indistinguishable from the normal oceanic waves, since the depth and volume of the water conserve kinetic energy and allow for a low height for the moving waves. In open seas, therefore, tsunamis may have a height of only around a meter or less. Along the coast, however, the energy that the waves possess is affected by the shallow depth, so that the water compensates by shoaling or increasing in wave height. The destructive force of these tsunamis is, therefore, effectively transmitted as large sea waves that reach heights of several tens-of-meters above the normal sea level. Other factors that may affect the destructiveness of tsunamis are irregularities on the sea floor, coastal topography, or the presence of shoals and embayments that can modify and dissipate the energy. A tsunami can, therefore, affect one part of the shoreline, while adjacent parts remain unaffected

because of the differences in coastal structures.

The waves sometimes reach a considerable distance inland. During their advance and retreat, they destroy woodlands, buildings and infrastructures and sweep with them movable objects, such as automobiles, which add to their destructive power.

On several occasions, tsunamis have affected various coastal areas of the Philippines and their source regions, ranging from as far as Alaska to Krakatau in Indonesia. Local earthquake events are also known to generate tsunamis

Particularly vulnerable to tsunamis are the coastal areas of Southern Mindanao facing the Celebes Sea, because tsunamigenic earthquakes often originate from the bottom of the Celebes Sea.

From 1603 to 1975, 27 earthquakes generated tsunamis, which wreaked considerable damage to coastal towns. On August 16, 1976, the Moto Guro earthquake produced a tsunami which devastated the southwest coast of Mindanao and left more than 3,000 people dead, with at least 1,000 people missing. More than 8,000 people were injured, and approximately 12,000 families were rendered homeless by 5-meter-high waves.

I do suggest that you get some kind of documents, through Brad, TO COLLECT ANYTHING. Brad should also know if they can legitimately lock the place without giving a 3-day notice. It may be possible to continue to move things, with access to the house, since they have not properly served a Notice to Vacate. Before you can do much more, you probably need to know where the property lines are, and you will need the Deed to the south lot, 131, we think. It should be in the P. Church file. There was a lot of litigation about it, so it ought to be a fairly thick file. If Brad is in the trial in Carson City on the George Green/books matter and can't

assist, see if he or his secretary can locate the real estate attorney in Bakersfield who acted as our expert in the malpractice case, if you seriously need an attorney. And, when you go to the place to recover things, GO WITH SEVERAL PEOPLE, RATHER THAN INDIVIDUALLY. This applies especially to Gene; let's not take any risks we can avoid.

Those aviaries were brought to that property and they will go with the Birds—even if to only grace the new Bird Shop in the Apple Center. If you can't get the aviaries NOW, you will really need help from Brad. If the argument is over "property", then it certainly WILL NOT include pets, family or bird-life! NOTHING WAS "ABANDONED"—AS IS TOTALLY IN EVIDENCE—AND THIS MUCK IS UNACCEPTABLE TO EVEN HUMANE PARTIES. IF NECESSARY—GET AUDREY AND ERIC TO PLEASE GET A HUMANE SOCIETY ORDER TO GET THOSE BIRDS INTO SAFETY AND SECURITY! WE CAN ARGUE LATER—LEAVING THEM IS NOT APPROPRIATE—WE DO NOT BATTLE WHERE LIVING CREATURES ARE AT STAKE.

Do not fight with anyone, please, as to "things"—just get the birds into care and safety—and leave the rest to the LAW. I repeat, if you are not allowed to get them into care: THE HUMANE SOCIETY CAN!

The smaller Propane tank is leased by us, personally, so it can be shut off and either moved to the south lot or exchanged out. The company can attend it—it does NOT go with the house and—now that there is a GAS LINE up to the house—it needs nothing more.

Perhaps within only DAYS we will be able to build bigger and better birdhouses, so don't distress. This is major harassment and intent to damage, and it should be treated IN EXACTLY THAT MANNER! They need heated houses, and I no longer trust the security of putting any of them at the farm, except if they are watched 24-hours-a-day. So, my preference is just to build them a shelter somewhere—where heat and safety are provided—and we can work from there. It is apparent that the cult is going to continue the evil manipulations. Isn't anyone else tired of Tricky and Etheric, and their cute little gang of Halloween Rays? God said they would not stop the assaults until they use up everyone possible, and perhaps they are about to the end. Then realize that that "old Luciferian dude" will dump them like the used-up hot potatoes they have become. He never keeps his promises, and the dump happens when they are no longer USEFUL TO HIM. GOD OF LIGHT WINS! NOT THE THIEVES OF DARKNESS.

And no, team, WE WILL NOT BREAK!—the laws nor our Spirit.

And if they say they couldn't serve a three-day notice to quit—remind them that there have been at least 15 people on the premises moving out. Oh, did anybody LOOK? That alone represents a loss of at least three Macaw birds which would have sold for at least \$2,500 or more, each, even the eggs. No—YOU add it up and don't give me the old "Well, it could be worse!" It is bad enough, and babies cannot survive without heat, or incubation or parents. SOMEONE IS GOING TO BE RESPONSIBLE FOR THIS ATROCITY OF INJUSTICE IN THIS TERRIBLE AND UNLAWFUL ACTION. When you have picked on the innocent of my creatures, you have really done a number on yourself.

OK, NEXT: There are eye-witnesses who saw people at the house, on the north side, removing things. (Oh yes, REALLY!) We know that there are several of you out there and Mr. Elley can find out who, through the records of the old RTC case and Mr. Horn's presentation through Tuten and Green.

Ugly? Depends on your perspective, I suppose.

I believe, for instance, that Tulanians, for instance, can testify that they sold to E.J. and installed the entire fireplace insert, which was several thousands of dollars—now missing from the premises. And what of the outside gasheater, used for tending the Drias in winter—from the back deck? No, it is not in the storage areas. Just the missing items from the weekend—when people were seen removing things as if in service to Millers—are adding up to near \$25-30 THOUSAND. THIS IS DEFINITELY UNACCEPTABLE.

And as for the rest of things and how things in Manila are going: Merry Christmas and a delightful New Year! Won't be a bad Halloween for the goodly, either! And, oh yes, Dharma: HAPPY BIRTHDAY! And, yes, God does know what HE is doing.

By the way, get an order to have returned, in perfect working condition, the fork lift(s). That was taken without permission from Ekkers—from the farm, and David Campbell was seen and stopped for inquiry while removing it to his "job" in the L.A. area. Those were paid for handsomely several years ago, in cash, and they will be returned, and to solve the problem of decision making, you will simply get a court order. You have witnesses, and his wife Kathy; I wouldn't think—after all the other incredible problems—she would lie about the use of those pieces of equipment. They were used for tilling the farm and are needed for lifting the heavy equipment during this move. We should charge double for failing to return them in time for moving out the furnishings in the house just evacuated. It is not "vacated", in fact, just evacuated under threat and duress, to secure the property.

Mr. Campbell says he has them (the heavy equipment) because they needed repair? Well, he had agreed to pay a minimum of a \$1,000 per month in his first taking for use of that equipment—agreed with Charles. Even with repairs, there is outstanding some thousands of dollars, due and owing. Well, Charles is no longer in charge, is he? The equipment will be returned IN GOOD WORKING CONDITION, NOW. There is an accounting to be done on all property and business, and to solve the problem of preferences or decision making—we will issue subpoenas to the people involved with any business for any entity,

including Ekkers, relative to that business, notes, loans, property, items such as the lifts, personal loans, repayments of loans, salaries paid, hours actually worked, etc. It is being taken out of our hands with the removal (unlawfully) of files and information.

Oncoming Monetary Collapse— The Fight For Honest Money

Address by Lawrence M. Parks, Executive Director, Foundation for the Advancement of Monetary Education (FAME)

Delivered to Doctors for Disaster Preparedness Scottsdale, Arizona, July 12, 1998

Suppose I were a United States Congressman. And suppose I were not a particularly principled United States Congressman. (Although, for most of this audience, that may be redundant.) And suppose my congressional buddies and I decided to spend \$900 billion on the "general welfare". Or, for those of you who are more cynical about these things, suppose we decided to shower \$900 billion on particular constituent groups in order to buy their votes and thus assure our continued reelection.

Since Congressmen are astute politicians—if they were not astute politicians they wouldn't be in the Congress to begin with—they know that if they were to raise taxes to pay for this largesse, there would be resentment and their purpose would be defeated. But, with our fiat "funny-money" monetary system—fiat money being money that is created out of nothingpoliticians don't have to do that.

They merely pass the enabling legislation, and send it over to their employees at the Treasury Department. They, in turn, type up a Government bond; think of it as an IOU. Then, in this instance, their agents take the \$900 billion bond to a small group of private companies called commercial banks and ask them to buy it. As I speak, according to the Federal Reserve's Flow of Funds Reports, banks in the U.S. have, in fact, bought \$900 billion worth of U.S. Government Bonds for their own accounts and have them on their balance sheets. It is at this moment that this presentation begins to get interesting. Because, where do you suppose the banks got the \$900 billion to pay for these bonds?

Before continuing, let me dispose of two places where they most certainly did not get the money. Most people in this country and around the world are under the mistaken impression that banks merely re-circulate deposits. That is, that they lend money that has been saved by others. But, when the banks bought these \$900 billion in U.S. Government securities, was anybody's bank balance reduced? Did you ever have the experience that one day your bank balance was inexplicably reduced and, when you inquired, the bank told you that they had lent your money to someone else? Of course not.

One of my colleagues, who is a director of a small bank, once suggested to me that banks got the money from bank capital. But, the banks in this country never had even a third of this amount in bank capital. So, if they didn't get the money from depositors or from capital, where did they get it?

The answer is that they simply created it out of nothing! If the notion of a small group of private companies creating \$900 billion out of nothing is confusing to you, it is only because the concept is so blatantly outrageous. Why, in a democracy, should a small group of private companies have this power? By State". They object to the notion of transferring wealth

the way, they don't call it creating money. No one would stand for that if they understood what is happening. They use jargon to confuse you. They call it "fractional reserve lending".

And, physically, how do they work this magic? It is simple. Little fingers go to a computer keyboard and type "900" followed by nine zeroes and, miraculously, beyond the dreams of any Sixteenth-Century alchemistwho might have spent a lifetime trying to turn a lump of lead into gold—these bankers created \$900 billion. Amazing!

For those of you who are into accounting, the Taccounts look like this: On the left side, the assets are the \$900 billion in Government bonds that the folks at the Treasury Department typed up and, on the right side, the liabilities are the \$900 billion that the banks created out of nothing. So, the books are in balance.

But, one might ask, don't the books get out of balance once the money is taken out of the banks? This is part of the genius of the system. The money never leaves the banking system. Consider what you do with any check that you get from the government, whether it is a Social Security check or payment for whatever. Every check must eventually be deposited in a bank.

For our erstwhile politicians, this is a wonderful arrangement. In effect, they can act unilaterally without bothering the people to pay for whatever they want to do. This has led to some monstrous excesses. For example, the Vietnam War could never have happened if President Johnson would have had to raise taxes to pay

It was acceptable to most people, because mostly the kids of poorer families had to go fight, and "no one had to pay for it". That is, taxes were not increased. If Johnson had proposed legislation to raise taxes by the more than thirty percent needed to finance the war, there would have been much more oversight as to what was happening with the money. This is true for almost all government expenditures.

If politicians don't need to raise taxes to pay for their programs, people are much less concerned than they might otherwise be. In the case of President Reagan, he was able to actually lower taxes while increasing government spending.

But, as good a deal as this is for politicians, it is a fantastic deal for the banks, because they get almost \$50 billion in "interest", year in and year out, on the \$900 billion worth of U.S. Government Bonds that they "bought". Since there was virtually no work in creating the \$900 billion (how much extra work is needed to create \$900 billion as opposed to just \$9 billion? One has only to press the zero key twice!), they are, in effect, getting the \$50 billion each year as a gift. And since money on deposit in commercial banks pays virtually no interest—when last I looked, my checking account paid 0.8% interest—the interest that they get from the government on their bonds is virtually all theirs to keep.

Now, there are some people in this country, perhaps even in this room, who decry the so-called "Welfare Typically, one hears them complaining about things like the School Lunch Program, whereby the government subsidizes lunches for children who might otherwise not get enough to eat. Sometimes the object of their ire is the Food Stamp Program, whereby adults are subsidized who might otherwise also not get enough to eat. Very definitely, they complain about Aid for Dependent Families Program, whereby women who have kids without another breadwinner are subsidized by the government. And, always, they complain about payments to people who arguably could and should work.

But, what about this not inconsiderable amount of wealth transfer to banks? Where are the libertarian. conservative and Republican voices being raised against this bit of injustice? I have listened very carefully, and I have never heard them. And, since people in banking are generally more well-to-do than the rest of us, isn't richer people? I call it "stealing from the poor to give to the rich". It's Robin Hood, in reverse.

And what about the constitutionality of this kind of wealth transfer? Where are organizations like the Federalists, who believe that judges should interpret the Constitution the way it was written and not the way they wish it was written, when it comes to this bit of injustice? Here is an instance where the Congress has delegated to the banking system a power that the Congress itself does not have. Virtually all of those who believe in the Rule of Law have been silent. How come?

Let me interject that FAME Foundation Scholar Edwin Vieira, a Harvard-trained attorney who has devoted most of his life to these issues, has written a wonderful monograph on this matter called The Forgotten Role of the Constitution in Monetary Law. It appeared in the Fall, 1997 issue of the Texas Review of Law & Politics. It is also available in full text on FAME's web-site, www.fame.org.

Let's continue. Suppose, now, our political friends decide to raise another \$450 billion. As before, they pass the enabling legislation and send it over to their employees at the Treasury Department, who type up a bond issue. But, this time, instead of having commercial banks monetize—turn into money—this debt, they take it to their quasi-employee, Alan Greenspan, at the Federal Reserve, and they ask the Federal Reserve to buy it. Being the fiscal agent of the Treasury, the Federal Reserve is happy to oblige.

And where does the Federal Reserve get the \$450 billion? The same place the banks got it. Little fingers go to a keyboard, type "450" followed by nine zeroes, and the \$450 billion miraculously appears in the government's checking account. Obviously, I am using a bit of hyperbole here. Both the \$900 billion and the \$450 billion were not created by eighteen key presses. They are the result of many such transactions over a period of years. If all of this happened at one time, people would catch on and would object.

But, in the case of the Federal Reserve monetizing U.S. Government debt, there is an important distinction, as opposed to when banks create money. The Federal Reserve does not keep the interest for its own account. After subtracting its "expenses", a portion of which is used to buy off critics, especially economists, the Federal Reserve returns the interest back to the Treasury.

So, in effect, it is as if the U.S. Government created the \$450 billion itself. Further, when the \$450 billion is spent and becomes deposited in commercial banks, it becomes the "reserves" about which you have heard so

from people who earn it to people who don't earn it. much. The truth of the matter is that this is so much taxpayers, this, in Chairman Greenspan's words, of nothing and act as a constraint only on small-bank money creation. As a practical matter, big money-center banks are not limited by reserves.

> Now, this story gets even better, or worse, depending upon your point of view. Not only do banks create money when they lend to the government; they create money when they lend to anyone! For example, if you get a \$100,000 mortgage from Citibank, where do you suppose Citibank gets the \$100,000, which they credit to your account? Again, after they lend you the money, there is not a single depositor in the bank who has any less money in his account than before they lent you the money. As with the \$900 billion, the bank creates the money with a simple bookkeeping entry.

How much money have the banks in this country created? According to the Federal Reserve's Flow of this a case of transferring wealth from poorer people to Funds Reports, since 1950 they have created something in excess of \$5 trillion. Just in the last six years, they have created \$2 trillion, and in the last two years, they have created \$1 trillion. To put this another way, if they can find someone to borrow, they can create more money on which they get interest and fees. Thus, they are fully motivated to create all the money they can, which is why they sent out three billion credit-card solicitations last

> But what about credit risk? If they lend wantonly, won't they be penalized? In fact, this is a growing problem for them. In the last thirty years, as the capital markets have become more efficient, the more creditworthy borrowers of the world, such as IBM or the Ford Motor Company, bypass banks when they need money. They go directly to the commercial paper market where they get better terms and pay less interest.

> As a result, to continue to generate fees and interest, banks have had to lend to less credit-worthy borrowers, such as "emerging countries", and for more illiquid investments, such as real estate. This means that the quality and liquidity of bank assets has been decreasing as the amount of money they are creating has been increasing. This is an unstable situation, and everyone in the banking industry knows it.

> In order to protect themselves, bankers have negotiated with, or to use a less friendly term, colluded with, politicians over a long period to legislate two safety nets for the banks; and, today, for many Wall Street firms, too. Federal Reserve Chairman Greenspan has identified these safety nets as true subsidies. Since, by definition, every subsidy is, in fact, wealth transfer, this is another instance whereby wealth is being transferred from working people to the financial sector. In effect, these safety nets protect and subsidize the banks' balance sheets. They come in two flavors.

> First, and most important, bank assets are protected by what is commonly known as the "lender of last resort" facility at the Federal Reserve. In the event that bank assets systemically, not individually, start to deteriorate, i.e., become "illiquid", or not marketable, then the Federal Reserve—read: the ordinary taxpayerstands ready to convert those possibly worthless assets into cash. And where does the Federal Reserve get the cash to purchase these assets? You guessed it. Little fingers go to a keyboard and they create it out of nothing. Folks should know that every time money is created out of nothing, it dilutes the purchasing power of money that has been saved or promised for future payments, such as pensions.

Because bank assets are guaranteed by ordinary

gobbledygook. The reserves themselves are created out encourages banks to take more risks than they otherwise would, if their own capital were at risk. He calls this lender-of-last-resort subsidy a "moral hazard". What this means is that the party taking the risks gets the rewards if the risks work out but, if they fail, someone else, the ordinary taxpayer, pays the price.

> It's as if you played in a poker game that was conducted in this way: If you win, you keep your winnings; if you lose, ordinary taxpayers will make up your losses. Who wouldn't play at a game like that? But is this fair to ordinary taxpayers? No one else in society has this kind of guarantee. Did our elected representatives ever explicitly vote for this? Did you?

> What is to stop the financial sector from milking the system? And milk it they have. The "regulators", with whom they have colluded for nearly a century, have put rules on the books to cause banks to operate with a certain amount of capital (because, with this kind of guarantee, why would a bank need any capital at all?). Meanwhile, banks have engaged in all kinds of offbalance-sheet shenanigans to take advantage of the subsidy.

> For example, today, depending upon whom one listens to, there are between \$60 and \$70 trillion in notional derivatives underwritten by banks. In effect, these are bets that banks make on things like interest rates and the like. Again, if they win these bets, they keep the winnings. If they lose, you pay! Is this fair?

> Still another example is a type of gambling that banks engage in which they euphemistically call "trading", as in "currency trading". Last year, according to Citibank's Annual Report, Citibank garnered nearly \$2 billion from this activity. The truth is that this is nothing but gambling, subsidized by ordinary taxpayers. And how much is the subsidy?

> According to Chairman Greenspan, in the event of a meltdown of bank assets—as is now happening in many foreign countries including Russia, Japan, South Korea, the Philippines, Mexico and elsewhere—the Federal Reserve stands ready to transfer wealth to the banks "without limit". Without limit! In other words, the banking system has a call on all of the accumulated wealth of this country, including that which has been put aside for workers' pensions. Again, did anybody vote for this? Is any of this fair? Not where I come from.

> Today, you hear a lot about the sanctity of free markets. When whole industries are transferred to foreign shores and working people lose their jobs and request some kind of protection, such as tariffs, our political leadership and the business community, along with their colleagues on Wall Street, rev up the mantra "free markets are essential". But do any of these subsidies and guarantees, along with the power to create legal tender money out of nothing, sound like free-market innovations to you? I don't think so. Again, where are the libertarian, conservative, Republican or even Democratic voices being raised against this injustice? All are silent.

> The second safety-net subsidy I want to mention is that which guarantees the liability side of bank balance sheets. It's called Federal Deposit Insurance. The notion is that if banks cannot make good on people's deposits, ordinary taxpayers will do it for them. This allows banks to borrow money more cheaply than otherwise, because the credit of the U.S. government stands behind repayment. In effect, ordinary taxpayers are subsidizing them again.

This wasn't always the case. In the last century, it

is true that there were many bank panics whereby banks went bust. However, an insignificant amount of depositors' money was lost due to bank failures. This was not that much of a calamity for ordinary people. It was, however, a calamity for the banks involved because, in those days, with some limitations, bank officers and directors were personally liable to depositors in the event that their bank could not make good.

As a result, they were much more conservative in their money creation, which was not legal tender. In those days, bank capital as a percentage of bank assets, i.e., the amount of money that a bank creates, was on the order of 40%. Today, it is a tiny fraction of that. As Deposit Insurance transfers wealth from ordinary taxpayers to the financial sector, from poorer people to richer people. It is simply not fair.

When I first got started with this, some people granted to me that perhaps I was right and that none of this is fair. But, they said, life is not fair. In a \$7 trillion economy, so what if the financial sector skims a few hundred billion a year or whatever? Meanwhile, we are incredibly prosperous. Interest rates are lower than they have been in a generation, unemployment is down, the "economy" is booming, and so is the stock market. So, what is the problem?

China, hundreds of fiat-money monetary systems have been attempted. And, 100% of time, they have failed. Why should a monetary system—its moral defects notwithstanding—that hasn't worked for 1200 years, work now? Why shouldn't our fiat money melt just like every other funny money?

The reason why fiat money monetary systems always fail is this: Whenever bankers and/or politicians are left in charge of the integrity of legal tender fiat money, the temptation to manipulate that money for their own benefit has been so overwhelming that none of them have been able to resist the temptation. In every case, they have driven the purchasing power of the fiat money down to its cost of production, which is near zero. Why would any thinking person think that our politicians and/ or central bankers have any more brains or integrity than those of the past? Indeed, they have already succumbed to the temptation. Since 1950, our dollar has lost more than 90% of its purchasing power. Why does anyone believe that the last 10% is sacrosanct and will not disappear as well?

Many believe that our system is different. They believe that prudent legislation and oversight from the Federal Reserve will protect us. They believe in the ability of Chairman Greenspan to guide us through the shoals. But, if there is any lesson that has been learned from the demise of the so-called "Evil Empire", it's that central planning doesn't work.

I am going to ask for a show of hands: How many of you agree with the proposition that central planning doesn't work? (Virtually everyone raised his or her hand.) Well, if you all agree that central planning doesn't work, then why would anyone expect that our central bank, which is in fact a central planner, will have any more success than any other central planner? This is a contradiction that most people have yet to deal with.

All over the world, fiat money is melting: in Russia, in South Korea, in Malaysia, in Thailand, in the Philippines, in Indonesia, in Mexico, in Canada and elsewhere. As the fiat money melts, working people whose savings are denominated in their fiat money—lose those savings.

Interest rates increase because lenders cannot have real reason why we don't have gold-as-money, I have an confidence that when lent money is returned it will have equivalent purchasing power. Commercial relationships predicated on lower interest rates unravel and businesses go out of business. People lose their jobs. Mass suffering results, and frequently there is a regime change. Mass suffering, loss of savings and loss of jobs don't generally lead to freer societies. They many times result in a tyranny.

THE SOLUTION:

So what is the solution to all of this? The answer with the lender-of-last-resort bailout facility, Federal is commodity money, and the commodity money of choice for all time, whenever it was available, is gold-asmoney. It is important to realize that all transactions are, in essence, barter. We are always trading work for work, wealth for wealth, value for value. Money comes about if you send me an e-mail at LPARKS@FAME.ORG, we because direct barter is too inefficient; the transaction costs are too high.

> commodity, with which to trade. Over time, the medium-of-exchange commodity has been many things: It has been cattle, salt, whisky, tobacco, beads and, of course, the precious metals, gold and silver.

But there is a problem with commodity money. For The problem is that since the Eighth Century in most transactions, especially small transactions, it is inconvenient to carry the commodity. For example, how would you buy a newspaper or a cup of coffee and pay for it with tobacco or gold? The market has solved this problem.

> Commodity money generally evolves into what is known as fiduciary money. People deposit their commodity in a warehouse, which becomes the fiduciary, and the warehouse issues receipts for the commodity that are redeemable on demand. Then people trade the receipts, because they have confidence that they may redeem the receipts whenever they wish.

> The commodity that people settle on evolves. Whenever and wherever one drops in on the planet, whether it be the Aztecs in the Eighth Century, the Chinese in the Twelfth Century, the Babylonians in Biblical times or the English in the Eighteenth Century, one finds gold-as-money. How did that happen?

> It's not as if someone came down from outer space and decreed over the millennia and over the continents that people use gold. Gold is not money because some potentate or government chose it so. Gold is used as money because free people chose it in free markets, all over the world and for thousands of years. Simply stated, they chose it because it is the most efficient medium of exchange for transmitting value over space and for transmitting value over time.

> The historical record clearly shows that with commodity money there is greater stability, more limited government, a freer society, lower interest rates, more jobs, a longer planning horizon, more manufacturing, a higher standard of living for all, especially working people, and a more peaceful society.

> So, if honest money, commodity money such as gold-as-money, is so much better, why are we stuck with the inferior stuff? Why don't we have gold-as-money?

> Only a few, if that many, economists have identified the real cause. Murray Rothbard and George Reisman come to mind. But it took a non-economist, and one of the most brilliant financial men on the planet, George Soros, to put it clearly into a single sentence.

> Before I tell you what George Soros identified on page 101 of his excellent book Soros on Soros as the

even more eloquent formulation, also in one sentence: The reason why we have fiat money and not gold-asmoney is that gold-as-money is incompatible with the ability of banks to create money out of nothing.

What Soros said is: "[A lender of last resort] is what was missing in the gold standard in the nineteenth century (sic—1900s), that is what led to the development of central banking and the eventual abandonment of the gold standard."

Creating legal-tender money out of nothing is extremely profitable for banks. However, without the subsidy provided by the lender-of-last-resort bailout facility, it can lead to eventual ruin. Gold stands in the way of the ability of a bailout. So, bankers colluded with politicians to get rid of gold. In FAME's Fight for Honest Money brochure, which is available at no charge give more of the historical background to this.

Others have touched on this subject. Lord Maynard So the market looks for an intermediate good, a Keynes, for example, who as some of you know was responsible for setting up the central bank in India, understood full well that gold stood in the way. He was a marvelous wordsmith, and it was he who came up with the phrase, "Gold is a barbarous relic."

> In recent times, authors such as Robert Pringle, a past editor of the magazine Central Banking, who, along with Marjorie Deanne, an editor of The Economist, wrote on page 183 in their book Central Banks that central banks understand that paper money is in competition with gold, and that they want paper money to win. What better way to win the competition than to get politicians to outlaw gold, which is what Franklin Roosevelt did in

> For forty years it was a felony for U.S. citizens to own monetary gold. What "public policy" could possibly have been served by this atrocity? Even in his fireside chat, after he seized citizens' gold, Roosevelt assured the people that our money "would not be fiat". It's clear to me, at least, that we have been swindled.

ACHIEVING HONEST MONEY

Assuming one buys into this argument and recognizes that we have a problem, how can we achieve honest money? Thomas Jefferson provided the answer: Shine a light on the truth. Jefferson was willing to forgo everything in the Constitution, except freedom of the press. He understood that people will always do the right thing, when they understand what is going on.

To effect social change in America, one must recognize that the media sets the agenda. We have no leadership in the putative sense. It's not as if you run a company and you tell your employees what to do and they do it. Our so-called leaders are, in fact, poll-takers. They wake up in the morning and put their finger to the wind to see which way the wind is blowing. That is the way they blow...today.

Or, to put it another way, they look for a parade and, when they find one, they get in front of it and say, "Whatever these folks are for, I'm for it." So, the challenge is to start a parade.

One way to do that, especially on a limited budget, is with a grass roots effort. FAME is organizing people who understand the injustice of fiat money and the benefits of gold-as-money, to help bring the media up the learning curve.

I want to tell you something that almost no one knows:

Journalists get hardly any mail. If you write an intelligent letter to a journalist, it will get read. Sometimes that journalist will respond and you can begin a dialogue. On the other hand, when people get upset about something they read in a newspaper or magazine, they most-times write a letter-to-the-editor, if they do anything at all. As a result, editors get tons of mail, almost all of which is unread.

FAME has done something else, which I think is unique. We have taken this issue very strongly to Organized Labor, because working people are the principal victims of fiat money. When fiat money melts, rich people become less rich. Professional people earn less. But workers lose everything. They lose their savings, their pensions and their jobs. In places like Indonesia, for example, workers are starving. After a lifetime of work and saving, they are eating bark off trees and boiling grass

To paraphrase AFL-CIO President John Sweeney, when speaking of other issues of concern to Labor, they have the votes and they will do something about it. To help get closer to Labor, I have joined two unions: The Workers' Education Local 189, CWA AFL-CIO, and the National Writers' Union, UAW Local 1971 AFL-CIO.

One of the reasons why I am optimistic about Labor is that Labor has a long heritage in support of honest money. For example, when the Labor Movement first got underway in the U.S., circa 1830, there were three issues driving men to join unions: the ten-hour workday, education for workers and hard money. The Labor Movement strongly supported Andrew Jackson, a populist Democrat who opposed the Second Bank and whose slogan was "Gold is the friend of the farmer (and the worker)."

One of the very first union leaders, Ely Moore, who helped found and was President of the Typographer's Union in 1832, was a staunch supporter of Jackson and hard money. He was also the first union man elected to the Congress, which was in 1834, and hard money, as opposed to paper money, was an important issue for him.

Labor was keen on hard money until after the Civil War, when there was confusion all around. But, by the end of the century, Labor reaffirmed its support for honest money. William Jennings Bryan's "Cross of Gold Speech" notwithstanding—and Bryan was for silver-as-money, not fiat money—Labor by and large was in favor of gold.

In the most important labor publication of the day, *The* American Federationist, which was the house organ of the American Federation of Labor, there were many articles supporting gold-as-money. (By the way, nothing gets into a labor publication unless it has the support of the leadership.)

At that time, Labor said: "Gold is the standard of all great civilizations." Labor said: "We (the American Federation of Labor) believe in a financial policy that will neither depreciate our currency at home nor abroad." Labor said: "No legal-tender law is ever needed to make men take good money; its only use is to make them take bad money. Kick it out!" Labor said: "We believe in an honest dollar." They even had little buttons that said "Honest Money".

Mindful of the benefits of honest money: secure savings; lower interest rates; a higher standard of living; more and better paying jobs; a more peaceful society; a freer society; and because of the perils of fiat money: complete loss of savings; loss of jobs; maybe even the loss of our basic freedoms; I urge you to help us to achieve a fair and just monetary system. I invite you to join the Fight for Honest Money. Thank you for your kind attention, and may God bless you all, and may God bless our great country.

Various combinations of agendas from other projects like Monarch and MK-ULTRA as well as the Montauk Project are being implemented via these in New York City and Long Island-and many years operations.

Nearly every major population area in the country has a "Montauk Boys and Girls" project underway at this time. Children can be "accessed" and programmed through various means—such as having schoolchildren on overnight field trips bunk at "decommissioned" military facilities, during which time they are abducted, programmed and returned.

Subsequently, triggers and cues embedded in popular mass entertainment (for example, the movie *Scream* has been cited as inspiring certain of the horrendous, grisly mass murders committed by young adolescents in the U.S. recently) can set these "sleepers" off in predetermined ways. Parents: More than ever, and in ways you would never have dreamed of, watch out for your children—who they are with, what the influences on them are, where they go, what they are interested in.

TEENS AND PRETEENS WHO (MASS) MURDER

The ongoing string of mass murders committed by young boys—often right around the age of puberty (considered to be a very significant age by the Montauk in one of Alex Constantine's articles on the mass-ritual-

Project mind-control experiment operators)—has finally pushed me over the brink; into confronting, head-on, the likelihood that this and a veritable blood orgy of similar mass murders by youngsters in the past couple of years—mostly but not only in the southeastern U.S.—are the result of some sort of mind-control program.

I have had strong suspicions that the Jonesboro, Arkansas massacre in March 1998, a May 1998 graduation-dance massacre in Edinboro, Pennsylvania and a subsequent school shooting rampage in Springfield, Oregon—to name only the some of the more recent incidents—represent the tip of the iceberg of some serious and extensive youth-directed/mass-conditioning programs currently underway. Regarding the Arkansas tragedy, in particular, there were some very troubling aspects to the mass shooting there by two youngsters, aged 11 and 13, who murdered four schoolmates and a teacher, while wounding 11 others. The two were in possession of a number of weapons, camouflage clothing, a van stocked with provisions and "survivalist" gear, among other oddities, and there were reports of ties to a satanic cult of some kind currently popular in the southeastern U.S.

Despite a fairly rigorous childhood and teenage-hood since spent in other major urban areas like L.A. and the Bay Area—I must say I can really recall no precedent for these types of mass slayings perpetrated by teens and preteens, against their peers or elders, often carried out at (usually public) schools.

What in the name of God or any standard or concept of a more evolved, civilized and positive existence and being—what in the name of any decency, reason, compassion, or awareness—could possibly be motivating or compelling these young people to manifest such remorseless, shameless and vicious violence in mass murder?

And notice, also, that this is not happening in New York, L.A., Chicago or other large cities. It's happening mainly in quiet, totally "typical", rural/suburban Middle-American communities, among predominantly White, middle-class people.

I think programming is on the scene here in a most major style.

Subliminals embedded in popular entertainment could even be the triggers for certain preprogrammed behavior and responses ready to be "activated". In fact, outright CIA connections, he notes that many of the CIA's child-oriented MK operations are "administered" by an Indonesian religious cult. One of the leading members of this cult is also a principal officer in a MAJOR computer-games software-manufacturing/ developing business. He doesn't name names, but I believe it must be either Sega Genesis or Nintendo, or some corporation rather close to them in terms of market share, from the way he writes it. The name of the religious cult is "Subud".

MUSIC AND MIND CONTROL

The use of music as an aid to programming—which forms a significant aspect of the operation experienced first hand by "Mr. Coffee" and described in his account reprinted directly following this section—has been consistently commented on by certain researchers, including Preston Nichols. Music provides access to the deeper, subconscious, emotional, nonlinear/logical portions of the psyche. As shown so clearly by "psychedelic" pioneers Tim Leary and Richard Alpert in their government-sponsored LSD research (some [of] which occurred at Montauk AFS)—"set and setting" are crucial in determining the impact and outcome of an LSD trip...and a mind-programming operation. Music, as an especially emotional art form, could be utilized very effectively (albeit diabolically!) to assist in amplifying, intensifying and boosting the impact of certain programming operations and experiences.

music previously used during programming.

There is information put forward by people like "Sue Ellen" (above) and others indicating that certain music stars are being trained/programmed/groomed/mindcontrolled, so that in their roles as mass entertainers they are fulfilling a certain function in the general mindcontrolled New World Order of things, and that there are very likely entrainment frequencies and subliminal commands and such embedded within the sound tracks: certainly in the case of country music the overall tone of the lyrics of many country songs is undeniably "down" and puts forth an ultimately depressing view of things. So many of these songs are about serious emotional distress, failed relationships and similar topics.

Technically, and even artistically, the level of musicianship, proficiency, etc. could be quite high, and the music could "sound good", but there could be specific signals/frequencies mixed in later, perhaps unbeknownst to the performing artists, which reinforce an element of the lyric content or even communicate some other "message". Even subliminal vocal tracks could be used in this way. Much "heavy metal" and rap music overtly exhibits extraordinary levels of negativity, hatred and descriptions of violence in the lyrics, the destructive impact of which could all easily be supplemented with a hefty dose of subliminal images, commands and the like.

One concept which could be getting inserted into country and other pop music by these and various other methods might be this: to abuse (physically, sexually, emotionally) or neglect children—resulting in them ending up under the control the government; or to directly "turn them over to the government" in any number of other ways, and/or assist the government in gaining access to and control over children so that the government can (have means and opportunity to) subject them to psychosexually-abusive/mind-control

sex-abuse case involving McMartin Preschool and their programming, so they can serve certain purposes as similar charges have been made by a number of other agents of the government. If kids are abused at home, and/or families are being subliminally encouraged in many ways through manipulation of mass media to literally disintegrate, then more and more kids have been and will be ending up either in some sort of government custody or on the streets, where they become fair game for the picking; particularly by organized crime which, as I noted in my first report, is strongly implicated in the procurement of young people by any number of means, for covert government agencies to utilize in their unconscionable, inhuman and unconstitutional operations.

> This is the sort of social engineering that is apparently occurring: molding and shaping of consciousness and social reality through covert (and evil) manipulation of mass communication, such as the press and the news media, television, entertainment, movies, music, and so on. Additionally, there are the technologies developed in the Montauk Project, by which our very thoughts and even psychic-level experiences can be interfered with, tweaked, twisted and controlled.

I received an e-mail on the subject of music as utilized in mind-control operations, which read, in part, as follows:

"With the advances in technology since Dick Sutphen's book The Battle For Your Mind first came out, is it still impossible to reduce various frequencies to detect the subliminals when they are psycho-acoustically modified and synthesized so that they are projected in the same chord and frequency as the music?"

Though I'm unfamiliar with the book mentioned In addition, certain triggers can be activated by the above, the topic is certainly intriguing. Here's my response to the question, based upon my admittedly limited familiarity with the nuts-and-bolts of such operations: Certain people connected to the Montauk Project have made repeated references to the way popular entertainment—in particular, music—has been and is being utilized as an aid to EM/RF mind-control programming, either directed towards a population as a whole or towards smaller groups or individuals.

> Preston Nichols has relayed information about some of the more esoteric technologies, which utilize music as a medium for dissemination. He referred to what he calls a "quantum" waveform of some kind, which is not in either the audio or electromagnetic-wave spectrum, and which can transmit extensive amounts of information. This quantum-information signal apparently interacts with certain levels of consciousness and awareness: there is no commonly available technology at this time with which the information can be decoded.

> One point made by Nichols which I, as a musician, found intriguing is that the equipment used in implementing this quantum information wave is highly dependent upon vacuum tubes, as much of the Montauk Project technology has been in general, although transistors are utilized to some extent. It is interesting that many electric musicians, especially guitarists, have adamantly withstood the tidal wave of solid-state technology when it comes to instrument amplifiers: as many rock fans know, most electric guitarists, bassists, miked vocalists and other musicians swear by the vast superiority of the tonal qualities of vacuum-tube amps and the ability of such equipment to convey a far greater range of subtle nuances of feeling than transistor amps.

> Nichols indicated to me that a substantial amount of popular music since the 1960s has been utilized in service of a covert (of course!) MK agenda using various methods and technologies and, as I've pointed out,

people. (Nichols worked as a sound-recording engineer before going to work at Brookhaven Labs around 1970.)

More detailed and technical information was conveyed to me about this entire matter but, to be honest, the technical part is a bit over my head. I am a bit weak in radio electronics as well as quantum physics, relativity and the Unified Field Theory.

I have been extremely intrigued by the statements made by Nichols and others about music being utilized for mind-control purposes but remain somewhat unclear about how this is actually accomplished technically. Then, of course, questions—such as those posed by Mr. Hart, above—have crossed my mind as well: that is, how can the subliminal psychoacoustic frequencies, quantum information waves and other embedded data be isolated, deciphered, etc.

MIND-CONTROL VICTIMS— PERSONAL TESTIMONY

Certainly one of the most astonishing accounts from a victim/survivor of an intensive mind-control programming operation to have ever come my way is this one; e-mailed to me in late 1997 by an individual who gave me a brief autobiography, which described how he had been picked at the age of ten, through the "auspices" of the "Silva Mind-Control Program", to be an unwitting candidate for the "MK-ULTRA/Montauk/ Ewen Cameron School of Mind Control" (I think I made that last one up!), which commenced in earnest when he entered college at Rochester, NY.

Continually monitored by military agents who had tracked the fellow throughout high school, my contact was given the full complement of Montauk-type programming after he entered college, and he subsequently worked for his programmers in an altered state of mind as a slave-like agent. Among other horrors, he has had recollections of assassinating targeted

Here's the real grabber—this fellow has pieced together solid evidence (including recovered computer text files detailing this particular MK method) showing that music was used as a major aspect of a CIA, covert, mind-programming technology/system, as a means of substantially strengthening the emotional components of psyche and personality and "enlisting" these aspects for the programmed "cause". This translates into a much more intense "commitment" and connection to the program on the part of mind-controlled agents. This same music, perhaps with encoded subliminals, as well, is used to activate the previously-embedded program in the agent.

An incredible and terrifying story—and, the dates of his major involvement, which this fellow recalls, coincide exactly with information from Preston Nichols, regarding a very recent phase of the Montauk Project, from 1988-

This man was most recently an operative in the southeastern U.S.; however, that is where his "handler" made some major errors in "handling" my contact, which resulted in substantial and traumatic memory breakthroughs, a breakdown in the mind-control program in his case, and my contact's disconnection from the operation. (Naturally, though, severe harassment and vicious threats have followed him almost continually

Preston Nichols has reported that—after the departure of the Montauk Project's mind-control crew

end of 1992—the Project was somewhat at loose ends for a couple of years, but the directors then regrouped and ensconced themselves in the Atlanta, Georgia area, at Robbins Air Force Base.

I had occasion to meet this man, whom I will call "Mr. Coffee" (a pseudonym), in person during my trip to Long Island in the summer of 1998, which has been recounted previously in this report. I found him in some degree to be not what I expected; certain elements of the type of programming he has been subjected to-what might be called a fearless, kamikaze-type warrior with total confidence—seem to have leaked through into his everyday personality. Coffee indicated to Nichols and me that he (Coffee) may very well still be utilized, while in an alternate state of mind, for various covert operations by intelligence/military agencies. He attested to feeling bizarrely affected by the energy, particularly at It was like it was mind over matter. Camp Hero, but also in the village of Montauk.

Here is what Coffee had to say:

"Dear Sir:

"I believe that I was/am the subject of some horrific government mind-control experiments. I believe that the government "selected" me at a very young age, watched me develop as a young man and then, when the time was right, forced me into their "mind-control project". My memories of these events were all but nonexistent until recently, when a single event triggered a massive flood of memories, which started to all come back to me. To be honest, the whole experience has left me quite shaken as well as quite scared—but mostly confused.

"It all started when I was 10 years old. My mother enrolled me in a mind-control course called "the Silva Mind-Control Method". It is sort of a self-hypnosis course, where you learn to dive down into the different levels of your mind. You learn things like how to heal your body with your mind, relaxation techniques, ways to focus your concentration, and melt spoons with your mind (things like that). You may have heard of it? Anyway, while in the course, we learned to go to our "level" (a relaxed state of mind which is the basis of the Silva method). I was extremely good at all of the things we were doing, for some reason, right from the start. The instructor...was praising me like I was god's next gift to mankind; telling me that I was the greatest student he has ever seen, etc., etc.

(about six weeks into the course) the instructor asks me to go outside to meet some of his 'friends'. I go outside with him (and let me tell you, when you are 10 years old and you are in a classroom for two hours at a time on your Saturdays and Sundays, for eight straight weeks, you ABSOLUTELY live for your 15-minute breaks) so, needless to say, I was not very interested in wasting my "break time" talking to whomever these people were. We go out the double doors and there are two men waiting to talk to me. THEY BOTH WERE WEARING MILITARY UNIFORMS, one was wearing army green, and the other was in blue (possible Air Force but I cant be sure). The instructor states to the men, 'this is the kid', and they make some small talk. To be honest, I really didn't pay much attention to them (I was looking at the other kids on the playground and wondering why the hell I'm over here and not over there). But here's the main point: The man in green bends down on one knee and says to me, 'I hear you have some very special abilities', and I said 'I do'? He stands back up and speaks to the instructor some more, then kneels back down and says, 'It was very nice meeting you, YOU

DAY!' As a 10-year-old, you don't quite grasp what is really going on, and I remember laughing and telling him that I didn't quite understand, but it was nice meeting him, and I ran off to the playground. But, when I looked back, the three adults were still standing there looking at me, talking about me, and sizing me up.

"That was the only time that I actually spoke to those men for years, but what happens next is very odd. Growing up, my parents were fighting all the time and they finally got divorced. So what did I do, I used sports as my escape. All I focused on was sports; I would leave the house and go down to the field or into the back yard and practice, and practice my soccer skills. As a result of this, I became extremely good, so knack for it). I didn't think about doing it, I just did it. have my physical taken to attend Annapolis.

were so unbelievable on the soccer field. You have to see it to believe it. Here is how: I honestly didn't know any better. I didn't know that I wasn't supposed to be able to do that—just take the ball down the field by yourself and score, EVERY TIME! But, in my mind, I could do it, so I did it in real life, EVERY TIME. When the opposing teams' coaches asked how old I was, when I told them, they didn't believe me; after the games were over, they would thank me for not running up the score and humiliating 'their boys'. That's how good I was, and I do have video tapes of the games to prove it!

"Here is the thing, and I didn't put it together at the time: When you go to any children's sporting event, you see all of the parents. They are usually dressed casually and usually bring a folding chair and sit around and watch the game and gossip with the other parents, etc.,

"I REMEMBER looking around at all the parents. I REMEMBER noticing TWO GUYS IN MILITARY UNIFORMS FREQUENTLY AT MY GAMES—ONE IN GREEN AND ONE IN BLUE. I remember this specially because they stuck out like sore thumbs, and I specifically remember this because I was thinking, 'I a college I had never heard of before, called the wonder whose fathers are they?' They looked familiar, from when I was 10 years old, but I just could not put my finger on it.

"I remember seeing the same two guys all through "This is where it all starts: During one of the breaks my high school sporting events; whether it was football, basketball or track—at the county track meet, during EXPLAINING EVERY DETAIL; OF HOW, WHEN some football games, etc. (I can rattle off 5 or 6 different examples.)

> "Imagine how effective would an assassin or an agent be if, in his mind, through hypnosis, he truly had no fear; if, in his mind, through hypnosis, he truly believed that he could do superhuman things—things like jumping off a 3-storey roof and landing without injury, just as if he was jumping a foot stool—if, in his mind, through hypnosis, he truly believes he possesses superhuman strength and can turn his body's adrenaline glands on and off like a faucet. These are just some of the experiments they conducted on me, in an effort to make me the 'perfect weapon' or the 'perfect killing

> "When it came time for me to go to college is when strange things started happening. I was a 'blue chip' athlete and was recruited heavily as an A-rated football player by most of the major universities. By the end of my senior year in high school, the decision as to what school to attend was narrowed down to 2 or 3 schools.

"Mysteriously, in the mail I received a letter, which

from the Montauk underground installation, roughly the KNOW YOU'RE GOING TO WORK FOR ME SOME stated I had an appointment to have my physical taken for admittance to attend West Point. I didn't think much about it and the physical date came and went. Another letter arrives stating that I was 'Rescheduled' FOR ANOTHER physical at West Point. This physical date also comes and goes. Again, I didn't think too much about it. Then I get a phone call from someone in the military; I don't remember his name, but I think he said he was major something-or-other. Anyway, he asks me why I didn't go to the physicals, and I told him that, first of all, I wasn't the least interested in a military career because my father was in the military and it just wasn't my 'bag'. Secondly, my father graduated from Annapolis, and if I went to West Point he would disown me. About a week later I get a THIRD letter. > "The thing is, I never spoke to anyone about "It's funny because, honestly, I could do things that attending either West Point or Annapolis. I never spoke to any football coaches, I never discussed it with my parents, I spoke to NO ONE about applying to ANY military academy!

> > "I did some research about the process which one must to go through to enter either academy. Let me tell you that the physical is about the third screen they use to weed out unqualified candidates. These screens include either a presidential or a congressional nomination (I could have gotten one due to the fact that my father attended Annapolis but, since neither of us even approached the subject, it really makes you wonder what the Hell is going on). In addition to this, I was extremely under-qualified, since neither my grades NOR my SAT scores were EVEN CLOSE to the levels expected by the academies by their applicants.

> > "So how did I get THREE physicals scheduled to enter the military's most distinctive schools, WITHOUT EVER APPLYING? Someone wanted me to be in the military very badly, and I still have all the letters 'requesting' my presence at the academies for my physicals to prove it!

> > "By a rather odd set of events, I ended up going to University of Rochester, located in UPSTATE NEW YORK, right between Buffalo and Syracuse. I attended the University from 1988-1992.

> > "This is when they took me into their program. I CAN GO THROUGH ANOTHER 15 PAGES AND WHY THEY HYPNOTIZED ME; HOW THEY WOULD TAKE ME IN THE NIGHT, THE LABS, THE EXPERIMENTS, EVERYTHING!

> > "This was a 'Black Book Operation'; these men were not exactly in the military but some sort of a private group, operating from groups within groups. You see, I was so far gone and under their control because, for some reason, my mind adhered to their 'suggestions' extremely well, like nothing they had ever seen. Anything they told me to do while I was in this state of mind, I could do.

> > "The experiments were all under hypnosis and were initially designed to test how far the human could be pushed; things like the limits of human strength. While under hypnosis, they would tell me to imagine that my arm was a hydraulic press, with unlimited power. They then would place objects in my hand and tell me to crush them, and I could. Another favorite was to test the limits of human pain tolerances. For this experiment, they would tell me to 'turn off my nerves'; 'you are in a warm and safe place, you feel nothing and have NO

varieties of this test. They controlled me like I was a robot or something, and I remember standing and walking with 'tunnel vision'. I had no control of myself at all. I remember having to give demonstrations of my abilities so they could get the funding needed to continue with the project.

"I remember being in a field. It was dusk, and I demonstrated my abilities and showed the things I could do. There were 6 to 8 men there; one of them, dressed in a suit, was either a senator or a congressmen and, after he saw the things I could do, he said, 'JESUS CHRIST—if I didn't see that with my own eyes, I wouldn't have believed it possible. ANYTHING YOU NEED, YOU GOT IT!'

"The main focus quickly turned from doing simple tests on me to developing me as a killing machine, a military weapon, and they trained me as an assassin. I have memories of killing several people and executing several 'Missions'.

"My code name was 'The Rhino', and I believe I killed several people between 1988 and 1992.

"To be honest with you, this letter should have only taken me a day or two to write, but I have been working on this for over three weeks now. I am not going into great detail about most of my experiences and the really painful memories. Every time I start thinking about these events, my stomach turns and I become nauseous. I must ask you to please forgive me, if any of this is unclear or doesn't flow smoothly. I'm sorry, but I'm trying my best, but it is very difficult and painful to remember and write all this down.

"I graduate from college and I move down South. In my apartment complex, this guy introduces himself to me at the pool and we become good friends. At this time I have no memories of all these events, so I didn't put the following together until later. The guy's name is Aaron, and he is down South to get his masters degree in PSYCHOLOGY. Coincidentally, he is also from Rochester, NY. He becomes my best friend and about a year goes by. When we would go out drinking or be at parties, Aaron would brag about being able to hypnotize people without them even knowing it, and how he could just 'fuck' with people's minds. I never thought much about it because he was my best friend. I get my first job with a major corporation. Threehundred-and-sixty resumes for 1 spot, and I got the job. So, naturally, I was very excited and told all my friends. The job involved traveling all around the Southeast every week (being gone Tuesday through Friday, on the road, every week).

"The job didn't start until late August, and it was early July, so I had some time on my hands. About two weeks after I told Aaron that I had gotten the job, he calls me and asks me to come over (as he was my best friend, I would go over to his place all the time, so I thought absolutely nothing about it). I get to his apartment and we bullshit for about an hour, and he tells me out of the blue that 'some people are concerned about your new job', and I said, 'What the fuck are you talking about' and he said 'the fact that we won't know where you are during the week'; and I was just utterly confused and extremely pissed off (I still had no memory of any of the events mentioned earlier) and I said, 'What the hell are you talking about? Who is concerned? What business is it of theirs anyway? Who? I don't understand?' He let it go. What happened next, he did not let go.

of training. I was 24 years old and this was my first remember anything else. 'real job' with a company car, expense account and everything. Ever since I was very young, I stuttered LONGER THERE! I MEAN, HIS NAME IS severely when I spoke. The thing is, I knew it was all in my mind, because when I was alone I could speak very fluently, but when I had to speak to anyone, read aloud or, heaven forbid, speak to a group of people, my entire throat would just 'lock up' and I could not speak word one. When I opened my eyes, the doctor's face was white as a ghost and he is sweating bullets; there are now two assistants in the room and they have the same horrific look on their faces. The doctor, in a trembling voice, asks me, 'DID YOU KNOW YOU HAVE SOME KIND OF A GOVERNMENT MEMORY CAP IN YOUR MIND?' I said, 'No, what are you talking about?' He is still sweating profusely, and I ask him what was going on. He would not discuss it, but he said he wanted to see me tomorrow.

"I go to pay for the session in the lobby and I ask the assistant 'What happened in there?' At first she would not tell me, but I finally got it out of her. She said that I absolutely FREAKED OUT, and I was absolutely screaming uncontrollably. She also stated that, in her 15 years with this doctor, she had never seen anything like it. She said the doctor tried for 15 minutes to put the cap back on and I would not let him; they had to get three other people to hold me down and, finally, he got control of the situation again. This is on a Tuesday, the doctor wanted to see me the next day but he was booked through Friday; the assistant made room for me to see him on Thursday.

"I leave very confused, still having no clear memories of any of the government experiments. The thing is, I go home and what do I do, I go right over to my best friend's apartment (Aaron) and tell him the whole story about the hypnotherapist and the memory cap. He starts to FREAK OUT-you went to a hypnotherapist WHEN? And let me tell you, he was PISSED! I remember being very confused because I still didn't make the connection. I remember going into his apartment, telling him what happened; he gets very angry, but after that, there was 'lost time'. It was between 3:00 and 4:00 o'clock in the afternoon when I went over there. I remember this, because there were soap operas on the television when I was initially telling him my story; when I left, Jeopardy was on and it was becoming dusk. It was about 7:30 in the evening. I leave his apartment and go home; I found myself sort of wondering what happened? I ASK THE RECEPTIONIST WHAT IS GOING ON AND SHE TELLS ME TO PLEASE LEAVE AND DO NOT COME BACK. I ask about the doctor; she closes the receptionist's window, turns her back to me and walks

"I go home, even more confused; Aaron calls me about it. This is where all hell breaks loose. I go to his apartment and we are sitting down talking as usual. From the back bedroom, six or seven men come out! The same two military officers I had seen all along from my childhood and at the University of Rochester (one in green and one in blue). The other men were dressed in black. The instant I saw these men I began to remember; my instinct tells me to run but I was taken totally by surprise. The men in black leap over the couch, grab and hold me. They pinned me against the back of the couch; I had no leverage to plant my feet and try [to] get up. They start to laugh and say things like 'this guy isn't so tough' and 'that was easy'.

"I remember looking at Aaron with a look of betrayal: He could not look at me. The military officer in green says, 'Do you have any idea how much trouble you've been; we should have killed you a long time ago'; he asks Aaron, 'Is he going to remember any of this?' Aaron answers no. He proceeds to punch me in the face. I am struggling to get up but I just could not move; Aaron then takes over.

"Aaron then says the 'magic word' and instantly I cannot move; he tells me how relaxed I feel; how I feel warm and safe; how I am in a 'happy place'.

"This is where things start getting a little crazy. What he did to me, I remember, he somehow locked me away in my own mind, creating multiple personalities. I remember fighting him for control in my mind. He said that I [you] will do what I tell you to do. He said the walls are closing in and you cannot fight it; in my mind I,of course, pictured the walls closing in. On his instruction, the walls closed in until I was inside a 'vacuum-sealed steel coffin'. I could not fight it and I could not move. He then said, 'You are being sent to a place in your mind where you will never be found'; at this point I start screaming 'no, no, no'. After he sent me to a place where 'no one will ever find you', he instructed that 'a steel plate the size of ten football fields and 10-feet thick is crashing down upon you' and he said 'Here it comes, and there is no escape'. I remember screaming again as he says 'boooom'. Here comes another one, 'boooom', and he proceeded to do this five or six more times. I am screaming during all of this.

"The hypnotherapist had pulled me out of it; two days later the hypnotherapist has disappeared and Aaron locks the 'monster' away again, with new doors and in a new place. The monster who claims to be the real me who is even now locked away somewhere in my mind? This concept is very scary and confusing, but these are

"This all took place in the summer of 1994. After that, I couldn't remember any of these events, and Aaron continued to be my 'best friend'. Over the next two years, I would go over to Aaron's apartment and hang out. I remember a lot of missing time; watching a movie and all of a sudden I would be watching a different movie and it is 2:00 in the morning. Sometimes he would get up and lock the door, when it is only the two of us and we were both about 6 foot tall and 230 pounds, with bodybuilder physiques, living in a very quiet and secure apartment complex. So I began to wonder about these events and I would ask him 'why do you sometimes lock the door' and he would never answer me.

"There is much more to the story—how I broke free, where I am today, are they still watching me? It's funny because I play these events over and over again in my mind. Government experiments, multiple personalities, hypnosis. The thought that the United States Government assigned someone to 'watch' me for years sounds kind of crazy. The thing is, as I was sitting here typing on my computer and writing this letter, I remembered that Aaron used to come over and use my computer for some of his 'theories' and 'projects'. When we were 'best friends', I never thought much about it.

"MEMORY REGRESSION TECHNIQUE" (MRT)

Memory Regression Technique (MRT) involves the process of retrieving past memories and can assist in the retrieval of repressed material (memories) from the unconscious. MRT understands the process of association in relation to memory and strongly believes that specific memories can be brought to consciousness. Furthermore, MRT assumes to seize (particularly regarding the repressed patient) deep-seated memories and experiences through the aid of association, using music.

INTRODUCTION

Memory Regression Technique (MRT), involves the process of retrieving past memories. Memories that are either general or specific in nature. What the technique consists of is regressing one's mind (through age and time). By having individuals retrieve information (memories) from their past using a systematical process, they begin to develop an adaptation to this process. A 'familiarity' of retrieving past memories and, as this process continues, releasing stored material is made easier by the individual.

Memory Regression Technique can assist in the retrieval of repressed material (memories) from the individual's unconscious. Repressed material or pieces of information can be brought to consciousness through the aid of association. It is certainly probable that specific individual experiences/events were recorded in one's memory through association, particularly with music, during a specific 'time' or period in one's life. Accordingly, MRT can assist the individual in locating a desired 'time episode' of when certain specific events (memories) transpired, that may have been repressed

through time.

Why is MRT so unique? MRT understands the process of association in relation to memory. When memory is stored, it is essentially always stored in relation to the attainability of one's senses via smell, taste, touch, visual, and through auditory processes.

When individuals tend to remember past experiences, it is usually retrieved through related associations (whether it was induced by the color red or from a personal meaningful experience). MRT parallels with that of state-dependent memory. State-dependent memory is an extension of context-dependent memory (information that is better retrieved in the "context" in which it was encoded and stored or learned). sometimes happens that we retrieve information better when we are in a physiological or emotional state that is similar to the one in which we encoded and stored the information. Our moods may also serve as cues that aid in the retrieval of memories. Emotion influences not only what is stored in memory, but also how easily records can be accessed from memory. Individuals can best retrieve emotional memories by reinstating the emotion they were experiencing at the time they originally stored it, especially if the memory is associated with music.

The objective is to increase the process of retrieval. "But LOOK what I found on my computer. Here is Knowing that music (a specific song) can elicit a past memory for an individual, MRT realizes this principle: More songs may elicit more memories. MRT is an extensive collection of condensed music from past years to the present in chronological order. MRT is designed for availability to most settings: classical, country, jazz, rhythm and blues, pop, rock and roll, rap, gospel, folk, reggae, etc.

A subsequent e-mail from Coffee read:

"John: I got your name off the mind-control forum web-page and sent e-mails to all the people who I thought could help me. I had sent you that mail a while ago and a lot has happened since then. Since then I have regained more of my memory. As it turns out I have incredible telekinetic abilities, I can move, levitate and create objects using only my mind. And yes, I was one of the superstars at Montauk from 1988-1992. They since have erased my memory of everything and my abilities but I am slowly getting them back.

"The thing is, I have remembered that I have an 8year-old son and his mother is my sole [sic] mate and the woman I am supposed to marry, both of which they have and are raising my son for their own purposes. I am limited plant life (little grass clumps or small bushes) going to be forced to make a trade with them in exchange for my silence.

"As you can imagine, I cannot discuss the details for many reasons. I cannot go public, as the whole affair goes a lot farther then just a simple trade and, if I do, they will kill them. I have tried to get him before and they simply erased my memory again, this time I am more prepared.

"I have read your articles and must say that you are correct on many accounts and can tell you only that everything Preston Nichols claims happened in his books is all too true.

"I thank you for your concern and reply to my request for help. I hope you understand that things are in a very critical time for me and even writing this letter is extremely dangerous for me. But I will try and keep in touch with you as best as I can. Thanks again"—Mr. Coffee

regarding matters such as public disclosure of what he has been through and what he knows. He has met with Nichols a few times, and with Peter Moon. Nichols informed me that Coffee is "definitely involved" with some recent phase of the Montauk Project but, given the seriousness and sensitivity of the situation (in regards to Coffee's wife and child), Nichols would not discuss it further with me on the phone—which is pretty rare for him (even though he openly acknowledges that his phone line is intensively tapped).

As described earlier, I did meet Coffee in person during my trip to eastern Long Island in the summer of 1998. At that time Nichols indicated to me that he felt Coffee may have been used as a breeder and/or as cloning stock by the secret government, probably due to certain racial or blood-line factors. Nichols believed that Coffee had, without doubt, been subjected to "Montauk Project-related" government mind-modification programs and that his alternate identities had been extensively programmed to function as a fearless, "invincible", extremely self-confident soldier.

In early September 1998, Mr. Coffee was arrested by local police where he currently resides in New Jersey, at the instigation of the FBI and aided by a complaint against him by a suspiciously eager ex-girlfriend. They had a court order to confiscate all Coffee possessed Though he was compliant in every way with the officers, they found some pretext on which to arrest him and he ended up incarcerated in a psychiatric hospital! Several days before, Coffee had appeared on a Long Island TV talk-show, in which he aired an extensive account of his involvement in government mind-control programs, and the day after the broadcast he was the target of a kidnapping/murder attempt.

From "Oscar Laurent" (a pseudonym)—The following testimony describes his own childhood induction into a government-run, covert, mind-control program:

"I have very vivid recollection of an episode (beginning midday, summer) from where I was in a van (mini-van or other taller vehicle) sitting in the front passenger seat and pulling over at a gate in the fence where the road (perpendicular to highway, dirt) extended for a long distance (miles?). Depth perception in arid, western lands with only reference as a distant mountain range is quite confusing) from the highway to the mountains in the distance... I believe I've entered within a geomagnetic hot spot. The land around this road is quite arid, plain, no structures, rocks or dunes—only and extremely flat. During this time of transport between the highway and mountains, there is a large missing block of time...The next memory is entering the wooded area of the mountains, many solid-rock faces with steep angles on the sides of the road winding through the forest, and (because I was woke up by the bumpy road) then another lapse of missing time due to sleep...The next memory is constant till the end.

"The arrival (waking now) is to a dirt/gravel parking lot. There in this parking lot was a large, house-like structure; wide, typical design of a hotel; large front porch, dumpster and propane tanks outside to right (facing) of building; other cars/small trucks in lot near house; gravel on ground in parking lot; grassy area behind house with wooded area beyond that...all sides of this area are steep hill/mountain sides forming a basin (slightly darker in lighting) where the building was...miscellaneous other little things (trivial) the interior I am currently unaware of Coffee's intentions of this building was house-like; we passed by dining and

lounge rooms (boredom eliminated memory of most of the fairly large, probably 2 feet wide, unknown depth. Squarish basement of this building...

"...Stuff in basement was typical of an old building, miscellaneous old junk, whatever, but on the side wall (following a wide path through junk) was a modern and shiny metallic door with digital-numeric-keypad combination lock on the right side, which the person leading me to it stood in front of and opened (note: perspective is from a 2,3,4-year-old looking up at the man; lock at doorknob height, still above head) when door was opened it swung open towards me, and I notice that the side of it is about a foot thick with bolt locks extending from it (similar to bank vault—might have been the receptacles for locks mounted in the doorframe) all metallic chrome or steel, and a long tunnel extending from it down at a slight angle, and to the right—this in perspective to the building means it was leading beyond the back, left corner of the building (facing front) where the rock slope of the mountain extended upwards nearby. This tunnel was well lit at the entrance (white lights as found in office buildings), similar arrangement of lighting as the interior running lights of an airplane, (long light source in cavity on upper corners of wall, and if I remember correctly, slightly rounded and metal chrome, compliments nicely with the pure, white walls and metal flooring [diamond hatch grips on floor]). There was also a chrome handrail extending the length of this hallway, which I would look up at (being what, 3 years old?) and being led by the individual behind me with hand placed on shoulder sometimes for guidance or whatever, but always walking behind...(I do not have recollection of this man's face, as the driver of the van I was in stayed upstairs in the house, and I went with the 'owner' of the house down to the basement, etc.) as we progressed down this hallway, it was obviously intended as a light-adjustment area, so the eyes could slowly adapt from the bright light of upstairs and outside and the entrance to the tunnel to the darkness where this tunnel met up with others in a spur. At this spur (probably 100 feet from entrance [perception of small person]) the lighting was rather dark at the lower level...The tunnel was straight, but the atmosphere and the gentle slope of this tunnel told our senses we were now quite a ways under ground...At the spur intersection at the end of this tunnel (very dark) we turned in some direction (no visual reference) to the left (geography of above ground surface say this would be directly under the large mountain (solid rock) and a ways into the center of it, although nowhere near the exact center of the mountain, other tunnels went that way) as we continued in the left tunnel we came upon a room...

"... The tunnel ends in a 45° angle to a squarish room to the right, its farthest two walls of unknown distance (black walls, some chrome, but limited lighting from [it] was not enough to make out anything in the room besides [it]): the simple description: a 'iridescent, purplish, pinkish, bluish-purple cuboid' (pausing for shivers due to recollection of this...quite powerful emotion). On the right wall, as you enter the room you will notice a semi-circular table (large) extending from that wall, dark, yet reflective coloration of table, and some chromed metal throughout the 'device'. I'm having trouble continuing to type...any attempt to describe the thing is practically impossible...(excessively strong emotional response). I've tried numerous times with multitudes of materials and lighting to try to reproduce something that even somewhat resembles the thing, but haven't been able to even come close to its color, no less its semi-transparent texture and appearance of it...(well, we will continue to try:)

"Ok...let's start with it. It is a rectangular solid. It is

interior, until going downstairs) and finally ended up in the front face. It is mesmerizing. If you can picture a huge mass of fiber-optic material (translucent surface) with infinitive tubules intertwined within it in a rectangular, solid shape, with blue, purple, and pink light streaming in high-speed bursts throughout this mass, creating a glowing 'purplish, pinkish, bluish-purple cuboid' then you are coming close to the reality.

> You may also define it as similar to the primitive (in comparison), but current attempts to create an optical switching/processing device (computer) by many government and private research institutions. (OK. At least I got through that... :) this cuboid was situated slightly lower than the surface of the table, in what appeared to be an indentation (my height was at the table level, or slightly above, so I could see that it went down below the surface of the table, but no idea what it was seated on.) This thing also had the most powerful aura or 'mental energy'—or psyche or whatever you want to call it—I have ever encountered (I have tried to recreate this feeling with numerous forms of radiation, magnetic and energy fields, large antenna structures connected to my high-power amateur-radio equipment, etc., the only thing coming close was accidentally bridging a 30+ amp power supply and the extremely painful shock and high-energy level in my body at that, instantly created from the discharge [please don't attempt, [it's] life threatening].)

> "This aura, or whatever it was, was so intriguing that I was guided by this other individual who led me down there to either stand or sit next to the receptacle (please see drawings) to the thing, and insert my hands and forearms into a rubber-like apparatus with metallic contacts for the base of your palm (science knows of a gland in that section of the hand...If you look at the right hand, palm up, at the lower, left side, top of wrist, is the top of the arm bone or wrist bone, whatever, fairly large...Now go up about a third of the way from this bone to the base of the little finger, there is a large muscle/mushy flesh section on the left 25% of the palm, inside or below this muscle is the gland or nerve endings or whatever was used to interface with the thing). As I found the metal balls within the rubber interface, I was offered a chair (seen out of corner of eye) by the leading individual, and this scene (vivid, mental image of the cuboid to the upper-right field of view, the counter to the right, the interface directly in front, some chrome pipes or whatever directly beyond that, darkness in the rest of the room, the front of my body below, and the chair off to my right being placed behind my legs for seating...). This is the last memory I have of the entire event when a "supernatural" feeling swept all of me and I made contact with both hands to the metal receptacles in the interface unit (previously only touched by fingers, now by that spot on both hands).

> "Event happened between 1982 and 1984. Very commonly, as I travel frequently and tend to find tons of interesting things wherever I go, I have recalled these memories spawned by similarities in the environment where I currently am. HOWEVER, these things that I see DO NOT in any [way] effect my vision memory of the experience with the thing. The memory is there; it is unchanging and solid, but the resemblance of other things always bring the experience back. For example, I mention the long, remote highway, the distant mountains, etc...When visiting New Mexico and Texas and attending a camp in NM (twice)—including travel between the airports (New Mexico) and the camp—I am commonly looking for the view and dirt road which are so vivid in memory along the entire trip, always hoping to see this same scene, or feel the same sensations as we approached the "thing"

facility...Various sci-fi shows, especially Star Trek with the Borg flashback recollections of the 'thing' room, especially the interface, although nothing in *Star Trek* resembles this arrangement of devices.

'Whenever I pass a wooden post/wire fence, I think of the trip along the highway and the gate we passed through. When wandering around at family friends' house in NM or Texas, I think of the view looking out of the van, over the fence, across the plain to the mountains...Whenever visiting a rocky and mountainous area here in the northeast, whenever we come upon a tall, steep rock side of a mountain on a windy road, I think of the views entering the mountains at the facility. The placement of the dumpster and other tanks and vehicles at the kitchen building of a camp I have frequently attended, are quite similar to those on the side of the house/hotel building, but even with the excessive number of times I've passed by them, they are never right (the height of the porch is similar, the building construction is similar, but in no way close enough). Entering well- or dimly-lit buildings sometimes reminds me of the tunnel, as would a smaller (with same slope) tunnel used to connect the airport to the plane's portal; same grating on the floor in some cases.

"NOTHING HAS EVER RECREATED THE EMOTIONAL FEELING OF THE FACILITY, thus I will soon be traveling to Montauk Point, NY where there are other geomagnetic 'hot-spots', as it is the closest place to my current location with similar characteristics."—© 1997, all rights reserved

A therapist from New Orleans, named Valerie Wolf, presented two of her patients to the President's Committee on Human Radiation Experiments on March 15, 1995, in Washington D.C. The two patients, both women, gave bloodcurdling accounts of some of their horrific experiences while being subjected to government-run mind-control/ modification/manipulation programming, which included, among other "techniques", use of such tactics as drugs, torture, hypnosis, electroshock and rape, as well as being exposed to an unspecified or unknown amount of radiation. David E. Two of his clients, Jerry L. Dotey and Ann White, though apparently victims of radiation exposure, were also subjected to very severe mindcontrol programming while at the ARCO plant.

Dotey and White were allegedly subjected to tortures of many kinds, while under drug-induced hypnosis as part of this mind-control operation, with each one undergoing at least three different "training" programs by plant physicians.

Each victim was trained to enter into a hypnotic state upon the occurrence of specific stimuli—usually involving a "cue" word or phrase—and trained to "remember to forget" what transpired in the hypnotic state. They were repeatedly subjected to identical stimulus-response sequences, in order to produce nearly automatic reactions to the particular "trigger". The secretive Bilderberg society, a group some believe conspires semi-annually to foster global government, will hold a steering committee meeting in Washington next month, *WorldNetDaily* has learned.

NEW MILITARY UNIT FOR DOMESTIC DEPLOYMENT

Critics are denouncing recent congressional changes to the *Posse Comitatus Act* that will allow a broader use of U.S. military forces in a domestic law-enforcement role, including a new unit for deployment in assisting civilian officers during a terrorist attack.

The new command, established Oct. 7 in Norfolk, Va., will be called the U.S. Joint Forces Command, and replaces the former U.S. Atlantic Command. At a ceremony commemorating the new unit, Defense Secretary William Cohen told participants the American people shouldn't fear the potential of seeing U.S. military forces on the streets of U.S. cities.

The military must "deal with the threats we are most likely to face," Cohen told reporters, downplaying concerns about troops operating on home soil. "The American people should not be concerned about it. They should welcome it."

The new command is designed to prepare U.S. troops to fight abroad or to respond if terrorists strike with nuclear, chemical or biological weapons.

In opposing the measure, critics cite the 1878 Posse Comitatus Act, which prohibits federal troops from participating in domestic law-enforcement activities under most circumstances. With the concern over domestic terrorism rising since the World Trade Center bombing and numerous incidences of cyber-attacks on U.S. defense and financial institutions, the Clinton administration has begun to relax some of those restrictions...

...Since the Waco debacle in 1993, when federal law officers and military personnel assaulted a church community

resulting in the deaths of over 80 men, women and children, Kopel said the federal government has been "eroding the protections contained in the *Posse Comitatus Act*". In the past, he told *WorldNetDaily*, most of the amendments to the original law had been based on bogus drug issues. Now, he said, that issue seems to have shifted to so-called terrorist attacks, or at least the threat of them.

The Defense Department has said only the military has enough equipment to operate in a poisoned environment, or to manage a massive decontamination effort. Secretary Cohen told reporters last week that federal law will not be violated because the military would only respond if requested. "It is subordinate to civilian control," he said.

But Gregory Nojeim, legislative counsel for the American Civil Liberties Union in Washington, D.C., told *WorldNetDaily* he is concerned about "nightmare scenarios" like those in the recent films, *Enemy of the State* and *The Siege*.

"Soldiers are not equipped, by training or temperament, to enforce the laws with proper regard for civil and constitutional rights," he said. "They're trained to kill the enemy."

Nojeim said the ACLU is concerned about "letting loose the most effective fighting force in the history of the world" on American civilians.

Cohen said that the creation of the Joint Forces Command would better coordinate the training of the four armed services. However, history is replete with reasons why some Americans continue to be hesitant about using military troops in a law-enforcement capacity.

Besides questions about the Army's Delta Force role during the Waco siege, most recently, in 1997, U.S. Marines assigned to assist the U.S. Border Patrol in combating illegal immigration, accidentally shot and killed an 18-year-old goat herder. That force has since been withdrawn and reassigned, but lawmakers have remained committed to expanding the military's civil law-enforcement role in other ways...

...Nojeim questioned the need for such an expansion of federal military forces into the domestic law-enforcement arena, even though U.S. officials have said the nation is now at greater risk of terrorist attack. He also believes the White House should do a better job of educating the American people about why the changes to the *Posse Comitatus* law are needed.

"For years the federal government has showered the FBI with hundreds of millions of new dollars to help it combat crimes involving chemical and biological weapons," he told *WorldNetDaily*. "Taxpayers need to know where that money has gone and why the president now wants to call in the troops."

Addressing the long-term ramifications of the change in military law-enforcement policy, Nojeim said, "When the crisis hits, those with the biggest guns will be subordinate to no one."

DOCTORS KILL MORE PEOPLE THAN GUNS AND TRAFFIC ACCIDENTS

SANDPOINT—Last St. Patrick's Day, Sandpoint Chiropractor Blaze Welch gave a lecture on how to "get off of the disease scary-go-round" at the Gardenia Center here. The purpose of the talk, which was sponsored by the North Idaho chapter of Vaccination Liberation, was to teach people that they are responsible for their own health. Dr. Welch also discussed figures from right out of the *Journal of the American Medical Association (JAMA)* which prove, through

century we chose the wrong fork in the road with regard to our health-care paradigm.

Most people have been conditioned to believe in what is called the "germ theory" of disease—that germs cause disease. The truth is that germs (bacteria) are everywhere and they are attracted to and proliferate in diseased tissues.

Bacteria decompose dead matter. That is their job. For instance, when a tree dies, bacteria come in and eat the tree and it eventually becomes soil. Bacteria does [sic] not eat a live, healthy tree. The same thing is true in people—bacteria are attracted to dead matter. Therefore, if you have dead matter in your body, bacteria will come in and get to work decomposing the dead tissue so that it may eventually become

In the mid-1800s, western medical science had the choice of going one of two ways. Bechamp's theory of disease maintained that every living thing has arisen from the microzyma (the "fundamental unit of the corporate organism") and "every living thing is reducible to the microzyma".

Bechamp believed that microzymas secrete fermentative substances that aid in digestion in a healthy body and evolve into bacteria when they encounter dead or damaged cells.

Pasteur's germ theory of disease maintained that diseases come into our bodies and make germs that we must fight so that we may be rid of them. J.I. Rodale explained Pasteur's "germ theory" of disease by stating that, "Germs live in the air, every once in awhile get into a human body, multiply and cause illness. Nothing to it at all. All you have to do is kill germs and disease is licked."

Bechamp's theory placed all of the responsibility of disease prevention on the individual and his lifestyle. In a practical sense, there was no money in that and people would be empowered with the ability to resist disease by taking care of themselves.

Western medical science went with Pasteur's theory because it opened the door which created the world's medical and pharmaceutical industries. Since the 1850s, we have been developing new drugs to attack and kill the disease invaders and the result has been epidemics of cancers and sicknesses and diseases—and a very rich and powerful pharmaceutical industry.

"Last year," commented Dr. Welch, "the pharmaceutical industry did \$182 billion in drug sales world wide." In contrast to that figure, it cost approximately \$183 billion to treat adverse reactions from all of those drugs, said Dr. Welch.

Dr. Welch read off some statistics which should cause concern to anybody who sees an allopathic doctor, has medical insurance or may end up in the hospital someday. Again, the following admissions were taken from JAMA:

The top five causes of death in the United States, in order, are: Tobacco, alcohol, medical malpractice, traffic and firearms

According to JAMA, doctors kill more people than auto accidents and guns. With that in mind, one has to wonder why gun control is such a hot legislative issue when, perhaps, we should be more concerned about doctor control.

"The number of people that doctors kill per day from medical malpractice is roughly equal to the amount of people that would die if every day, three jumbo jets crashed and killed everybody on board," commented Dr. Welch who added, in defense of his own profession, "Just imagine what headlines would result if a chiropractor or a naturopath accidentally killed just one patient?"

Another JAMA statistic stated that 1/5 (20 percent) of all people who see an allopath will suffer an "iatrogenic" (doctorinduced) injury.

Again, according to JAMA, 16 percent of all people who die in the hospital are determined by autopsy to have died of something other than their admission diagnosis. In other

CHEMICAL MAY HAVE KILLED BIRD FLOCK

MASCOUTAH, Ill. (AP)—State officials now suspect a chemical—not strong winds—killed thousands of birds in a southern Illinois farm field.

Biologists are running tests on some of the birds and should have the results today, Department of Natural Resources spokesman Joe Khayyat said.

The bodies of about 2,000 red-winged blackbirds, starlings and grackles were found last week in a farm field about 30 miles southeast of St. Louis with their wings to the side and heads pointing into the ground.

Biologists at first suspected that a violent downdraft killed the birds by slamming them into the ground—something that has happened before, Khayyat said...

RUSSIA REAFFIRMS WEST AS PRIME ENEMY

Russia Today, 10-2-99

MOSCOW (Reuters)—Russia has published a new draft military doctrine that retains the right to use nuclear weapons first, but defense experts said on Monday the main surprise was its strikingly anti-Western tone.

President Boris Yeltsin approved the last doctrine in 1993, after the military reluctantly put down a parliamentary revolt. It was never published in full, but excerpts on nuclear policy and intervention abroad caused a stir in the West at the

The Defense Ministry newspaper Krasnaya Zvezda published the new draft in full at the weekend, and it is already grabbing the attention of Russian and Western military analysts. It also means new NATO Secretary-General George Robertson will have his work cut out. He wants to convince Moscow, NATO is not a threat.

"Recent events, including in the Balkans and the North Caucasus, meant that we had to complete the work on the draft started more than two years ago under presidential orders," Colonel-General Valery Manilov, the General Staff man in charge of drafting the doctrine, explained to the newspaper.

At the core of the new doctrine is the concept of two opposing trends—unipolar, meaning U.S. superpower domination, and multipolar, implying many centers of influence including Russia.

"The Russian Federation considers that social progress, stability and international security can only be guaranteed in the framework of a multipolar world and works in all ways to achieve it," the draft says.

The United States and its NATO allies are not explicitly mentioned but the meaning is clear. The doctrine lists among the country's main external threats attempts to marginalize Moscow in world affairs and the stationing of troops near Russia.

"Unfortunately, it is a return to the Soviet pattern, the Soviet scheme, whereby the West was regarded as an alien entity which always jeopardized Russian national interests," said Yevgeny Volk of the Heritage Foundation think-tank in Moscow.

Colonel-General Manilov noted the draft even saw foreign hands in funding and training rebel groups, such as those in Chechnya, where Russia is battling Islamic militants...

...A Western defense expert said he traced the change in overall mood back to Russia's post-Cold War anger at NATO's enlargement to include East European states as members. NATO's bombing of Yugoslavia and Western doubts about the country's economic reforms had served to deepen a disillusioned mood.

'What really amazes me is that the views expressed by the General Staff are shared by quite a lot of civilians in the political establishment," the Western defense expert said. "I'm afraid this is a change we will feel very heavily in future."

He said the shift was more profound than a simple pre-election change of mood. Russians elect a new parliament in December and a new president in mid-2000. The 1.2 million-strong military remains a key slice of the electorate.

Manilov said Yeltsin would get a final version of the military doctrine for approval next month. The draft says Russia reserves the right to use nuclear weapons first in specific circumstances, for example if faced with an invasion.

The Western expert noted a broader security concept adopted last week by Prime Minister Vladimir Putin's government similarly homed in on threats from beyond Russia's borders.

"It is no longer taboo to be anti-Western," said one Russian military analyst who knows the workings of the General Staff well. "In 1993 it was impossible to write our enemy is the West. Now it is there, albeit between the lines. But it is there."

OFFICIAL MIND-CONTROL SCHOOL PROGRAM

PALM SPRINGS, FL—Beginning in January, kindergarten teachers in 15 elementary schools will fill out questionnaires on every child to identify which ones may need professional help to prevent future behavioral problems.

After watching their students for nine weeks, teachers will complete a "Teacher Observation Checklist" of 32 statements, such as: "The child makes friends easily." The teachers will choose one of five answers, from "I strongly agree" to "I strongly disagree".

A social worker or psychologist at each school will review the questionnaires. If they think the child needs help, parents will be called. The social worker will work with the children or refer them to psychologists or social service agencies.

How many troubling responses would trigger a call for professional help?

"We haven't yet determined what norm will be used to determine when intervention is needed," said Sheila Rogers, a school psychologist who will work as the program's behavioral health coordinator.

The five-year pilot program, unveiled Thursday, will be paid for with \$9.27 million in grants. It is designed to prevent troubled children from developing more serious problems, sell their high loan-to-value loans or to raise more capital, officials said. But Rogers conceded that the questionnaire might wrongly identify some children as troubled...

... Most of the money for the Children's Behavioral Health Initiative—about \$7 million—will come from The Quantum Foundation, a private, nonprofit organization formed after the 1995 sale of the JFK Medical Center.

Officials unveiled the plan Wednesday at a news conference at C.O. Taylor/Kirklane Elementary School.

"Nobody's ever done this before," said Harold Ostrow, chairman of the Health Care District, which contributed \$2 million. "We're going to make it work..."

..."We began work on this program in March," noted Tim Henderson, chief program officer of The Quantum Foundation. "Before Columbine."

Andy Kayton, legal director for the American Civil Liberties Union of Florida, said the initiative raises no civil liberties concerns as long as the questionnaires remain

...Rogers said not all the program's privacy issues have been resolved, but that the questionnaires would not become part of the student's cumulative record.

"There are national standards for this sort of thing," Rogers said. "I would say the questionnaires would be kept confidential."

The program will expand into first, second and third grades in coming years. It will also incorporate "A World of Difference", a program developed by the Anti-Defamation League to teach tolerance for diversity.

"No one can overestimate this program," Juvenile Justice Court Judge Ronald Alvarez told the gathering, "but I'm going to try. I'd liken it to the invention of the wheel. Mental health has been overlooked, underestimated and discriminated against

BANK-FAILURE BAILOUTS ON RISE

WASHINGTON (AP)—The Federal Deposit Insurance Corp. says bank failures this year are expected to generate the insurance fund's biggest losses since the regional banking crises of the early 1990s.

Much of the loss was caused by the failure of a big West Virginia bank.

While the FDIC still has plenty of money to cover losses to depositors, the failures bolster recent warnings by regulators that some banks may need to tighten their lending standards.

who oversees nationally chartered banks, told a bankers' group Monday that regulators see some signs of risk spreading in the banking industry despite high earnings and hefty assets.

Last month, the Federal Reserve warned banks and directed its examiners to watch for signs that risky bank loans are piling up...

... The new type of high-risk loans, known as loan-tovalue residential loans, have become increasingly popular in recent years.

Banks, thrifts and consumer finance companies have been in a heated competition for the new loans, which are marketed primarily as a way for consumers to consolidate their debts. The loans break the rules of traditional financing by letting homeowners borrow as much as 125 percent of their home's value.

The FDIC estimates that so far this year, five bank failures will cost the insurance fund \$760 million...

... Through most of the decade, there have been fewer than 10 bank failures a year. But in 1992, at the height of the banking crisis, 122 banks failed—mostly in Texas and New England, as their oil and real-estate booms, respectively, collapsed.

The banking debacle was not nearly as severe, however, as the savings and loan crisis of the same period, in which lax lending policies eventually forced a government bailout of hundreds of billions of dollars.

Then as now, the bank insurance fund, which backs each account up to \$100,000, has an adequate cushion to cover depositors' losses. The fund currently has \$29.8

up to \$750 million—stems from the failure of First National Bank of Keystone, a large bank based in Keystone, W.Va.

Federal regulators, who closed the bank last month, said they found "evidence of apparent fraud that resulted in the depletion" of its capital. They alleged, for example, that \$515 million in loans fraudulently remained on the bank's books after they had been sold.

The FDIC now controls the bank's assets. Several lawsuits, some by other banks, have been filed in federal court making claims on Keystone assets.

CHURCH PAYS BILLS OF PREGNANT GIRL, 12 BRITISH BACKERS OF ABORTION RIGHTS CALL IT BRIBE TO HAVE BABY

LONDON (AP)—Weeks after the British government launched a moral crusade to cut the number of teenage pregnancies, the Roman Catholic Church in Scotland has revealed that it is paying the bills of a poor, pregnant 12year-old to prevent her from having an abortion.

The announcement provoked a furious backlash Monday from abortion-rights advocates—and renewed the debate about how to curb Britain's teenage-pregnancy rate, the highest in Western Europe.

SCIENTISTS BREED MICE THAT RESIST CANCER

Scientists have created cancer-resistant mice by deleting certain genes that govern the formation of blood

The experiment could lead to drugs that destroy tumors in people.

Each of the 57 specially-bred mice was injected with 100 million tumor cells. Many of them didn't develop cancer at all; others grew tumors, but they eventually shrank or didn't spread. Deleting most copies of the genes appeared to have no harmful side effects for the mice.

The finding is the latest advance in one of the most exciting and promising areas of cancer research: angiogenesis, or blood-vessel formation. Scientists are trying to find ways to kill cancer by stopping the growth of the blood vessels that nourish tumors.

Last year, in one of the most celebrated developments in angiogenesis research, Dr. Judah Folkman of Harvard University reported that two proteins, angiostatin and endostatin, caused tumors in rats to shrink or disappear by cutting off their blood supply. Tests on people are about to get under way.

The mice study, published in today's issue of the journal Nature, involves two genes called Id1 and Id3 that were found to play a vital role in the little-understood process of angiogenesis.

One of the researchers, Robert Benezra, a cell biologist at New York's Memorial Sloan-Kettering Cancer Center, said the findings could lead to drugs that target tumors by inactivating the genes. In particular, the findings could help scientists develop treatments that can distinguish between normal blood vessels and those sprouting from tumors.

But scientists emphasized that further research is needed before any human applications are developed. For one thing, mice are much simpler creatures than humans. And the cancerresistant mice were injected with malignant cells; they did not develop cancer naturally.

Researchers are now breeding mice that develop cancer naturally. Such experiments will help determine whether the Id genes play a role in these situations, too.


